### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of PruittHealth, Inc. Employees 401(k) Plan and Hero Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of PruittHealth, Inc. Employees 401(k) Plan and Hero Fund's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. # Notes To Financial Statements

## NOTE 1. PLAN DESCRIPTION

The following description of the PruittHealth, Inc. Employees 401(k) Plan and Hero Fund (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution profit-sharing plan covering all employees of PruittHealth, Inc. and its affiliates (the "Company") who have adopted the Plan. PruittHealth, Inc. is a subsidiary company to its parent entity United Health Services, Inc. The Plan covers employees of the Company who have at least three consecutive months of service and have reached 21 years of age. The Plan also contains a cash or deferred arrangement as described in Section 401(k) of the Internal Revenue Code (IRC). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the IRC and similar state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan was amended effective July 1, 2023 to include the employees of PruittHealth Veteran Services – Maryland, Inc. ("Veteran Services") and to provide matching contributions for Veteran Services employees. Veteran Services employees are eligible to enter the Plan once they have reached 18 years of age. Participation in the employer matching contributions requires completion of one year of service.

### Contributions

Participants may elect to contribute to the Plan a percentage of their compensation as defined in the Plan. Participant contributions for 2024 were limited to \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participant contributions are allocated into various investment options offered by the Plan as directed by the participants.

The Company may make discretionary contributions each year. During 2024, the Company made a special employer contribution of \$2,631,538, net of forfeitures, which represented approximately \$313 for each eligible participant who was employed by the Company during the year. The Company may also contribute discretionary profit-sharing contributions each year. No such discretionary profit-sharing contribution was made during 2024. Company discretionary and profit-sharing contributions are invested in a portfolio of unit trust investments as directed by the Company.

For Veteran Services employees only, the Company also makes safe-harbor matching contributions to eligible employees. The match is 100% of the first 3% of annual eligible compensation and 50% of the next 2% of eligible compensation. The Company made \$333,277 in matching contributions during 2024.

## **NOTE 1. PLAN DESCRIPTION (CONTINUED)**

The Plan records employer and employee contributions receivable when compensation is paid. In accordance with ASC 326, *Financial Instruments - Credit Losses*, no allowance for credit losses has been recorded at December 31, 2024 and 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. After two years a participant is 20% vested. A participant continues to vest 20% for each successive year until 100% vested after six years of credited vesting service.

### **Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$82,660 and \$396,096 respectively. These accounts can be used to reduce employer contributions or to pay Plan expenses. Forfeitures totaling \$618,202 and \$122,974 were used to pay Plan expenses and to reduce employer contributions, respectively, in 2024.

### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments as specified in the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allows in-service distributions to a participant who has not separated from service provided the participant has attained the age of 59 ½. Hardship distributions are allowed in the Plan.

## **NOTE 2. SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding decrease to participant contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative and other expenses incurred by the Plan during the year included trustee and custodial fees, audit fees, investment management fees, recordkeeping fees, and consulting fees.

### NOTE 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

#### NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no other changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and mutual funds – unit trust:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market funds:* Valued at cost, which approximates fair value.

**NOTE 6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Matrix Trust Company. Matrix Trust Company is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Matrix Trust Company for investment management and recordkeeping services are included in net appreciation in fair value of investments and administrative expenses.

**NOTE 7. INCOME TAX STATUS**

The Plan has received a notification letter from the Internal Revenue Service (IRS) that the Plan has been approved as to form under Section 401(a) of the Internal Revenue Code (IRC). The Plan received its latest favorable determination letter from the IRS in August 2013. The Plan has been amended since receiving the last determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participant accounts will become fully vested in their employer contributions.

**NOTE 9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
