Notes to Financial Statements

Note 1: Description of Plan

The following description of the OEM Fabricators, Inc. 401(k) Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of OEM Fabricators, Inc. (the "Company") who have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In December 2022, Setting Every Community up for Retirement Enhancement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from beginning effective immediately through 2028. Those provisions include both required and optional elements. Plan management will determine the optional provisions to elect in the future.

Contributions

Each year, participants may contribute pretax and/or Roth deferrals up to 100% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company may make a discretionary matching contribution. Participants direct the investment of contributions into various investment options offered by the Plan. The discretionary matching contribution was 100% of the first 3% of the participant's compensation deferred. The Company may also make a discretionary profit sharing contribution. No discretionary profit sharing contributions were made for the year ended December 31, 2024. During the year ended December 31, 2024, the Company made matching contributions of \$537,537 to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Effective January 1, 2024, the plan also includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled at a 3% pretax deferral rate unless they affirmatively elect a different rate. The automatic deferral percentage will increase by 1% up to a maximum of 10% of compensation on January 1 each year, unless the participant affirmatively elects out of the automatic escalation provision.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of Company profit sharing contribution and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings (losses) thereon.

Vesting in the Company's contribution portion of their accounts plus actual earnings (losses) thereon is based on years of service. Company contributions vest according to a four-year graded vesting schedule. A participant's Company contribution balance vests 25% each year until it becomes fully vested after four years of service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A maximum of two loans outstanding are allowed by the Plan. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates on existing loans range from 4.25% to 9.50%. Principal and interest payments on notes receivable are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, hardship distributions out of the participant's account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,654 and \$17,626, respectively. These accounts may be used to reduce Company contributions to the Plan or pay Plan administrative expenses in accordance with the Plan document. For the year ended December 31, 2024, matching contributions were reduced by \$27,797 from forfeited nonvested accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

FBRICs were reported at contract value, which was the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Administrative expenses paid from Plan assets are allocated proportionately to Plan participants based on their respective account balance. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money market: Valued at the balance in the account, which approximates fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Fair value was estimated using the NAV per unit by the issuer of the pooled separate accounts. NAV was based on the fair value of underlying investments held by the pooled separate accounts.

Note 4: Fully Benefit-Responsive Investment Contracts (FBRICs)

The Plan invested in a FBRIC with Minnesota Life Insurance Company (MLIC) in the form of a guaranteed investment contract (GIC) that was issued as individual or group contracts in the year ended December 31, 2023. MLIC maintained the contributions in a general account. Contract value, as reported to the Plan by MLIC, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. MLIC was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The GIC was carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer, but could not be less than 0.00%. Such interest rates were set at contract inception and remained static for the life of the contract or was reset from time to time as specified by the contract.

Certain events limited the Plan's ability to transact at contract value with MLIC, including Plan termination and other events as specified in the GIC. The Plan administrator did not believe that any events, which would limit the Plan's ability to transact at contract value with participants or the issuer were probable of occurring. The GIC did not permit MLIC to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by Trustee/Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value, FBICs at contract value, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company ("Ascensus") and Minnesota Life Insurance Company (the Trustee/Custodian of the Plan).

Management has obtained certifications from Ascensus as of December 31, 2024 and for the period January 18, 2024 to December 31, 2024, and Minnesota Life Insurance Company as of December 31, 2023 and for the period January 1, 2024 to January 17, 2024.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Note 7: Tax Status

The Company adopted a non-standardized plan document with an IRS opinion letter, which states the plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Party-in-Interest Transactions

Ascensus is the Trustee, as defined by the Plan, and therefore, qualifies as a party-in-interest. Certain Plan investments were managed by Minnesota Life Insurance Company. Minnesota Life Insurance Company was the Custodian, as defined by the Plan and, therefore, these transactions qualified as party-in-interest transactions. Fees incurred and paid by the Plan for Plan administration services to these parties-in-interest are included in administrative expenses. Fees for the investment management services paid to these parties-in-interest during the Plan year ended December 31, 2024, were included in total investment income.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
