Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Gregory Pharmaceutical Holdings 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Notes to Financial Statements

December 31, 2024

Note 1 – Description of Plan

The following description of the Gregory Pharmaceutical Holdings 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Gregory Pharmaceutical Holdings, Inc. (the “Company”) who are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan allows eligible participants to enter on the first day of the month.

Contributions

Each year, participants may contribute from 1% up to 80% of pretax annual compensation as defined in the Plan, up to the maximum allowed by the *Internal Revenue Code (IRC)*. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective December 6, 2023, the Plan was amended to establish auto enrollment for new hires and rehires with a 1% deferral and auto escalation of 1% at each anniversary of enrollment up to a maximum deferral rate of 4%. The amendment also permits Roth elective deferrals effective December 5, 2023. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company matches 100% of the first 4% of eligible compensation that a participant contributes to the Plan. Contributions are subject to certain limitations. Additional profit-sharing amounts may be contributed at the option of the Company’s Board of Directors. Matching contributions were made by the Company in 2024 totaling \$466,006. No discretionary profit-sharing contributions were made by the Company in 2024.

Participant Accounts

Each participant's account is credited with the participant’s contributions, the Company’s fixed matching contribution, the Company’s discretionary profit-sharing contribution (if any), and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching and discretionary profit-sharing contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. Effective December 6, 2023, the Plan was amended to allow 100% vesting after three years of credited service.

Hardship Withdrawals

Hardship withdrawals are permitted pursuant to Internal Revenue Service (IRS) regulations.

Notes from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loans fund. Loan terms range from one to five years, unless the loan is used to purchase a primary residence. Notes are secured by the balance in the participant's account and bear interest at rates that range from 5.25% to 10.25%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant or a participant's beneficiary in the case of a participant's death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or a non-recurring partial payment from the vested portion of the participant's account. For termination of service due to other reasons, a participant with a vested balance in excess of \$5,000 may elect to receive the value of the vested interest in his or her account as a lump-sum distribution or as a non-recurring partial payment. For terminated participants, vested benefits less than \$5,000, increased to \$7,000 effective January 1, 2024, will be paid in a lump-sum amount. In-service distributions of pre-tax elective deferrals are permitted for participants who have attained the age of 59½ and in-service distributions of matching and profit-sharing contributions are permitted for participants who have attained the age of 65. Effective December 6, 2023, the Plan was amended to reduce the age restriction to 59½ for in-service withdrawals on all contribution sources.

Administrative Costs

Although not required to do so, the Company may pay certain administrative expenses of the Plan. During 2024, contract administrator fees, investment advisory fees, and auditing fees totaling \$87,995 were paid by the Plan.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$191,706 and \$29,358, respectively. These accounts will be used to reduce future employer contributions or Plan expenses. Forfeitures of \$19,535 were used in 2024 to reduce administrative expenses of the Plan.

Note 2 – Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits

Benefit payments are recorded when paid.

Notes from Participants

Notes from participants are reported at their unpaid principal balance plus any accrued but unpaid interest.

Note 3 – Certified Information

Certain information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Plan's Trustee (John Hancock Trust Company, LLC as of December 31, 2024 and 2023). Note 4 – Fair Value Measurements

The Plan's investments in mutual funds are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs have the lowest priority. The Plan uses appropriate

valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year-end.

Note 5 – Related Party Transactions and Parties-in-Interest

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

John Hancock Trust Company, LLC (“John Hancock”) provides custodian and certain administrative services to the Plan pursuant to Services Agreements with John Hancock.

Note 6 – Tax Status

The non-standardized, pre-approved profit sharing plan document obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable sections of the *IRC*. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC* and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 – Subsequent Events

Management evaluated all activity of the Plan through October 1, 2025 (the issue date of the financial statements) and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.
