INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Trustee
of AST Spacemobile Services, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the AST Spacemobile Services, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of the AST Spacemobile Services, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General - The Plan is a defined contribution plan, sponsored by AST Spacemobile Services, LLC (the "Company") for the benefit of its full-time employees who are 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective February 22, 2024, the Plan was amended to add a service requirement of two months to be eligible to participate in the Plan. Additionally, effective April 16, 2024, the Plan was amended to change the force-out provision to exclude amounts attributable to rollover contributions in determining the value of the participant's nonforfeitable account balance.

Contributions - Each year, participants may contribute up to 90% of annual compensation as pre-tax or Roth contributions, subject to certain limitations as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may make a discretionary matching or non-elective employer contributions. During the years ended December 31, 2024 and 2023, the Company did not make any matching contributions to the Plan.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant investment account options - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, if any, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) Description of plan (continued)

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. In the event the Company elects to make discretionary contributions, vesting in the Company's contribution portion of their accounts is based on years of continuous service. Company contributions are subject to the following vesting schedule:

Forfeited accounts - Forfeitures of non-vested contributions may be applied to pay the Plan's administrative expenses or to reduce employer contributions. There were no forfeited non-vested accounts as of December 31, 2024 and 2023.

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. The plan administrator determined that the rate as reflected in the Wall Street Journal plus 1% is a commercially reasonable rate for new notes. Principal and interest are paid ratably through payroll deductions.

Payment of benefits - On termination of service due to any reason, disability, death, retirement, and upon reaching age 59 ½, a participant or designated beneficiary may receive the value of the participant's account as a lump sum distribution, equal installments or partial distributions. For events qualifying under certain "hardship" rules as prescribed by the Internal Revenue Service ("IRS"), a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Contributions - Contributions from Plan participants and Company's contributions, if any, are recorded in the year in which the employee contributions are withheld from compensation and compensation is earned.

(2) Summary of significant accounting policies (continued)

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(3) Information prepared and certified by the custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments:

- Investments at fair value
- Net appreciation in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

(4) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at net asset value of shares held by the Plan at year end.

(5) Related party transactions and party-in-interest transactions

Certain Plan investments are shares of mutual funds in the custody of Matrix Trust Company. Matrix Trust Company is the custodian for the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to the recordkeeper of approximately \$18,000 and \$11,000 during the years ended December 31, 2024 and 2023, respectively, which was not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

(6) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any employer contributions, if applicable.

(7) Tax status and subsequent event

The IRS has determined that the volume submitter profit sharing plan is designed in accordance with applicable sections of the IRC and informed CCH Incorporated DBA ftwilliams.com of such in a letter dated June 30, 2020. Although the Plan has been amended since the date of this letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

(7) **Tax status and subsequent event (continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan has identified certain discrepancies which relate to 2021, 2022, 2023, and 2024 employee deferrals and the application of plan terms with respect to the definition of compensation. To correct these discrepancies, during 2024 and 2023, the Company recorded a qualified non-elective contribution totaling \$170,436 and \$113,101, respectively, which is included in employer contributions receivable. In August and September 2025, the Company remitted \$113,101 of qualified non-elective contributions related to 2021 - 2023, including lost earnings, to participant accounts. The Company is currently in the process of remitting qualified non-elective contributions totaling \$170,436 plus lost earnings related to 2024.

(8) **Risks, uncertainties and concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflicts. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

At December 31, 2024, approximately 76% of the Plan's investments were invested in three funds. At December 31, 2023, approximately 67% of the Plan's investments were invested in two funds.

(9) **Reconciliation of financial statements to Schedule H of Form 5500**

Certain investments and investment income line items reported on Schedule H of Form 5500 have been reclassified on the accompanying statements of net assets available for benefits and statements of changes in net assets available for benefits. These reclassifications have no impact on net assets available for benefits at December 31, 2024 and 2023 or changes in net assets available for benefits for the years then ended.

(10) Delinquent participant contributions and subsequent event

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all 2022 employee contributions to the Plan in 2022, lost earnings relating to \$1,417 of 2022 delinquent participant contributions were remitted in May 2024. Delinquent participant contributions for the year ended December 31, 2024, totaled \$49,396, of which \$49,123 were remitted in March 2025 and the remaining \$273 are in the process of being remitted. Additionally, the Company is currently in the process of remitting lost earnings relating to 2024 delinquent participant contributions.

(11) Subsequent events

The Plan has evaluated subsequent events through October 2, 2025, which is the date the financial statements were available to be issued. Other than as disclosed in Notes 7, 10, and below, no other significant matters were identified for disclosure during this evaluation.

Effective January 1, 2025, the Plan transitioned recordkeeping services from Human Interest, Inc. to Fidelity Workplace Services LLC and custodial and trustee services from Matrix Trust Company to Fidelity Management Trust Company. To facilitate the transition, the Plan had a black out period from December 28, 2024 to February 19, 2025. During the black out period, participants could continue to contribute to the Plan.

Effective January 1, 2025, the Plan adopted a Fidelity Pre-approved Plan document amending the following:

- In the event the Company elects to make discretionary contributions, participants will become 100% vested immediately in such contributions.
- The definition of eligible compensation was changed to exclude reimbursements or other expense allowances, fringe benefits, moving expenses, welfare benefits, and the value of restricted stock.
