**NOTE A - DESCRIPTION OF PLAN**

The following description of the Simon & Simon Group Medical Plan Health and Welfare Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan covers all full-time employees of Simon & Simon P.C. and their eligible dependents for the year 2024. On January 1, 2023, the Plan sponsor contracted with Veris Benefits Consortium to self-fund medical insurance benefits. Accordingly, certain Plan assets are held in a taxable trust. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA).

**Benefits**

The Plan provides self-insured medical and prescription benefits. Participants who have medical benefits qualify for vision benefits at no additional cost. All other benefits are provided under a separate Employee Benefit Plan. Employees are eligible to enroll for coverage under this Plan once the employees complete a waiting period of 30 days from the first day the employee reports for employment with Simon & Simon, PC. Participation in the Plan will begin as of the first day of the month following completion of the waiting period provided all required election and enrollment forms are properly submitted to the Plan Administrator.

**Self-Insured Benefits**

The Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

**Contributions**

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The company and the participants' share the premiums for the self-funded medical insurance with the participants contributing based on bi-weekly payroll deductions in accordance with the provisions of the plan.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, distribution of participants' accounts shall be in accordance with the Plan document. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Consequently, Company contributions are recorded when received and are not accrued. Benefits paid and premiums/fees paid are expensed when paid and are not accrued. Accordingly, the accompanying financial statements are not intended to present net assets available for benefits and changes in net assets available for benefits in conformity with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein; claims incurred but not reported; eligibility credits; claims payable; and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Tax Status**

The trust established under the Plan to hold the Plan's assets is not qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is subject to income taxes. The Plan did not make any income tax payments for the year ended December 31, 2024, as such, no provision was recorded for income taxes paid. Income taxes are recorded when paid.

Accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Payment of Benefits**

Health claims and premiums are reported when paid. Premiums paid by either the Company or the trust are recorded as premium payments and self-insured benefits paid in the accompanying statement of changes in net assets available for benefits--modified cash basis.

**Cash and Cash Equivalents**

Cash included currency on hand, demand deposits, and highly liquid investments purchased with financial institutions with a maturity of three months or less.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Stop Loss**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Premiums for stop loss insurance are included in premium payments for healthcare and insurance in the accompanying statement of changes in net assets available for benefits – modified cash basis. During the year ended December 31, 2024, stop loss reimbursements recorded in claim payments to healthcare providers on the statement of changes of net assets-modified cash basis were \$44,074.

**Concentration of Credit Risk**

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of cash deposits. Accounts at each institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At December 31, 2024, the Plan had \$0 in excess of federally insured amounts.

**Administrative Expenses**

Administrative expenses of the Plan are paid by the Plan Sponsor by making a contribution to the plan's trust account. Veris Benefit Consortium provides an invoice for the administrative expenses due each month. The contribution receipt and the payment of the administrative expenses is recorded in plan's trust activity.

**Date of Management's Review**

Management has evaluated subsequent events through September 29, 2025, the date which the financial statements were available to be issued.
