December 31, 2024

1. Description of Plan

The following description of the William T. Gardner, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

General

The Plan is a defined contribution plan covering eligible employees of William T. Gardner, Inc. and affiliated companies (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Charles Schwab Trust Bank serves as the custodian and EPIC Retirement Plan Service serves as the recordkeeper of the Plan.

Eligibility

Employees of the Company, who are at least eighteen (18) years of age are eligible to participate in the Plan, on the first day of the calendar quarter following completion of 6 months of service.

Contributions

Participants may elect to contribute a percentage of their compensation to the Plan on a pre-tax basis, subject to Internal Revenue Code (IRC) limitations. Contributions are made by payroll deduction. The percentage contribution may be changed on the first day of each calendar quarter.

The company provides a safe harbor match of 100% of employee contributions up to 3% of employee compensation and 50% of contributions that exceed 3%, but that do not exceed 5%. The Company may also make a discretionary non-elective contribution. There were no employer discretionary non-elective contributions for 2024.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Rollover contributions from pension, profit-sharing plans, and IRA account meeting the requirements of Section 401(a) of the Code are accepted by the Plan.

Participants may currently elect to invest their account balances in any combinations of money market, mutual funds, or life insurance. All funds are self-directed allowing the participants to change their investment selection at any time.

Notes to Financial Statements (continued)

1. Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and, (b) Plan earnings or losses, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options.

Vesting

Participants are immediately vested in their voluntary contributions and the company's safe harbor matching contributions. The account balances of employees who separate from service with the Company as a result of retirement, death or disability are 100% vested. Amounts representing the company's discretionary non-elective contributions and earnings thereon, vest according to the following schedule:

Forfeitures

Forfeited company discretionary contributions can be used to reduce Plan expenses or employer contributions. For the year ended December 31, 2024, no forfeitures were used. Unallocated forfeitures at December 31, 2024 and 2023, were \$159 and \$159 respectively.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or 50% of the vested portion of their account balances, subject to certain restrictions specified by the Plan. Participant loans (notes receivable from participants) bear interest at a rate similar to those rates charge by commercial lenders, and are repayable within a period of five years, unless the loan is for the purchase of the principal residence of the borrower, in which case the term may exceed five years.

William T. Gardner, Inc. Profit Sharing Plan

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Loans are secured by the respective participant's remaining balance. Principal and interest are paid ratably through regular payroll deductions.

Interest rates on outstanding loans at December 31, 2024 were 4.25% to 9.50% with various maturities through July 2029. Interest rates on outstanding loans at December 31, 2023 were 4.25% to 9.50% with various maturities through September 2028.

Payment of Benefits

Withdrawals may be made from a participant's account at retirement, death, disability, or termination of employment. The participant's account shall be distributed to the participant (or to the participant's beneficiary in the event of the participant's death) in a single lump-sum payment or direct rollover distribution. Participants over age 59 ½ with five years of service, may elect to withdraw all or a portion of their account. All distributions are subject to the applicable provisions of the Plan.

Terminated participants with the balance less than \$1,000, will receive the balance of their account in a lump sum payment unless the participants request a rollover. For balances greater than \$1,000, but less than \$7,000, benefit payments are made in the form of either a lump sum payment or are rolled over into an IRA account for the benefit of the participant.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time, subject to the provisions of ERISA.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis in accordance with U.S. generally accepted accounting principles.

Notes to Financial Statements (continued)

2. Significant Accounting Policies (continued)

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value (except for the life insurance which is stated at cash surrender value). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Subsequent Events

Management evaluated subsequent events for the Plan through September 30, 2025, the date the financial statements were available to be issued and have determined there are no events that require disclosure.

3. Investments and Notes Receivable from Participants

Certain investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends For the Year Ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the custodial of the Plan.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1), and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.

Level 2 – Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.

Level 3 – Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable. These inputs reflect management's judgment about the assumptions that a market participant would use in pricing the investment, and are based on the best available information, some of which may be internally developed.

The level in the fair value hierarchy within which the fair value measurement is categorized is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Mutual Funds– Valued at the closing price on the active market on which the individual securities traded.

Life insurance – Valued at the reported cash surrender value as determined by the insurance company.

Money Market Account-Valued at cost, which equals fair value.

5. Tax Status

The underlying Non-Standardized pre-approved profit sharing plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the code, and therefore, the related trust is tax exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Plan management has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

William T. Gardner, Inc. Profit Sharing Plan

Notes to Financial Statements (continued)

5. Tax Status (continued)

Accounting principles generally accepted in the United States require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related Party and Party in Interest Transactions

Administrative expenses charged to the Plan for year Ended December 31, 2024 were \$14,200. Certain other expenses are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits, as they are part of the mutual fund charges. Administrative expenses include amounts paid to the recorder keeper, custodian, and investment advisor. These transactions qualify as party-in-interest transactions; however, the transactions are exempt from the prohibited transactions rule under ERISA. Notes receivable from participants are also considered party-in-interest transactions.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

8. Other Employer Contributions Receivable

In 2023, it was determined that the Plan was not operating in accordance with the Plan adoption agreement as it relates to the definition of Plan Compensation. Accordingly, the Plan Sponsor calculated and recorded other employer contributions receivable of \$6,105, to correct the operational failure.

9. Late Contributions

During 2023, the Company failed to transmit certain participant's contributions and loan repayments to the Plan in the amount of \$7,176, within the period prescribed by ERISA. Late transmission of participant contributions and loan repayments constitute a prohibited transaction.
