Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of The Mosser Group Employee Savings Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Description of the Plan

The following description of The Mosser Group Employee Savings Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all non-union full-time employees of WMOG, Inc. (the Plan Sponsor and Administrator) and its participating subsidiaries (collectively, the Company). Eligible employees are permitted to make contributions to the Plan on the first day of the first calendar quarter following their employment date. A participant, who is employed by the Company on the last day of the Plan year, is entitled to share in the allocation of Company discretionary matching and participant forfeitures for that Plan year in which the participant is credited with at least 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Participant accounts are credited with their elective contribution, as defined in the Plan, and an allocation of Company discretionary and matching contributions and Plan earnings (losses). Allocation of Plan earnings (losses) is based on participant account balances, as defined. Participants direct the investment of their accounts among the investment funds offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested balance in the participant's account.

Contributions

Participants may choose to have a percentage of their compensation contributed to the Plan on their behalf. Participants may also contribute amounts representing distributions from other qualified plans, as well as amounts transferred from The Mosser Group Employee Stock Ownership Plan and Trust through an election to diversify.

Company discretionary and matching contributions are at the sole discretion of and are determined annually by the Board of Directors of the participating subsidiaries. In addition, the Plan made safe harbor matching contributions amounting to 100% of the first 4% deferred by the participants for the 2024 and 2023 Plan years. Company contributions may be made in cash or Company stock. If the Company contributions are made in Company stock, such contributions are made to and held in The Mosser Group Employee Stock Ownership Plan and Trust (ESOP) in accordance with the terms of that Plan. Company contributions in cash may be designated by the Plan Sponsor whether such contributions are to be made to and held by the ESOP, or whether such contributions will be made to this Plan. All Company discretionary contributions, totaling \$522,675 in 2024 and \$558,977 in 2023, were contributed to the ESOP. All safe harbor matching contributions, totaling \$403,843 in 2024 and \$357,950 in 2023, were also contributed to the ESOP. There were no discretionary company matching contributions in either year.

Payment of Benefits

Upon retirement, disability, or death, the Plan provides for distributions to be made in a single distribution or as further defined in the Plan document.

All participant contributions and rollover contributions are eligible to be distributed to a terminated participant as soon as administratively feasible. Other benefits payable to terminated participants are based on the participant's vested account balance and are payable as governed by the Plan document in which the contributions are held.

Vesting

Participant balances representing Company discretionary contributions are fully vested after three years of credited service, or upon retirement, disability or death. Participant elective contributions and rollover contributions are immediately fully vested, as are Company safe harbor matching contributions.

Forfeitures

Forfeitures of terminated participants' nonvested account balances are reallocated to the remaining participants. The reallocation, as added to the Company contribution, is based on the relative compensation of the remaining participants of the Company contributing during the year of the forfeiture, and is performed in the Plan year following the year in which the forfeiture occurs.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' accounts become fully vested.

Administrative Expenses

The Company has the option to pay certain expenses necessary to operate and administer the Plan. Investment manager fees for the Plan years ended December 31, 2024 and 2023 have been deducted from Plan assets. Fees are paid by the Company for audit and other administrative expenses. Fees are paid to parties-in-interest.

Note 2 – Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In contrast, contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There have been no changes in the valuation methods used. The Plan's investments are held by Transamerica Financial Life Insurance Company Inc., the Custodian.

The Stable Value Core Account is a fully benefit-responsive investment contract valued at contract value, which represents deposits and transfers made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Units held in pooled separate accounts are valued at net asset value (NAV). The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less any liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

Note 3 – Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) of investments for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Transamerica Financial Life Insurance Company Inc., the Custodian.

Note 4 – Guaranteed Investment Contract

The Plan holds a traditional investment contract that meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract issuer declares a guaranteed interest rate that applies for a six month period, after which it is reviewed for resetting.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value without adjustment. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer. The contract permits the issuer or the Plan to terminate the agreement as defined in the contract.

Note 5 – Fair Value Measurements

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets and liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Note 5 – Fair Value Measurements (continued)

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments valued at fair value in the statements of net assets available for benefits are all pooled separate accounts, which are valued using NAV as described previously, and therefore not required to be categorized within the fair value hierarchy.

Note 6 – Income Tax Status

The Internal Revenue Service ruled on June 30, 2020 that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA, upon which the Plan is based, qualifies under Section 401 of the Internal Revenue Code (IRC) and that the related trust, therefore, is not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
