## INDEPENDENT AUDITORS' REPORT

To the Trustees of  
Active Power, Inc. 401K Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Active Power, Inc. 401K Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Active Power, Inc. 401K Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## **Opinion**

**Note 1 Description of Plan**

The following description of the Active Power, Inc. 401K Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering substantially all non-union, full-time employees of Active Power, Inc. (the “Company”) who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

***Contributions***

Each year, participants may contribute up to Internal Revenue Service (“IRS”) dollar limitations as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations. The Plan currently offers twenty-six mutual funds, a common/collective trust fund and a self-directed brokerage account as investment options for participants. The Company may make matching contributions to the Plan in amounts determined and authorized by the Company’s Board of Directors. The matching contribution was 3% for both years ending December 31, 2024 and 2023. The Company may make discretionary non-elective contributions in an amount determined by the Board of Directors for each plan year. There were no such contributions made by the Company in 2024.

The Plan automatically enrolls newly eligible employees with a pre-tax deferral rate of 4% thirty days after an employee’s hire date, unless the employee opts out or selects their own deferral rate. Participants who are automatically enrolled will have their deferral rate increased by 1% every year until the deferral rate reaches 10%. Participants are able to change their deferral rate at any time.

***Participant’s Individual Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings, and charged with the participant withdrawal, an allocation of administrative and investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their contributions and matching contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their account is based on years of service. A participant is 100% vested after four years of credited service.

***Notes Receivable from Participants***

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at commercial bank rates, determined at the time of the loan. Loans currently outstanding bear interest at the rate of 5.25% to 10.50%. Principal and interest are paid through bi-weekly payroll deductions.

***Payment of Benefits***

Upon termination of service, disability or death of a participant, the participant or beneficiary will receive the value of the participant's vested interest in their account in either one payment or annual installments. Financial hardship withdrawals are permitted pending submission of verification to the Plan Administrator warranting the financial hardship.

***Funding Policy***

The Company remits employee deferral and Company matching contributions to the Plan on a bi-weekly basis.

***Forfeitures***

Forfeited accounts are amounts forfeited by participants who have terminated their employment and who have withdrawn from the Plan.

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10 and \$326, respectively. During the years ended December 31, 2024 and 2023, forfeited non-vested accounts of \$323 and \$0, respectively, were used to reduce employer contributions.

**Note 2 Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America except for benefit payments which are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reporting amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

***Contributions***

Participant contributions are recorded when the Company makes payroll deductions from eligible Plan participants. Employer contributions are accrued in the period in which they become obligations of the Company.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balances plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Payment of Benefits***

Benefits are recorded when paid.

***Operating Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to investment management services and administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Note 3 Fair Value Measurements**

The Financial Accounting Standards Board’s (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, Fair Value Measurements, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

---

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

---

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust Fund:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Brokerage Account:* Plan investments held in self-directed brokerage accounts, which consists primarily of registered investment companies, are stated at fair value. The fair values of mutual funds and stocks within the self-directed brokerage accounts are based on quoted market prices.

**Note 4 Information Prepared and Certified by Trustee**

The Plan Administrator has elected the method of compliance by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Fidelity Management Trust Company ("Fidelity"), trustee of the Plan, certified to the completeness and accuracy of all investments and related investment activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

**Note 5 Related-Party Transactions and Party-in-Interest Transactions**

Plan investments are managed by Alliant Retirement Services, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$26,100 and \$21,132 for the years ended December 31, 2024 and 2023, respectively.

Fidelity provides recordkeeping and administrative services to the Plan. Fees paid by the Plan to Fidelity for these services amounted to \$19,793 and \$15,861 for the years ended December 31, 2024 and 2023, respectively.

Strategic Advisors, Inc. provides investment advisory services to the Plan. Fees paid by the Plan for these services amounted to \$10,295 and \$8,423 for the years ended December 31, 2024 and 2023, respectively.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA.

**Note 6 Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 7 Tax Status**

The Plan Sponsor has obtained an opinion letter dated June 30, 2019, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). The Plan Administrator believes that the Plan is currently designed and being operated in accordance with IRC requirements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would be sustained upon examination by federal, state and/or local taxing authorities. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 9 Subsequent Events**

Management has evaluated subsequent events through September 23, 2025, the date that the financial statements were available for issuance, for disclosure and/or recognition in the financial statements.
