Opinion

1. Description of the Plan

The following description of the Fringe Benefit Plan for Service Contract Act Employees of Maximus Services, LLC (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General: The Plan provides health and other benefits to full-time and part-time Service Contract Act ("SCA") employees of Maximus Services, LLC and Maximus Federal Service, Inc. (collectively the "Company"). Part-time SCA employees and their dependents are eligible for certain programs. The assets of the Plan are held in a trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Employees become eligible the first day of the month coincident with or next following the completion of 30 days of employment.

Benefits: The Plan provides health benefits (medical, vision, dental, and prescription drug), life insurance, short-term and long-term disability benefits, critical illness, hospital indemnity, accident, legal, dependent care assistance, and an employee assistance program. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured benefits: The Plan offers two vision programs from which participants can choose. The Plan fully insures basic and supplemental life insurance benefits, accident insurance, legal, critical illness, hospital indemnity, short-term disability benefits, and long-term disability benefits.

Self-insured benefits: Medical benefits, dental benefits, and prescription drug benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Stop loss coverage: The Plan has entered into a stop loss arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount).

Contributions: Participants contribute specified amounts to the Plan based on applicable monthly premium equivalents established for their respective benefit elections.

The Company makes contributions on behalf of employees in amounts required to satisfy the fringe benefit contribution obligations under the SCA. The Company also makes contributions to the Plan as needed to fund premiums and claims in excess of participant contributions.

Participant accounts: A separate Premium Reserve Account is maintained for each participant. The account is credited monthly with the employee and employer contributions for the month and reduced by the premiums paid and administrative expenses incurred on behalf of each participant. Any net contribution in excess of a six month premium reserve is paid to the Company's qualified retirement plan on the participant's behalf.

Prior to January 1, 2024, the Plan included a Dependent Care Reimbursement program. Participants were permitted to transfer a portion of their Premium Reserve Account to the Dependent Care Reimbursement Program to be used to pay qualified expenses under this program. Effective January 1, 2024, this program was moved out of the Plan to a different employer sponsored plan.

Effective January 1, 2024, the Plan includes a Health Reimbursement program. Participants receive a contribution from the Company up to \$500 upon completion of wellbeing activities.

2. Significant accounting policies

Basis of accounting: The accompanying financial statements have been prepared using the accrual basis of accounting.

The Plan's benefit obligations as of December 31, 2024 and 2023 and changes in benefit obligations for the year ended December 31, 2024 have been presented on the same statements as the Plan's net assets available for benefits and changes in net assets available for benefits.

Cash and cash equivalents: Cash and cash equivalents consist of highly liquid debt instruments with initial maturities of ninety days or less. The Plan maintains a cash balance at one commercial bank which can exceed the Federal Deposit Insurance Corporation (FDIC) insured deposit limit of \$250,000 per financial institution. At December 31, 2024 and 2023, the Plan's cash balance held at a commercial bank exceeded the FDIC limit by approximately \$14,717,000 and \$27,092,000, respectively. The Plan has not experienced any losses through the date when the financial statements were available to be issued.

Contributions receivable: Contributions receivable represent amounts due from the participants for premium equivalents and from the Company for SCA contributions and any additional amounts necessary to cover claims.

Payment of benefits: Claim payments are recorded when paid by the third-party claims processors. Amounts due to the claims processors that have yet to be reimbursed by the Plan are recorded as due to claims administrators in the accompanying Statements of Benefit Obligations and Net Assets Available for Benefits. Amounts paid to claims processors in advance of the processor's payment to providers is recorded as advance to claims administrator in the accompanying Statements of Benefit Obligations and Net Assets Available for Benefits. Premium payments are recorded as expense in the period of insurance coverage.

Stop loss: Premiums for stop loss insurance are included in premiums paid in the accompanying Statement of Changes in Benefit Obligations and Net Assets Available for Benefits. Stop loss refunds totaling \$1,600,750 for 2024 have been netted with claims paid in the accompanying Statement of Changes in Benefit Obligations and Net Assets Available for Benefits. Refunds due at December 31, 2024 and 2023 are reported in accounts receivable and other assets in the accompanying Statements of Benefit Obligations and Net Assets Available for Benefits, and include approximately \$1,515,000 and \$605,000, respectively that was paid by the insurance company to the Company and is due to the Plan.

Refunds: Refunds from the Plan's PBM and other rebates are recorded when earned under the contract, and when the amounts can be reasonably estimated. Pharmacy rebates totaling \$2,289,721 for 2024 have been netted with claims paid in the accompanying Statement of Changes in Benefit Obligations and Net Assets Available for Benefits.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: Management has evaluated subsequent events for disclosure in these financial statements through September 30, 2025, which is the date the financial statements were available to be issued.

- 3. Claims incurred but not reported** Plan obligations for claims incurred but not reported are estimated based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.
- 4. Administrative expenses** The Plan pays administrative expenses that consist primarily of fees paid to third-party claims administrators, as well as other professional service fees to administrative service providers. These payments qualify as exempt party-in-interest transactions.
- 5. Tax status** The trust received a favorable exemption letter from the Internal Revenue Service on August 29, 2008, under the provisions of Section 501(c) (9) of the Internal Revenue Code (IRC) indicating that the trust is exempt from income taxes.

The Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and, therefore believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants.
