**NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Empire Today, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering all employees of Empire Today, LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Empower Trust Company, LLC (“Empower”) is the Plan’s Trustee and Custodian, and Empower Annuity Insurance Company (“EAIC”), is an insurance entity for the Plan.

***Contributions***

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Plan has an eligible auto enrollment feature (automatic contribution at 4% of eligible compensation) and an unwind feature (following auto enrollment an employee has up to 90 days to stop the deferral and have their monies removed from the Plan). The automatic deferral election of 4% of eligible compensation applies to all eligible employees unless otherwise elected by the participant. As participation is voluntary, those who do not wish to contribute to the Plan can change their contribution rate. The Plan was amended in 2023 to exclude the automatic enrollment of outside sales employees of 21st Century Flooring, LLC (d/b/a Luna) and Empire Today. Prior to the amendment, outside sales employees were automatically enrolled.

The Company provided a safe harbor matching contribution of 100%, up to 4% of participant’s compensation contributed to the Plan (including catch-up deferrals). All safe harbor matching contributions are 100% vested. Safe harbor matching contributions were discontinued as of June 28, 2024.

Profit-sharing amounts may be contributed at the option of the Company’s board of managers and are invested as directed by the participants into the various investment options offered by the Plan. Participants who have one year of service and are age 21 or older are eligible to receive profit-sharing contributions. No profit-sharing contribution was made by the Company during the years ended December 31, 2024 or 2023.

Participants direct the investment of their contributions and account balances into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution, Company safe harbor match contributions, allocations of the Company’s profit-sharing contribution, if any, and Plan earnings. Allocations are based on participant earnings or account balances, as defined. Participant accounts are also charged with withdrawals and applicable administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants in the Plan are 100% vested in their salary reduction and rollover contributions and the related earnings. Participants are also immediately 100% vested in Company safe harbor match contributions.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may only have one loan outstanding from the Plan at any time, and the term of any loan shall not exceed five years, unless the loan is related to the purchase of the participant's principal residence for which the term is 30 years. The loans are secured by the balance in the participant's account. The loan interest rate is determined quarterly by the Plan Administrator, and this rate is commensurate to local prevailing rates as referenced to the bank prime rate as reported by the U.S. Federal Reserve, plus 2% (ranging from 5.25% to 10.5% for loans outstanding as of December 31, 2024). Principal and interest are paid ratably through payroll deductions or paid directly by the participant.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Minimum required distributions for participants age 73 and above may be received in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$16,600 and \$36,700, respectively. Forfeitures can be used to pay Plan expenses or to reduce Company contributions. In 2024, expenses were reduced by approximately \$63,000 and \$2,800 were used to offset Company contributions.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Except for the Plan's stable value investment option (see Note D), the Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reported as distributions based on the Plan's loan policy.

***Administrative Expenses***

Certain Plan expenses (such as investment-related fees) are recorded as an offset to investment income. Other expenses are charged directly to the participant's account and are included in administrative expenses. Unless otherwise paid by the Plan, certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

**NOTE C - FAIR VALUE MEASUREMENTS**

Except for the Plan's stable value investment option, the Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The accounting framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to valuations using significant unobservable inputs (Level 3).

In accordance with the framework, Plan assets and liabilities measured at fair value are grouped into three levels based on the markets in which the assets and liabilities are traded, and the reliability of the assumptions used to determine fair value. These levels are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies and inputs used for assets and liabilities measured at fair value, as well as the general classification pursuant to the valuation hierarchy:

*Mutual funds* - Valued based on the daily quoted net asset value (“NAV”) of the shares held by the Plan at year end.

*Pooled separate accounts* - Valued at the NAV of units held by the pooled separate account. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV for the pooled separate account is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

<sup>(a)</sup> Redemption of pooled separate accounts is generally permitted daily, and there are no unfunded commitments. Funds in this category invest in a diversified portfolio of domestic and/or foreign stocks to achieve a long-term rate of return.

**NOTE D - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan provides a stable value investment option issued by EAIC, that simulates the performance of a guaranteed investment contract. EAIC maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semiannual basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include (1) transfers of assets from the fund into a competing investment option and (2) when total distributions and transfers in the fund exceed certain levels. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

**NOTE E - CERTIFIED INFORMATION**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, the Plan's trustee, and EAIC, an insurance entity, have certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE F - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by affiliates of Empower. These transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments. Participant loans are considered party-in-interest transactions.

The Plan participates in a revenue sharing program with Empower. Empower receives revenue from certain investment fund service providers for services the recordkeeper provides to the investment funds. This revenue is used to offset certain amounts owed to Empower for its administrative services. If the revenue exceeds the administrative expenses offset, the excess revenue is remitted to the Plan. During 2024, revenue received by the Plan was used to offset administrative expenses of the Plan and is reported as other income in the statement of changes in net assets available for benefits.

**NOTE G - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company profit-sharing portion of their accounts.

**NOTE H - TAX STATUS**

The Plan is a non-standardized pre-approved profit sharing plan ("Pre-Approved Plan") sponsored by Empower Retirement, LLC, and adopted by the Company. The Pre-Approved Plan obtained its latest opinion letter on September 16, 2022, in which the IRS stated that the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("Code"). The Plan has been amended since the date in which the Pre-Approved Plan received its opinion letter; however, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE J - DELINQUENT PARTICIPANT CONTRIBUTIONS**

The Plan failed to remit to the Plan's trustee certain participant contributions (totaling approximately \$7,613) in a timely manner in accordance with DOL regulations. The Plan corrected the matter and remitted the lost earnings in 2024.

**NOTE K - SUBSEQUENT EVENTS**

The Plan evaluated its December 31, 2024 financial statements for subsequent events through September 29, 2025, the date the financial statements were available to be issued. There were no subsequent events that required recognition or additional disclosure, other than those noted below.

Effective January 1, 2025, the Company will begin contributing a safe harbor match of 100%, up to 4% of compensation that a participant contributes to the Plan (including catch-up deferrals). The safe harbor match is 100% vested. Also, effective January 1, 2025, the Company amended its automatic enrollment provisions to clarify that the automatic deferral provisions will not apply to any employee who becomes a plan participant on or after January 1, 2025.

In addition, in 2025 the Plan has been formally amended for certain provisions of Secure 2.0.
