NOTE 1 DESCRIPTION OF PLAN

The following description of the Arrow Truck Sales, Inc. 401(k) Retirement Plan (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Arrow Truck Sales, Inc. (the Employer) originally effective January 1, 1996. The Plan has been amended throughout the years to comply with tax legislation and most recently restated January 1, 2015, and most recently amended effective January 1, 2021. Employees are eligible for participation in the Plan after completion of one year of service. The Plan excludes leased employees, nonresident aliens, and employees covered by a collective bargaining agreement. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective September 3, 2024, the Plan merged with the Volvo Group North America Voluntary Investment Pretax Plan, an affiliated plan. As a result of the merger, assets totaling approximately \$42 million were transferred to the affiliated Volvo plan.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) deferral or Roth contributions to the Plan. Employees are automatically entered into the Plan 30 days after becoming eligible with a 3% deferral contribution rate if they do not affirmatively elect either to contribute an amount other than 3% or to opt out of the Plan. Effective January 1, 2021, the automatic deferral rate increased to 5% for newly eligible participants. Effective January 1, 2023, the Plan implemented an auto escalation clause whereby automatic deferral rates increase 1% per year until they reach a maximum of 10%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Employer contributes a matching contribution of 50% of the employee deferral contributions up to 6% of eligible compensation. The Employer makes a fixed contribution of 5% of compensation for eligible participants. The Employer fixed contribution for 2024 totaling \$849,988 is included in Contributions Receivable and Due to Merged Plan in the accompany statement of net assets available for benefits as September 3, 2024. The Employer may, at its discretion, elect to make a discretionary contribution to the Plan. The Employer did not elect to make a discretionary contribution for the period ended September 3, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's salary deferral, the Employer's contributions, and an allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer contributions portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after five years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Master Trust

Volvo Group North America, LLC (VGNA) has established Volvo Group North America, LLC Target Retirement Fund Trust (the Master Trust) for the Plan and other retirement plans of affiliates of VGNA. The purpose of the Master Trust is to pool investment transactions and achieve uniform rates of return on comparable funds under all the affiliated plans. The Plan deposits funds in the Master Trust and owns an undivided interest in the net assets of the Master Trust.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Plan allows participants to borrow funds from the Plan based on certain conditions. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce future Employer contributions or administrative expenses. Forfeited nonvested accounts as of September 3, 2024 and December 31, 2023 totaled approximately \$0 and \$71,000, respectively. Forfeitures of approximately \$111,000 were used to reduce Employer contributions for the period ended September 3, 2024.

Benefit Payments

Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of his or her account in the form of a lump-sum distribution. The Plan allows for in-service distributions when a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 5 for discussion of fair value measurements.

The Plan's investment in the Master Trust represents the fair value of the Plan's proportionate share of the underlying net assets of the Master Trust. The pro rata share of investment income represents the Plan's proportionate share of total investment income of the Master Trust. Investment income includes recognition and allocation of interest income, dividend income, and realized and unrealized gains and losses, based upon each participating plan's share of the underlying net assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Master Trust Investment Fund

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. Investment income and administrative expenses relating to the Master Trust are allocated to individual plans based upon the amount of time the Plan's assets were invested in the Master Trust.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 3, 2024 and December 31, 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Benefit Payments

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Employer, as provided by the Plan document. Expenses paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

State Street Bank and Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of notes receivable from participants and investment information reflected on the accompanying statements of net assets available for benefits as of September 3, 2024 and December 31, 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits for the period ended September 3, 2024.

NOTE 4 INVESTMENT IN MASTER TRUST

The Plan and certain other employee benefit plans of AB Volvo participate in a Master Trust. The following is a summary of investments, other assets, and liabilities, at fair value, in the Master Trust and the Plan's proportionate interest in the Master Trust as of September 3, 2024 and December 31, 2023. The Master Trust was certified as complete and accurate by Transamerica Trust Company (Master Trust) and State Street Bank and Trust Company (Plan's Interest in Master Trust) through September 3, 2024.

NOTE 5 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Collective Trust Funds and Mutual Funds

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at September 3, 2024 and December 31, 2023.

Collective Trust Funds – Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions in and of ERISA. Participants should refer to the Plan agreement for a more complete description of Plan termination policies.

NOTE 8 PLAN TAX STATUS

The Plan is placing reliance on a determination letter dated October 6, 2016, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; and the Plan is currently under examination by the Department of Labor.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

The recordkeeping services and management of the investments are provided by State Street Bank and Trust Company, the recordkeeper and the trustee of the Plan, respectively. Therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
