## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bleigh Construction Company, Inc. ### **1. Description of Plan**

The following description of the Bleigh Construction Company, Inc. Retirement Savings Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Bleigh Construction Company, Inc. Retirement Savings Plan is a defined contribution profit sharing trust. Employees of Bleigh Construction Company, Inc., and Bleigh Farms, Inc. (collectively, "the Company"), are eligible to participate in the Plan. Eligible employees are age 18 or older who have completed 90 days of eligible service for elective deferrals and employer matching contributions. Eligible employees for the employer nonelective contributions are age 18 or older who have completed 6 months of service. Those qualifying for prevailing wage contributions are exempt from the service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Excluded employees include employees whose employment has been the subject of good faith bargaining between the adopting employer that has adopted the Plan and representatives of such bargaining unit, employees who are "leased employees", and employees who are "nonresident aliens".

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and thereafter. Accordingly, there has been no material impact on the Plan's financial statements.

#### **Contributions**

Employees may defer an amount up to 90% of compensation paid subject to the annual contribution limitations required by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. For the calendar years 2024 and 2023, the maximum amount that may be contributed to the Plan as 401(k) deferrals is \$23,000 and \$22,500, respectively, unless eligible for the catch-up contribution, in which case an additional \$7,500 and \$7,500, respectively, may be contributed. Participants may also contribute amounts representing distributions from other qualified plans. During 2024 and 2023, the Company made discretionary matching contributions. The Company makes contributions on behalf of workers who perform services under a contract, which is covered by the Davis-Bacon Act, a service contract act, or other prevailing wage law.

Types of contributions include the following under the Plan:

- Elective deferrals (including Roth deferrals)
- Employer matching contributions
- Employer non-elective contributions (including profit sharing and prevailing wage contributions)
- Rollover contributions

#### **Transfers from Qualified Plans (Rollovers)**

At the discretion of the Administrator, employees may be permitted to deposit into the Plan distributions employees have received from other plans. Rollovers will be placed in a separate account called a "participant's rollover account". Employees are 100% vested in their "rollover account". There were rollovers of \$28,933 into the Plan for 2024. There were no rollover contributions to the Plan in 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, plan earnings, and charged with an allocation of investment gains or losses, withdrawals, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. Description of Plan (Concluded)**

***Investments***

Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

***Vesting***

Participants are 100% vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of the participants' accounts is based on years of continuous service. Employees vest 20% per year after completing one year of service until becoming 100% vested after five years of credited service in accordance with the Plan document, or immediately if employment is terminated due to death, disability, or retirement upon attainment of the age of 65.

***Notes Receivable from Participants***

The Plan permits participants to borrow a minimum of \$1,000 up to 50 percent of their vested account balance not to exceed \$50,000. The notes are secured by the balance in the participant's account and bear interest at 1% above the prime interest rate. Principal and interest are paid ratably through ACH of the participant's bank account. Notes must be fully repaid within five years. Participant notes receivable are valued at their outstanding principal balance plus accrued and unpaid interest. As of December 31, 2024 and 2023, the Plan had outstanding notes to participants with principal balances totaling \$328,928 and \$285,684, respectively.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant can elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or various forms of annuities, as provided in the Plan document. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Forfeitures***

Any amount a participant loses the right to is called forfeiture. During the years ending December 31, 2024 and 2023, forfeited non-vested employer match accounts totaled \$0 and \$2,469, respectively. Employer match forfeitures are available to be used to reduce future employer contributions or to pay Plan expenses. Employer match forfeitures were used to pay Plan expenses of \$6,864 for the year ended December 31, 2024. No forfeitures were used for the year ended December 31, 2023. Employer profit sharing forfeitures will be allocated to the accounts of eligible participants. There were no employer profit sharing forfeitures for the years ended December 31, 2024 and 2023.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

**Investment Valuation and Income Recognition (Concluded)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Contributions**

Contributions from employees are recorded as they are withheld from the participant's wages.

**Payment of Benefits**

Benefit payments to participants are recorded when paid. At December 31, 2024, two benefit payments had been requested by participants for a total of \$19,862 but were not paid until the subsequent year.

**Plan Operating Expenses**

Certain expenses of maintaining the Plan are paid by the Plan and allocated to participant accounts. Expenses shared by all participants will be paid on a pro-rated basis, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the Plan are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value investments.

**3. Information Certified by the Custodian**

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the Plan management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Mid-Atlantic Trust Company, the custodian of the Plan, as complete and accurate, except for comparing such information certified by the custodian with information included in the Plan's financial statements and supplemental schedule.

#### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described below:

##### **Level 1 Fair Value Measurements**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

##### **Level 2 Fair Value Measurements**

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

##### **Level 3 Fair Value Measurement**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

##### **Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

##### **Collective Trust Fund**

Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023.

For the years ended December 31, 2024 and 2023, there were no transfers in or out of Level 3.

Certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits. The portfolio's investment objective is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. The portfolio invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements) and enters into "wrap contracts" issued by third parties and invests in cash equivalents represented by shares in money market funds. There are no unfunded commitments at December 31, 2024 and 2023. The fund has a daily redemption frequency and redemption notice period.

**5. Investment Contracts**

The Stable Value Fund is managed to protect principal and provide potential for higher rates of return than other conservative investments. The fund invests in instruments which are not expected to experience price fluctuations in most economic or interest rate environments. The Fund invests in a diversified pool of investment contracts issued by financial institutions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. Related Party and Party-in-Interest Transactions**

Certain Plan investments are managed by the investment custodian. Therefore, these transactions qualify as party-in-interest transactions. Investment fees paid to the investment custodian are netted against investment returns.

**7. Reconciliation of Form 5500 to Financial Statements.**

There are no reconciling items.

**8. Income Tax Status**

The Company has adopted a non-standardized plan pre-approved by the Internal Revenue Service (IRS). The IRS issued an opinion letter dated June 30, 2020, that the Plan is acceptable with the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Investment Options**

Participants have a choice of investments to elect to contribute to. The allocation can be changed by participants. An enrollment kit explaining these choices is available to all participants.

**10. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**11. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**12. Subsequent Events**

The Plan administrator has evaluated events and transactions subsequent to the statements of net assets available for benefits date through the date of the independent auditors' report (the date the financial statements were available to be issued) for potential recognition or disclosure in the financial statements. The Plan administrator has not identified any items requiring recognition or disclosure in the financial statements.
