## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Briarcrest Christian School 401(k) Retirement Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

**Note A - Description of Plan**

The following description of the Briarcrest Christian School 401(k) Retirement Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all full-time employees of the Briarcrest Christian School System (the School) who have accumulated 1,000 hours of service in a twelve-month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions** - Participants contribute to the Plan through a deferred salary agreement not to exceed Internal Revenue Service (IRS) limitations. Participants may also make rollover contributions representing distributions from other qualified retirement plans. Participants who have attained the age of fifty (50) before the end of the plan year are eligible to make catch-up contributions. Each year, the School may make a discretionary non-elective contribution to the Plan that will match 50 percent of the aggregate salary reduction contribution to the extent that the aggregate contribution does not exceed four percent of the participant's compensation. In addition, the School may make a discretionary contribution to the Plan for all eligible participants. During the years ended December 31, 2024 and 2023, the School made discretionary contributions equal to five percent of eligible participant compensation to the Plan. No discretionary matching contribution was made for 2024 or 2023.

**Participant Accounts** - Each participant's account is credited with the participant's contribution, the allocation of the School's contribution as directed by the participant, and the Plan's account earning and/or loss allocations based on the ratio that the participant's account balance bears to the total account balances of all the participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service and is determined as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
At least 1 year but less than 2	10%
At least 2 years but less than 3	20%
At least 3 years but less than 4	40%
At least 4 years but less than 5	60%
At least 5 years but less than 6	80%
6 years or more	100%

### Note A - Description of Plan - Continued

**Payment of Benefits** - Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document or upon the attainment of age 59 ½.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1.00%, currently between 5.00% and 9.50%. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

### Note B - Summary of Significant Accounting Policies

**Basis of Accounting** - The financial statements are presented on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value as of the balance sheet date. Fair value is the price that would be received to sell an asset or paid to transfer a liability in the orderly transaction between market participants at the measurement date. See note H for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Forfeitures** - Forfeited accounts are used to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced by \$14,388 and \$42,692 from forfeited non-vested accounts, respectively.

**Payment of Benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses and fees associated with maintaining the Plan are paid by the School and are not included in the statements of changes in net assets available for benefits. Certain investment related expenses are included in the net appreciation (depreciation) of fair value of investments. For the years ended December 31, 2024 and 2023, expenses are comprised of the following:

### Note B - Summary of Significant Accounting Policies - Continued

**Income Taxes** - The Plan is qualified under Section 401 of the Internal Revenue Code and is, therefore, exempt from federal income taxes.

### Note C - Participant Investment Account Options

The Plan allows participants to direct varying portions of their contributions and account balances among different investment options held by John Hancock Life Insurance Company (U.S.A.) (John Hancock) which includes a diversified selection of pooled separate accounts.

### Note D - Investment Information Certified by the Custodian

The plan sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian, John Hancock, has certified the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments at fair value and notes receivable from participants.
- Investment income, net appreciation (depreciation) in fair value of investments, and interest on notes receivable from participants.
- The schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

### Note E - Risks, Uncertainties, and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 55% and 53%, respectively, of the Plan's investments were invested in the Vanguard Target Retirement 2030, the Vanguard Target Retirement 2035 Fund, the Vanguard Target Retirement 2040 Fund, and the Vanguard Target Retirement 2045 Fund.

### Note F - Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

### Note G - Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service, and the plan sponsor believes the Plan continues to qualify and operate as designed.

The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

## NOTES CONTINUED

### Note H - Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Quoted prices which are not active, quoted prices for similar assets or liabilities in active markets, or inputs other than quoted prices that are observable (either directly or indirectly) for substantially the full term of the asset or liability. The fair value of pooled separate accounts is based on the values of the underlying assets.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Pooled separate accounts:** Valued at the Net Asset Value (NAV) of units of the separate accounts. The NAV, as projected by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that security liquidations will be carried out in an orderly business manner.

The following tables summarize investments for which fair value is based on NAV per share practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable to the Plan.

In accordance with Subtopic 820-10, pooled separate accounts that were measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy.

Note I - Related Party Transactions and Party-in-Interest Transactions

Plan investments are shares of pooled separate accounts managed by John Hancock, the custodian. Therefore, the investments and related investment transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Fees paid to John Hancock totaled \$42,422 in 2024 and \$39,383 in 2023. Fees paid to other service providers considered to be party-in-interest transactions under ERISA totaled \$41,467 in 2024 and \$38,961 in 2023. The School pays directly any other fees related to the Plan's operations.

Note J - Subsequent Events

Subsequent events were evaluated through October 2, 2025, which is the date the financial statements were available to be issued.
