### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Altron, Inc. 401(k) Profit Sharing Plan an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS  
ALTRON, INC. 401(K) PROFIT SHARING PLAN

**NOTE 1 - DESCRIPTION OF PLAN**

The following brief description of the Altron, Inc. 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

- A. "General". The Plan is a defined contribution plan covering all eligible (as defined in the plan agreement) employees of Altron, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. "Contributions". Each participant may elect to defer up to 100% of their compensation, subject to the maximum employee dollar deferral amount provided by the Internal Revenue Service for that calendar year, and have the Company transfer that amount to the Plan as an elective contribution on the participant's behalf. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employer matching contributions are subject to the determination of the Company. The Company approved matching contributions consisted of one hundred percent of the first 3% of total compensation and 50% of the second 3% of total compensation that a participant contributed to the Plan. Additionally, prevailing wage contributions are made by the Company for the prevailing wage service of each prevailing wage employee subject to certain provisions defined in the plan agreement.
- C. "Participant Accounts". Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant deferred compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.
- D. "Vesting". Participants are immediately vested in employee contributions, rollover contributions, employer safe harbor matching contributions, employer prevailing wage contributions, employer profit sharing contributions, plus actual earnings thereon. The plan agreement provides for a six-year vesting schedule for certain non-safe harbor contributions.
- E. "Payment of Benefits". On termination of service, a participant's benefits are distributed in a lump sum payment as soon as administratively possible or within specific periods defined in the plan agreement. Mandatory cash out distributions are required for participant accounts not exceeding \$5,000. Distribution of a participant's account with a balance exceeding \$5,000 requires the participant's consent and, in certain situations, the consent of the participant's spouse.
- F. "Participant-Directed Investments". The Plan permits a participant to direct the investment of the participant's account in any of the Plan's investment options. All Plan investments were participant directed in 2024 and 2023.
- G. "Participant Loans". Participants may borrow from their fund accounts, with the consent of the administrator, a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their account balance or \$50,000. Repayment terms cannot exceed 5 years except where a loan is made for the purchase of a participant's residence. The loans are secured by the balances in the respective participant accounts and bear interest at the prime rate (in effect when the loans are made) plus 2%, a rate deemed commensurate with rates charged by persons in the business of lending money for loans made under similar circumstances.
- H. "Plan Termination". Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements are prepared on the accrual method of accounting.

Notes Receivable from Participants and Allowance for Credit Losses – Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. The loans are collateralized by the respective participant accounts and the note payments are withheld by the Company from the respective participant wages. In the event of a default, foreclosure on the note and attachment of the security occurs when a distributable event occurs in the Plan, subject to the suspension of payments permitted by Internal Revenue Code Section 414(u)(4). The plan administrator evaluates the collectability of the loans based on the status of the note payments, the employment status of the participants, and the fair value of investment collateral. The plan administrator has determined that no allowance for credit losses was necessary as of December 31, 2024 and 2023.

Fair Value Measurements – The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

### *Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

### *Level 2 Fair Value Measurements*

No assets of the Plan were valued using Level 2 measurements.

### *Level 3 Fair Value Measurements*

No assets of the Plan were valued using Level 3 measurements.

### Net Asset Value

The investment in the common collective trust is valued as a practical expedient utilizing the net asset valuation as reported in the Federated Hermes Capital Preservation Fund (formerly, Capital Preservation Fund) in its audited financial statements as of December 31, 2024 and 2023.

Income Recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded when received, which does not materially differ from the accrual method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

**NOTE 3 – INVESTMENT INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

The following information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company for the period December 31, 2024 and 2023.

**NOTE 5 - TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated October 15, 2010 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code.

**NOTE 6 - RISKS AND UNCERTAINTIES**

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefit.

**NOTE 7 - PARTY IN INTEREST TRANSACTIONS**

The Plan has a number of service providers. Such parties are parties-in-interest under ERISA. Expenses totaling \$57,305 were incurred with these service providers during 2024. At December 31, 2024 and 2023, accounts payable to service providers totaled \$15,262 and \$13,380, respectively.

All of these parties-in-interest transactions are exempt from prohibited transaction rules of ERISA.

**NOTE 8 – RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H (FORM 5500)**

The financial statements are presented on the accrual basis of accounting. Form 5500 is presented on the modified cash basis of accounting. Accordingly, the accrual of certain revenue and expense items on the financial statement, "Statement of Net Assets Available for Benefits" and the recognition of same on the financial statement, "Statement of Changes in Net Assets Available for Benefits", have certain timing differences from those items reported on "Schedule H Form 5500".
