Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hometown Food Company 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Hometown Food Company 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Plan was established as of September 1, 2018, in connection with the sale of J.M. Smucker Co.’s shelf-stable baking business to Hometown Food Company. At that time, former participants of the J.M. Smucker Company Employee Savings Plan (“J.M. Smucker Plan”) who were eligible to participate in the Plan were provided the option to rollover their account balance from the J.M. Smucker Plan into the Plan. The Plan was most recently amended on November 17, 2023 for technical updates.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by the Retirement Committee.

Participant Eligibility and Contributions: The Plan provides that all full-time employees of the Company are eligible to participate in the Plan on the first day of employment. Participants may make elective contributions in the form of payroll deductions from 1% to 100% of all participant’s compensation, not to exceed the maximum amount allowed under applicable income tax regulations.

Company Contributions: The Company may make a discretionary match contribution to non-union employees determined each payroll period. In 2024, the Company contributed an amount equal to 50% of the first 6% deferred from a participant’s election. For collective bargaining participants, the Company matches up to 50% of the first 6% of employee deferrals. The Company also matches participants’ catch-up contributions.

Participant Accounts: Each participant’s account is credited with the participant’s contribution, their earnings, and an allocation of the Company’s contributions. Allocations are based on participant contributions, account balances, or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are 100% vested in their contributions and related earnings of the Plan thereon, if any. Vesting in the remainder of their accounts is based on years of service, as follows:

Payment of Benefits: On termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant’s account or rollover the amount into another eligible form of investment. Withdrawals from participant accounts are permitted in accordance with terms in the Plan document. In certain circumstances, participants may make “hardship withdrawals” as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Notes Receivable from Participants: Participants may borrow from their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer from the investment fund to the participant loan fund. Loan terms range from one to five years, or 15 years if the loan is used to acquire a dwelling unit that will be used as the principal residence of the participant. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1.00%.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Investments: All contributions, including employer matching contributions and employee discretionary contributions, are participant-directed into various investment options offered by the Plan. If no elections are made by the participant, then the contributions are invested in default investment alternatives established under the Plan.

Forfeitures: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan as a forfeiture. Forfeitures may be used by the Plan to pay plan expenses or used to reduce any matching contribution.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, as contract value represents the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

Risks and Uncertainties: The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks as well as the risks associated with global events such as a pandemic. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (ETC) and Empower Annuity Insurance Company of America (EAICA).

NOTE 4 - TAX STATUS

The Internal Revenue Service issued an opinion letter dated November 14, 2022, indicating that the pre-approved plan document adopted by the Plan, as then designed was in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended from the original pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

NOTE 5 - FAIR VALUE MEASUREMENTS

The fair value framework requires categorization of assets and liabilities into three levels based upon the assumptions (inputs) used to price the assets or liabilities. Level 1 provides the most reliable measure of fair value; whereas Level 3 generally requires significant management judgment. The three levels are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers as of the financial statement dates and recent transaction prices. The collective trust accounts provide for daily redemptions by the Plan with no advance notice requirements and have redemption prices that are determined by the fund's net asset value per unit.

In accordance with the Financial Accounting Standards Board fair value standard, the following table presents the Plan's assets within the fair value hierarchy as of December 31:

NOTE 6 - TRADITIONAL GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive traditional investment contract with EAI (“Issuer”). EAI maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contract. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan’s fully benefit-responsive contract was \$528,839 and \$570,518 on December 31, 2024 and 2023, respectively.

The Plan’s investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contracts. Examples of circumstances which would allow the Issuer to terminate the contracts include the Plan’s loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contracts at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.
