## INDEPENDENT AUDITOR'S REPORT

To Plan Administration of the  
Cinnaire Corporation Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Cinnaire Corporation Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cinnaire Corporation Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements is complete and accurate.

### Opinion

**NOTE 1 - SIGNIFICANT PROVISIONS OF THE PLAN**

The following brief description of the Cinnaire Corporation Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description, the Plan Agreement, and the Adoption Agreement for more complete information.

General

The Plan is a defined contribution profit sharing plan pursuant to Section 401(k) of the Internal Revenue Code covering substantially all employees of Cinnaire Corporation and certain affiliated companies (collectively, "the Company") and certain affiliated companies who are age 21 or older and have one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan entry is the first day of the plan year in which the eligibility requirements are met.

Contributions

The Plan only allows for employer profit sharing and rollover contributions. Profit sharing contributions of 8% are deposited into the Plan after year end. For the years ending December 31, 2024 and 2023, the Company made profit sharing contributions into the Plan of \$1,811,543 and \$1,468,468, respectively. These contributions were deposited during the December 31, 2025 and December 31, 2024 Plan years, as they're contributed after year end.

Participant Accounts

Each participant directs the investment of their account by selecting among investment alternatives offered through John Hancock Trust Company. Each participant's account is credited for contributions, interest and investment gains and charged for administrative expenses and investment losses. A participant is entitled to the benefit that can be provided from participant's vested account.

Vesting

Vesting in the Company's non-elective (profit sharing) contributions and related earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

Payment of Benefits

Upon retirement or other separation of employment, because of death, disability or termination, a participant may elect to receive a distribution as either a lump-sum payment equal to the value of the participant's vested interest in his/her account, or periodic payments. Participants may also take in-service distributions upon reaching age 59 ½. If the participant's vested accrued benefit is equal to or less than \$5,000 at the time of the participant's separation from service, the amount will be distributed in a single payment.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. During the years ending December 31, 2024 and 2023, forfeitures were applied to the profit sharing contribution deposited in the amount of \$41,333 and \$58,482, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The financial statements of the Plan are prepared on the accrual basis of accounting.

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Payment of benefits are recorded when paid.

The Plan evaluates events and transactions that occur after year-end for potential recognition or disclosure in the financial statements. These subsequent events have been considered through September 29, 2025, which is the date the financial statements were available to be issued.

Certain prior year amounts have been reclassified for consistency with the current year presentation. These reclassifications had no impact on previously reported net income or net assets available for benefit. See note 9 to the financial statements.

**NOTE 3 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 4 - INCOME TAX STATUS**

The Plan has adopted the Watkins Ross & Company prototype plan. The prototype plan sponsor has obtained a determination letter in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable sections of the IRC.

**NOTE 4 - INCOME TAX STATUS (continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right under the Plan to terminate the Plan, in whole or in part, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

**NOTE 6 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

Fees paid during the year for legal, accounting, administrative and other services rendered by parties-in-interest are, in the opinion of the trustee, based on customary and reasonable rates for such services.

Certain administrative expenses of the Plan are paid directly by the plan sponsor and are not charged to the Plan.

As described in Note 7, the Plan maintains investments managed by John Hancock Trust Company, the trustee of the plan, and therefore, these transactions qualify as party-in-interest.

**NOTE 8 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs used to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 8 - FAIR VALUE MEASUREMENTS (continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued at the net asset value (NAV) of units held by the Plan at year end, without further adjustment. Fair value of the underlying funds is based on reported NAV of each investment. Participant transactions (purchases and sales) may occur daily. There are no restrictions for a full redemption of each pooled separate account.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Pooled separate accounts are measured at net asset value, therefore no investments held by the Plan are subject to the leveling tables. The leveling tables are not applicable to the Cinnaire Corporation Profit Sharing Plan and Trust financial statements.
