We have performed audits of the accompanying financial statements of Michigan Pallet, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Michigan Pallet, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Michigan Pallet, Inc., the Plan sponsor and employees of Kamps Hardwoods II, Inc. The Plan was established in January 1997 under Section 401(k) of the Internal Revenue Code. Employees become eligible to participate in the Plan on January 1 or July 1 following one year of employment with at least 1,000 hours of service and attaining age 18. A participant becomes eligible to receive Company contributions after satisfying the participation eligibility requirements. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA).

Effective May 5, 2022, the Plan was restated to bring the Plan into compliance with legislative and regulatory changes.

Contributions

Participants may elect to make contributions to the Plan through payroll deductions from each participant's compensation, as defined, subject to statutory limitations. The Plan also allows participants to transfer funds from other employer qualified plans into the Plan.

The Company may elect to provide a matching contribution equal to a percentage of each participant's salary deferral. The Company may also make discretionary contributions to eligible participants' accounts. To receive a share of Company matching or discretionary contributions, a participant must be employed on the last day of the Plan year. The Company elected to make a matching contribution for the 2024 plan year equal to 25% of deferred compensation, not to exceed 1 ½% of annual compensation.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Plan Operations

The Company has appointed Empower Trust Company, LLC, to act as the Plan's Trustee and the Company to act as Plan administrator. The Trustee is responsible for holding the investment assets of the Plan, executing investment transactions and making distributions to participants. The Plan administrator interprets and communicates the provisions of the Plan and ensures that all government and participant reporting requirements are fulfilled.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan allows a participant to self-direct investment transactions associated with separate investment fund options made available by the employer for this purpose, as listed in the accompanying schedule of assets held at end of year.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer matching and discretionary contribution accounts is based on years of continuous service as follows:

Vesting (continued)

A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age.

Loans to Participants

Loans to participants are not allowed by the Plan.

Payment of Benefits

On termination of service a participant may elect to receive a lump sum amount equal to the value or a portion of the value of the participant's vested interest in his or her account. The lump sum balance may be paid in cash, rolled over to an IRA, or rolled over into another qualified plan depending upon termination type and elections. In-service withdrawals are permitted upon attaining age 59½ and in cases of financial hardship.

Forfeited Accounts

At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$4,858 and \$11,982, respectively. These accounts will be used to reduce future employer contributions or plan expenses. As of the employer contribution funding date, forfeitures of \$6,159 were used to reduce the 2024 employer match contribution.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. While management believes it has consistently applied its best judgment in those areas requiring estimates, actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Costs and Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

For the year ended December 31, 2024, plan management has evaluated subsequent events for potential recognition and disclosure through September 23, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS AND DISCLOSURES

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The mutual funds have been valued using unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access, which is defined as a level 1 measurement method.

The stable value fund has been valued using quoted prices that are observable for the asset either directly or indirectly. These include quoted prices for similar assets in active markets, quoted prices for identical assets in inactive markets, inputs that are observable for the asset, or inputs that are derived principally from or corroborated by observable market data. Using such quoted prices is defined as a level 2 measurement method.

The collective trust funds comprise the fair value of participation units held by Great Gray Trust Company that are valued at the net asset value of the underlying investments. The net asset value is used as a practical expedient to estimate fair value. In order to ensure all investments categorized in the fair value hierarchy are classified using a consistent approach, these investments are not categorized in the fair value hierarchy. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

NOTE 4 - RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the Trustees, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. The Plan made direct payments to the investment manager and third-party administrator of \$46,738 during 2024. The Plan Sponsor pays directly any other fees related to the plan's operations.

NOTE 5 - TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 - INCOME TAX STATUS

The Plan was restated effective May 5, 2022 to comply with legislative and regulatory changes. The prototype plan used by the Plan obtained an opinion letter dated November 14, 2022, in which the Internal Revenue Service stated that the prototype plan was in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the prototype opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.
