We have performed audits of the financial statements of Noble, Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1. Description of the Plan

The following description of the Noble, Inc. 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by Noble, Inc. (Company) for the benefit of its employees who are not leased employees and who have at least one year of service and are age 18 or older. Plan entry was quarterly. Effective January 1, 2024, Plan entry is now monthly. A related employer who also participates in the Plan is Kid's Only, Inc. (collectively, Company). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan's trustee is Reliance Trust Company and American United Life Insurance Company (AUL) is the Plan custodian. Effective April 19, 2023, a member of management was appointed as special trustee with the responsibility to collect delinquent contributions.

Contributions

Participants may elect to have a certain percentage of eligible compensation deferred up to the maximum percentage allowable by law. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Effective January 1, 2024, employee Roth contributions will be permitted. Additionally, the Plan was amended January 1, 2024, to include a qualified automatic contribution arrangement (QACA) equal to 3% of eligible compensation and will increase by 1% of eligible compensation up to a maximum of 15%. QACA contributions are 100% vested immediately upon entering the Plan.

The Plan provides for a safe-harbor matching provision. The Company's safe-harbor matching contribution is 100% of the first 5% of a participant's eligible compensation calculated each payroll period.

The Company may make profit-sharing contributions. Company profit-sharing contributions are discretionary as determined by the Company's Board of Directors. The Plan contribution formula is integrated at 81% of the taxable wage base.

Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary and Company safe-harbor matching contributions plus earnings thereon. Vesting in the Company's discretionary profit-sharing contribution portion of their account plus earnings thereon is based on years of credited service. A participant is fully vested after three years of credited service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

Upon termination of service, participants may receive a lump-sum amount equal to the value of their account. If the value of their account is greater than \$5,000, the account can remain in the Plan until requested. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, there were no forfeited nonvested accounts. During 2024, a total of \$4,621 of forfeitures were utilized to reduce employer contributions. No forfeitures were used to reduce employer contributions during 2023.

Notes Receivable From Participants

Participant loans are not permitted by the Plan.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Pooled separate accounts are valued at estimated fair value as provided by AUL.

The AUL Fixed Account and AUL Stable Value Account fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

The fair value of the guaranteed investment contract is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by OneAmerica Financial Partners, Inc. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the nonstandardized prototype document has a favorable opinion letter from the IRS. The Plan has been amended since the prototype received its favorable opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Custodian

The Company has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AUL, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Investment Contract With Insurance Company

The Plan has entered into fully benefit-responsive investment contracts with AUL. AUL maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

As described in the basis of accounting disclosure, because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no withdrawal restrictions.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract is contract value. The crediting interest rate is based on a formula agreed upon with the issuer. The AUL Fixed Account may not be less than 3.0% percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Level 2 securities include the pooled separate accounts, which are valued at estimated fair value as provided by AUL. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 securities held by the Plan.

Note 6. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in various funds of the current Plan custodian. The Plan paid fees of \$1,060 and \$585 to AUL in 2024 and 2023, respectively. The Plan paid fees to ProCourse Fiduciary Advisors, third-party investment advisors, of \$17,076 and \$14,217 in 2024 and 2023, respectively.

The Company provides certain administrative services at no cost to the Plan.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 9. Nonexempt Transactions

Defined-contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. The Company failed to remit employee contributions in the amount of \$449 in accordance with the Department of Labor's remittance policy for the year ended December 31, 2024. The Company remitted these employee contributions during 2024.

Note 10. Subsequent Events

Effective January 1, 2025, the following changes were made to the Plan:

- Kid's Only, Inc. is no longer a participating employer in the Plan
- The Plan no longer provides a safe-harbor matching provision
- The Plan provides for a discretionary employer matching contribution. Participants are immediately vested in their employer matching contributions plus earnings thereon
- Participants are immediately vested in the Company's discretionary profit-sharing contribution
- Eligible automatic contribution arrangement (EACA) equal to 3% of eligible compensation and will increase by 1% of eligible compensation up to a maximum of 15%. EACA contributions are 100% vested immediately upon entering the Plan
- Only one month of service to be eligible to enter the Plan and contribute elective deferrals. Entry is the first of the month following the one month of service

Subsequent events have been evaluated through July 10, 2025, which is the date the financial statements were available to be issued.
