To the Participants and Administrator of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Chiaromonte Construction Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Chiamonte Construction Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan formed on January 1, 2008, covering all employees of Chiamonte Construction Company. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

The assets of the Plan are held and managed by Principal Trust Company and Principal Life Insurance Company (collectively, "the custodian" or "Principal").

**Eligibility**

All employees age 21 and older who have completed three months of service are eligible to participate in the Plan. Eligible employees may become participants in the Plan on the first day of the month coinciding with or next following the date they meet the eligibility requirements.

Eligibility for prevailing wage contributions is immediate and not subject to age or service requirements. All employees hired under a prevailing wage contract are eligible to receive prevailing wage contributions from the first hour worked, even if they have not yet met the eligibility requirements for other contributions.

**Contributions**

Participants may contribute on a pre-tax or after-tax basis up to 100% of their annual compensation, as defined in the Plan, subject to the statutory limitations established by the Internal Revenue Code (IRC). The after-tax "Roth" contributions are subject to federal income taxes in the year of deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts, and a guaranteed investment contract as investment options for participants.

The Company may make contributions on behalf of eligible participants as follows:

- Safe harbor matching contributions equal to 100% of participant pre-tax or after-tax deferrals up to 6% of eligible compensation.
- Discretionary matching contributions.
- Discretionary non-elective contribution for eligible participants who have completed at least 1,000 hours of service during the year and are employed by the Company on the last day of the year.

**Contributions (Continued)**

- Prevailing wage contributions for participants performing work for the Company subject to Davis-Bacon Act, Service Contract Act or other federal, state, or municipal prevailing wage laws. The Company will make contributions to the Plan to help satisfy the requirements of the applicable prevailing wage law. The contribution will be determined based on the required contribution rates for the employment classifications under the applicable prevailing wage laws. The prevailing wage allocations will offset other employer contributions such as: safe harbor matching contributions, discretionary matching and non-elective contributions, and qualified non-elective contributions.
- Qualified non-elective contributions.

**Participant Accounts**

Each participant’s account is participant-directed and is credited with the participant’s contributions and allocations of the Company’s contributions, if any, Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant investments held, account balances, or specific participant transactions, as defined. Plan participants have daily access to their account via phone or internet and may change the allocation of their investments to any of the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their elective deferrals, rollovers, safe harbor and qualified non-elective contributions, as well as prevailing wage contributions, and all earnings thereon. Vesting in the employer discretionary matching and non-elective contributions is based on years of continuous service. After two years of service, a participant becomes 20% vested in the employer profit sharing and matching contributions in the Plan; the vesting percentage increases by 20% each year until the participant becomes fully vested in his or her account after six years of service.

**Notes Receivable from Participants**

Participants in the Plan may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their eligible account balance, reduced by any outstanding note balance. The loans are secured by the balance in the participant’s account and bear interest at the prime rate.

**Notes Receivable from Participants (Continued)**

The maximum duration of a loan is not to exceed five years, except in cases where funds are used to purchase a principal residence. Participants may have up to five outstanding loans at any time. Principal and interest are paid ratably through payroll deductions. Interest rates on the outstanding loans ranged from 3.25% to 8.50% as of December 31, 2024 and 2023.

**Payment of Benefits**

Upon termination of service due to retirement, death, full and permanent disability or attaining age 65, participants may elect to receive either a lump-sum amount equal to the value of their account, a direct rollover into a qualified retirement plan, a distribution in the form of installments, or a combination of methods. For termination of service due to other reasons, participants may receive their benefits in the form of a distribution equal to the value of the vested interest in their account. Distributions on account of death must be completed by December 31 of the calendar year containing the fifth anniversary of the participant's death unless a special election is made by the participant's beneficiary. The Plan allows in-service withdrawals at age 59 1/2 and hardship withdrawals under certain circumstances, as defined in the Plan document.

**Forfeited Accounts**

Forfeitures of nonvested balances of terminated participants may be used to reduce future employer contributions to the Plan or to pay plan administrative expenses at the discretion of the Company.

There were no forfeited nonvested account balances at December 31, 2024 and 2023. During 2024 and 2023, the Plan used \$9,077 and \$11,708, respectively, to reduce employer matching contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting standards generally accepted in the United States of America (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts (FBRIC). Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to FBRIC because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Use of Estimates**

The preparation of the financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for FBRIC, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Contributions**

Contributions from Plan participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses may be paid either by the Plan or directly by the Company. The Plan is not required to reimburse the Company for expenses the Company pays on behalf of the Plan. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

**NOTE 3 - CERTIFIED INFORMATION**

Certain information related to investments held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest and dividends for the years then ended, disclosed in the accompanying financial statements and ERISA-required supplemental schedule, was obtained by management and agreed to or derived from information certified by Principal Trust Company and Principal Life Insurance Company (collectively, “the custodian” or “Principal”), as complete and accurate in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Notes receivable from participants as of December 31, 2024 and 2023 and the related interest income on notes receivable from participants for the years then ended are not certified.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. The methods described below may produce a fair value calculation that may not be indicative of net realizable value or reflected of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds*

The Mutual Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts (PSA)*

The PSA invest mainly in domestic stocks and mutual funds which have observable level 1 quoted pricing inputs. The NAV of the pooled separate accounts is not publicly quoted but is available to current

investors via the custodian website or when Plan participants access their account values. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date. Therefore, those investments are considered to have a readily determinable fair value.

**NOTE 5 - GUARANTEED INVESTMENT CONTRACT - FBRIC**

The Plan has a fully benefit-responsive investment contract (FBRIC) with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The FBRIC is a single group annuity contract with a fixed rate of interest. As a result, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Under the terms of the existing contract, the crediting interest rate is based on a formula agreed upon with the issuer. The crediting rate is currently reset on a semiannual basis and will not be less than the guaranteed minimum interest rate. The minimum will range depending on prevailing market conditions, but in no case will the guaranteed minimum interest rate be less than 1% or greater than 3%. The contract provides for benefit payments at book value (i.e., no market value adjustments or surrender charge adjustments) for withdrawals due to retirement, termination of employment, disability, loans, Plan termination, or death, including participant-directed transfers. A plan fiduciary-directed surrender or transfer will be subject to 12 months' advance notice or a 5% surrender charge (subject to additional contractual limitations), whichever the Plan sponsor chooses.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the FBRIC.

The FBRIC is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Certain events limit the ability of the Plan to transact at account value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**NOTE 6 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

Plan investments are managed by Principal Trust Company. Principal is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan. There were no financial transactions recorded between the Company and the Plan other than contributions made. Notes receivable from participants also qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**NOTE 8 - TAX STATUS**

The Plan has adopted a profit-sharing prototype plan sponsored by CCH Incorporated, DBA ftwilliam.com. The prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype profit-sharing plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions for the statutory period; however, there are currently no audits for any tax periods in progress.
