Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of CareerBuilder, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about CareerBuilder, LLC 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) for the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of the CareerBuilder, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering all eligible employees, as defined, of CareerBuilder, LLC (the "Company"), who are age 18 or older. Employees can enter the Plan on the first day of any month following their eligibility. Employees are eligible for Company matching contributions upon entering the Plan. Employees are eligible for Company discretionary profit-sharing contributions upon completion of 600 hours of service during the plan year and being employed by the Company as of the last day of the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During the year ended December 31, 2024, the plan sponsor experienced a significant reduction in workforce, resulting in a partial termination of the Plan under ERISA. This partial termination was determined based on a turnover rate exceeding 20%, which is the threshold generally used to presume a partial plan termination. As a result of this partial plan termination, all affected participants became fully vested in their account balances.

CONTRIBUTIONS

Each year, participants may contribute up to the lesser of 60 percent of their eligible pretax or after-tax compensation, as defined in the Plan, or the maximum amount allowed by the Internal Revenue Service (IRS). The plan has a 3 percent automatic deferral feature for participants who do not make an affirmative deferral election. Participants who have attained age 50 before the end of the plan year may also make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may elect to make a discretionary matching contribution to the plan. During 2024, the Company made \$464,038 of matching contributions which are included in Company contributions on the statement of changes in net assets available for benefits. Employer contributions were reduced by \$160,667 from forfeited non-vested accounts, resulting in a net employer contribution of \$303,371. The Company's matching contributions are calculated based on the ratio of elective deferrals to compensation for the Plan's year. Participants must be employed at year-end to be eligible to receive matching contributions. At the discretion of the Company's Board of Directors, the Company may make profit sharing contributions. During 2024, the Company did not make a discretionary profit-sharing contribution. Contributions are subject to certain limitations.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's elective contribution, the Company's matching contribution and allocations of the Company's discretionary profit sharing contribution, if any, and investment earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balance, as defined. Each participant's account is charged with administrative fees on any loans the participant has taken. The benefit to which a participant is entitled is what can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF PLAN (Continued)

VESTING

Participants are vested immediately in their deferral contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contribution portion of their account is based on years of credited service. A participant is 50 percent vested after one year and 100 percent vested after two years of credited service. In addition, 100 percent vesting occurs upon the death, disability, or normal retirement of a participant.

INVESTMENT OPTIONS

Upon enrollment in the Plan, a participant may direct contributions into a variety of investments as more fully described in the plan agreement. Participants may change their investment options daily.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their account a minimum loan of \$500 and up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years but may be up to 30 years if used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1 percent. Rates on notes range from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates as determined by the Plan Administrator, at the time of origination. Principal and interest is paid ratably through payroll deductions. The participants may have one loan outstanding at any time.

PAYMENT OF BENEFITS

On termination of service due to death, disability, normal retirement, or upon reaching the age of 73, a participant or his beneficiary may elect to receive either a lump-sum distribution, an installment distribution, or partial withdrawals equal to the value of the participant's vested interest in his or her account. Upon termination of services for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum payment. Withdrawals may also be made from the Plan in cases of financial hardship in form of a lump-sum.

FORFEITED ACCOUNTS

At December 31, 2024 and 2023, forfeited non-vested totaled \$402,738 and \$167,437, respectively. Forfeitures may be used to reduce future employer contributions or pay plan expenses. In 2024, the Plan paid no administrative expenses from forfeited non-vested accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The summary of significant accounting policies is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, which is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with generally accepted accounting principles.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. However, as the Plan invests only in fully benefit-responsive investment contracts through its investment in a stable value common collective trust fund, contract value is deemed to be fair value.

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Due to the inherent uncertainty involved in making estimates, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note F for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

PAYMENT OF BENEFITS

Benefit obligations are recorded when paid.

EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 1, 2025, the date which the financial statements were available to be issued.

NOTE C - PLAN TERMINATION

Subsequent to year end, due to the closing of the plan sponsor, the trustees of the Plan decided to terminate the Plan. Upon Plan termination, participants will become 100% vested in their accounts, and all assets will be liquidated and paid to participants. The Plan intends to be fully liquidated as soon as administratively feasible.

NOTE D - TAX STATUS

The Plan is a non-standardized prototype plan sponsored by Empower Retirement, LLC that has been adopted by the Company. The prototype plan obtained its latest opinion letter on November 14, 2022, by which the Internal Revenue Service has determined and informed the Company that the Plan and related trust, as then designed, were designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Federal or Illinois taxing jurisdictions. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation or depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company (the trustee and custodian of the Plan).

NOTE F - FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued using the practical expedient at the net asset value (NAV) of units held by the Plan as of the end of the year.

Stable value collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust, as reported in the audited financial statements of the collective trust at year-end. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE H – PARTY-IN-INTEREST TRANSACTIONS

There were investment advisory and portfolio management fees paid directly to Morgan Stanley Smith Barney LLC, the broker for the Plan, which also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.
