We have performed audits of the financial statements of Emmi Roth USA, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## 1. Description of Plan

The following description of the Emmi Roth USA, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan established by Emmi Roth USA, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees, except for certain classes of prohibited employees, become eligible to make pre-tax and after-tax Roth contributions to the Plan on the first day of the month following 60 days of service, as defined by the Plan. The Plan's Retirement Committee is responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options.

### Contributions

Participating employees may make voluntary pre-tax and after-tax Roth contributions up to 90% of eligible compensation (deferral contributions), as defined in the Plan document, or the maximum amount defined by the Internal Revenue Service (\$23,000 for the year ended December 31, 2024), whichever is less. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of up to \$7,500 in 2024. Participants also may contribute amounts representing distributions from other qualified plans (rollover contributions).

The deferral rates of all participants deferring between 1% and 15% of eligible compensation into the Plan are automatically increased by 1% annually until a maximum deferral rate of 15% is attained, unless a contrary election is made. All newly hired employees who achieve the eligibility requirements for participation in the Plan, as defined by the plan document, are automatically enrolled in the Plan at an initial pre-tax deferral rate of 3%. Employees who are automatically enrolled will be subject to the aforementioned automatic annual deferral rate increases. Employees may forego enrollment or the automatic annual deferral rate increase by making a contrary election.

The Company makes matching contributions of 100% of the first 3% of eligible compensation and 50% of the next 2% of eligible compensation contributed by the participant. The Company may also contribute to the Plan a nonelective profit sharing contribution on an annual basis, at the discretion of the Company's Board of Directors, as a pro-rata allocation based on the participant's compensation. To be eligible for a discretionary profit-sharing contribution, the participant must have been an active employee on December 31 of the respective plan year and have completed 1,000 hours of service during the respective plan year. The Company did not make a discretionary profit-sharing contribution for the year ended December 31, 2024.

Employee deferral contributions and company matching contributions are recorded in the period the Company makes payroll deductions from the plan participants. Discretionary profit-sharing contributions are recorded in the period in which the employees earn the underlying eligible compensation upon which the contribution amount is calculated. Contributions are subject to certain limitations as defined by the IRS. In the event that contributions cause the Plan to exceed 401(k) discrimination limits, excess contributions will be refunded to the participants.

## Participant Accounts

Each participant's account is credited with the participant's contributions, company contributions, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Vesting

Participants are vested immediately in their deferral and rollover contributions and the Company's matching contributions, plus actual earnings thereon. Participants who leave the Plan because of death, early or normal retirement, or disability retirement, as defined by the plan document, are considered 100% vested. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 25% vested after two years of credited service and continues to vest in annual increments of 25% until 100% vested after five years of credited service.

## Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at the local prevailing rate, as defined. Principal and interest are paid ratably through monthly payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

## Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the plan document. The Plan provides for normal retirement at age 65. The Plan allows for benefits to be paid to active participants who have attained age 59 1/2. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or annual installments. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the plan document, including up to 100% of the portion of their account balance attributable to employee deferral and rollover contributions at any time. The Plan allows for partial withdrawals of the vested account balances of terminated employees, and requires that the vested account balances of terminated employees totaling less than \$7,000 be distributed to the participant or rolled over to another qualified retirement plan upon termination.

## Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,093 and \$3,103, respectively. These accounts may be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, plan administrative expenses were reduced by \$418, from forfeited nonvested accounts, in accordance with plan provisions.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

## Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

## Payment of Benefits

Benefits are recorded when paid.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

## Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## Subsequent Events

Subsequent events were evaluated through September 8, 2025, the date the financial statements were available to be issued.

During 2025 the Plan approved changes to the fund line-up replacing certain existing funds with new funds with similar risk characteristics.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market fund:* Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### 4. Concentrations

As of December 31, 2024 and 2023, the Plan had investments totaling \$6,357,093 and \$3,327,283 respectively, that were concentrated in two funds and one fund, respectively. These individual investments make up more than 10% of all investments in the Plan.

#### 5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental schedule, Schedule H, Line 4(j) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

#### 6. Related-Party and Party in Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company, the Trustee, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### **8. Tax Status**

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

## 1. Description of Plan

The following description of the Emmi Roth USA, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan established by Emmi Roth USA, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees, except for certain classes of prohibited employees, become eligible to make pre-tax and after-tax Roth contributions to the Plan on the first day of the month following 60 days of service, as defined by the Plan. The Plan's Retirement Committee is responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options.

### Contributions

Participating employees may make voluntary pre-tax and after-tax Roth contributions up to 90% of eligible compensation (deferral contributions), as defined in the Plan document, or the maximum amount defined by the Internal Revenue Service (\$23,000 for the year ended December 31, 2024), whichever is less. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of up to \$7,500 in 2024. Participants also may contribute amounts representing distributions from other qualified plans (rollover contributions).

The deferral rates of all participants deferring between 1% and 15% of eligible compensation into the Plan are automatically increased by 1% annually until a maximum deferral rate of 15% is attained, unless a contrary election is made. All newly hired employees who achieve the eligibility requirements for participation in the Plan, as defined by the plan document, are automatically enrolled in the Plan at an initial pre-tax deferral rate of 3%. Employees who are automatically enrolled will be subject to the aforementioned automatic annual deferral rate increases. Employees may forego enrollment or the automatic annual deferral rate increase by making a contrary election.

The Company makes matching contributions of 100% of the first 3% of eligible compensation and 50% of the next 2% of eligible compensation contributed by the participant. The Company may also contribute to the Plan a nonelective profit sharing contribution on an annual basis, at the discretion of the Company's Board of Directors, as a pro-rata allocation based on the participant's compensation. To be eligible for a discretionary profit-sharing contribution, the participant must have been an active employee on December 31 of the respective plan year and have completed 1,000 hours of service during the respective plan year. The Company did not make a discretionary profit-sharing contribution for the year ended December 31, 2024.

Employee deferral contributions and company matching contributions are recorded in the period the Company makes payroll deductions from the plan participants. Discretionary profit-sharing contributions are recorded in the period in which the employees earn the underlying eligible compensation upon which the contribution amount is calculated. Contributions are subject to certain limitations as defined by the IRS. In the event that contributions cause the Plan to exceed 401(k) discrimination limits, excess contributions will be refunded to the participants.

## Participant Accounts

Each participant's account is credited with the participant's contributions, company contributions, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Vesting

Participants are vested immediately in their deferral and rollover contributions and the Company's matching contributions, plus actual earnings thereon. Participants who leave the Plan because of death, early or normal retirement, or disability retirement, as defined by the plan document, are considered 100% vested. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 25% vested after two years of credited service and continues to vest in annual increments of 25% until 100% vested after five years of credited service.

## Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at the local prevailing rate, as defined. Principal and interest are paid ratably through monthly payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

## Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the plan document. The Plan provides for normal retirement at age 65. The Plan allows for benefits to be paid to active participants who have attained age 59 1/2. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or annual installments. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the plan document, including up to 100% of the portion of their account balance attributable to employee deferral and rollover contributions at any time. The Plan allows for partial withdrawals of the vested account balances of terminated employees, and requires that the vested account balances of terminated employees totaling less than \$7,000 be distributed to the participant or rolled over to another qualified retirement plan upon termination.

## Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,093 and \$3,103, respectively. These accounts may be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, plan administrative expenses were reduced by \$418, from forfeited nonvested accounts, in accordance with plan provisions.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

## Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

## Payment of Benefits

Benefits are recorded when paid.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

## Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## Subsequent Events

Subsequent events were evaluated through September 8, 2025, the date the financial statements were available to be issued.

During 2025 the Plan approved changes to the fund line-up replacing certain existing funds with new funds with similar risk characteristics.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market fund:* Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### 4. Concentrations

As of December 31, 2024 and 2023, the Plan had investments totaling \$6,357,093 and \$3,327,283 respectively, that were concentrated in two funds and one fund, respectively. These individual investments make up more than 10% of all investments in the Plan.

#### 5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental schedule, Schedule H, Line 4(j) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

#### 6. Related-Party and Party in Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company, the Trustee, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### **8. Tax Status**

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
