Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of NewAge Industries, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

(1) Description of Plan

The following description of NewAge Industries, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering all employees of NewAge Industries, Inc. (the Company or Sponsor), except collective bargaining employees, who are age eighteen or older. Employees become eligible for the Plan after completing 4 consecutive months of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors of the Company is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Under the plan, participants may elect to make pre-tax contributions in an aggregate amount not to exceed 100% of their annual compensation, subject to annual contribution limitations specified in the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. In addition, participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a deferral rate of 1% of eligible compensation unless they elect an alternate deferral rate or they affirmatively elect not to participate in the Plan.

The Plan has a safe harbor provision, requiring the Sponsor to contribute 5% of eligible participants' compensation. For the year ended December 31, 2024, the amount of the safe harbor contribution was \$941,819.

The Plan allows for a discretionary profit-sharing contribution to be determined by the employer. The discretionary profit-sharing contribution is allocated to each participant in proportion to their eligible compensation for the plan year to the total eligible compensation paid to all eligible employees. There was no discretionary profit-sharing contribution for the year ended December 31, 2024.

Participants' Accounts

Each participant's account is credited with the participant's contributions, Sponsor safe harbor contributions, Sponsor discretionary profit sharing contributions, and plan earnings. Participant accounts may also be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferrals and the Sponsor's safe harbor contributions, plus actual earnings or losses thereon. Upon termination from the Sponsor, participants who have attained normal retirement age or early retirement age, as defined by the Plan, are fully vested in the Sponsor's discretionary profit-sharing contribution.

For participants who have not attained retirement age, vesting in the Sponsor's discretionary profit-sharing contribution portion of their accounts is based on years of continuous service in accordance with the following schedule:

2	20%
3	40%
4	60%
5	100%

Participants' are fully vested upon death, disability, or the attainment of age 55.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the total of the participant's outstanding loan balances from the Plan, or 50% of their vested account balances. Participants are permitted to have a maximum of one loan outstanding at any given time. The loans are secured by the balance in the participants' accounts and bear interest at rates that range from 7.5% to 10.5%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. The balances are payable to the Plan in terms not to exceed 60 months (unless the purpose of the loan is to acquire a principal place of residence) in equal and consecutive weekly installments.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount up to an amount equal to the value of the participant's vested interest in his or her account. Installment payments are also allowed over a specified period. Partial withdrawals are allowed to the extent they exceed \$100. The Plan will make a mandatory distribution of a participant's vested account balance following termination from employment for participants with balances up to a maximum of \$5,000.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$347 and \$33,869, respectively. Forfeitures may be used to pay administrative costs of the Plan or to reduce employer contributions. During 2024, forfeitures of \$40,465 were used to reduce Employer contributions.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan trustees determine the Plan's valuation policies utilizing information provided by the custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based upon the terms of the plan document.

Contributions

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments to participants are charged directly to participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

(3) Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Empower Trust Company, LLC, and Empower Annuity Insurance Company of America (collectively Empower), qualified institutions.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

(5) Investment Contract with Insurance Company

The Plan has entered into a fully benefit-responsive guaranteed insurance contract with Empower through its investment in the Key Guaranteed Portfolio Fund totaling \$1,064,287 and \$1,072,931 at December 31, 2024 and 2023, respectively. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed insurance contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed insurance contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Generally, the only event that could limit the ability of the Plan to transact at contract value is a cessation of operations, as initiated by the Plan. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

There are not any events that allow the issuer to terminate the contract and would require the Sponsor to settle at an amount different than the contract value.

(6) Related Party Transactions and Party-In-Interest Transactions

One of the Plan's investments is a guaranteed investment contract which is managed by Empower. Empower is a custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees incurred by the Plan for investment management services are included in net depreciation in fair value of investments.

Administrative expenses paid by the Plan for recordkeeping and distributions amounted to \$88,316 for 2024. The Company paid directly any other fees related to the Plan's operations.

Under an agreement negotiated with Empower, the Plan is a beneficiary of a reduction of a portion of the Plan's mutual fund management fees, which are rebated to the Plan. The rebates are deposited in a plan expense account maintained by the Plan and can be used to pay plan expenses or allocated to participants as permitted by the plan document. At December 31, 2024 and 2023, the plan expense accounts totaled \$21,215 and \$39,417, respectively. During 2024, \$18,744 of this account was used to offset plan expenses.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer profit sharing contributions.

(8) Tax Status

The Plan uses a prototype plan document sponsored by Ascensus LLC. The Internal Revenue Service (IRS) has determined and informed Ascensus LLC by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(10) Nonexempt Transactions

During 2024, 2022 and 2021, the Company failed to remit to the Plan's custodian certain participant contributions within the period prescribed by the Department of Labor rules and regulations. Delinquent contributions for 2024, 2022 and 2021 aggregated to \$826, \$62,501 and \$219,411, respectively. Plan management is in the process of making the proper corrections in 2025.
