Basis for Opinion

**NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

1. DESCRIPTION OF PLAN

The following brief description of the Hobart and William Smith Colleges Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to employees of Hobart and William Smith Colleges (the Colleges) who meet certain eligibility requirements. The Plan is administered by the Retirement Plan Committee of the Colleges. Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF) are insurance companies of the Plan. TIAA, CREF and Transamerica Retirement Solutions, LLC (Transamerica) are recordkeepers of the Plan's assets. State Street Bank and Trust Company (State Street) is the custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All benefits-eligible employees of the Colleges, except for student employees, are eligible to begin salary deferrals immediately upon hire. Eligible employees, except for clergy employees, are immediately eligible to receive the Colleges' matching contributions. Eligible employees, except for clergy employees, are eligible to receive the Colleges' nonelective contributions after two-years of eligible service.

Contributions

Active participants may make voluntary contributions in the form of salary reductions and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (the Code) under Section 403(b). Eligible participants, who attain the age of 50 and/or have 15 years of service before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the Code.

The Plan was amended, effective September 1, 2024, to include an autoenrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a portfolio of investments based on the participant's normal retirement date until changed by the participant.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Colleges' contributions and allocation of the Plan earnings/losses and administrative expenses. Allocations of earnings/losses and administrative expenses are based on participant account balances according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account balance.

Funding Vehicles

Plan contributions are invested in one or more of the funding vehicles offered by the Plan as directed by the participant. The Plan does not permit plan-to-plan transfers or contract exchanges with any annuity contract or custodial account that is not a funding vehicle specifically approved by the Plan Administrator for use under the Plan.

Vesting

Participants are immediately vested in their account balance, which includes voluntary contributions, the Colleges' contributions, and actual earnings/losses thereon.

Plan Loans

Plan loans were issued directly from the funds owned by TIAA and CREF and were not issued from a participant's account. Accordingly, these loans are not presented as part of the plan assets on the statements of net assets available for benefits. An adequate portion of the participant's account is held in collateral to cover 110% of the outstanding loan in case of default. The collateral is held in the fixed annuity contract investment option. As of December 31, 2024 and 2023, total plan loans outstanding were \$94,031 and \$109,994, respectively. As of December 31, 2024 and 2023, plan loans in default were \$69,018 and \$65,458 respectively. Effective in 2020, the Plan no longer offers collateralized plan loans through TIAA and CREF.

Notes Receivable from Participants

Beginning on January 1, 2019, participants may only borrow against their respective account balance serviced by Transamerica. Participants are allowed to borrow up to the lesser of 50% of their vested account balances, or \$50,000 reduced by the highest outstanding loan balance incurred by the participant during the 12-month period ending on the day before the date on which the loan was made. A participant may borrow a minimum of \$1,000. Loans are repayable through payroll deductions over not more than five years, except in the case of a loan taken for the purpose of purchasing a primary residence. All loans bear interest at the prime rate plus 1%. Defaulted loans are deemed as distributions to the extent the law allows.

1. DESCRIPTION OF PLAN (Continued)

Payment of Benefits

Funds may be paid to participants upon either termination of employment, or the attainment of age 59 ½. Benefits are paid in lump-sum withdrawals or in periodic installments over a period that is not greater than or equal to the life expectancy of the participant.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's account. All hardship withdrawals must comply with Internal Revenue Service rules relating to hardships, which are uniformly applicable to all participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investments

Investments are reported at fair value, except for fully benefit-responsive fixed annuity contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

All investments are participant directed.

Annuity Contracts

The Plan has fully benefit-responsive contracts with TIAA. TIAA maintains Plan contributions in separate accounts. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals. Earnings on the underlying investments are guaranteed by TIAA at a rate of interest of 3%.

The Plan utilizes Retirement Annuity (RA) contracts, which are included in the non benefit-responsive fixed annuity contracts on the statements of net assets available for benefits. TIAA maintains Plan contributions in separate accounts. Under RA contracts, lump-sum withdrawals are not available to participants. All withdrawals and transfers from the account must be paid in ten annual installments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Money market funds: Valued at net asset value of shares held at year end based on quoted prices in active markets.

Registered investment companies: Valued at the net asset value of shares held at year end based on quoted prices in active markets. Included in registered investment companies are variable annuity contracts, which are valued based on quoted prices in active markets on the reporting date.

Pooled separate accounts: The fair values of interests in pooled separate accounts are measured based upon net asset value ("NAV") published on a daily basis using the fair value of the fund's underlying assets.

Non benefit-responsive fixed annuity contracts: Value is calculated as accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals.

A description of where the Plan's investments fall within the fair value hierarchy is provided in Note 4. There were no changes in valuation methodologies used during 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, political, currency, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the financial statements.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by participants. Certain management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, certain management fees and operating expenses are reflected as a reduction of net appreciation (depreciation) in fair value of investments.

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates and such differences may be significant.

5. TAX STATUS

The Plan is exempt from federal income tax under Section 403(b) of the Code.

The Plan is required to operate in conformity with the Code to maintain its tax exempt status for Plan participants. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

6. PARTY-IN-INTEREST TRANSACTIONS

TIAA, CREF and Transamerica are recordkeepers of the Plan's assets. State Street is the custodian of the Plan's assets. TIAA and CREF are insurance companies of the Plan. As such, transactions between TIAA, CREF, Transamerica, State Street and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Colleges have the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants would remain 100% vested in their accounts.

8. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.
