INDEPENDENT AUDITORS' REPORT

1) Plan Description:

- A) General – The Laboratorios Borinquen Employees Retirement Plan (the Plan) is a defined contribution plan established on July 1, 2004 by Laboratorio Clínico Borinquen, Inc. (Plan Sponsor). The Plan covers all regular employees of the Plan Sponsor and its affiliates entities: Conmed Laboratories, Inc., and Laboratorio Clínico Bairoa, Inc. The regular employees become eligible to participate in the plan after completing six (6) months of continuous service and are 21 years of age or older.

The Plan was amended effective January 1, 2008, to adopt the changes in the Popular Master Defined Contribution Retirement Plan and its associated Popular Master Trust. Subsequently, the Plan was further amended effective July 1, 2024, to implement changes to the Plan Sponsor's contributions based on years of service.

The Plan qualifies under Section 1081.01 of the Puerto Rico Internal Revenue Code (the "Code") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Banco Popular de Puerto Rico is the trustee of the Plan

Other relevant information is as follows:

Plan year	:	December 31
Normal retirement	:	Reaching age 65 or the fifth anniversary of the first day of the Plan Year in he/she commenced participation in the Plan.
Disability retirement	:	The participant will become fully vested and may retire before reaching normal retirement age upon becoming disabled.
Plan entry date	:	Monthly entry dates. The first day of each month.

- B) Contributions – The Plan provides for contributions to me made by the employers and by participants as follows:

- Pre-tax contributions – Are limited to \$15,000, as established by Section 1081.01(d)(7)(A)(i) of the Code (the Code).
- After-tax contributions – Are limited to 10% of the participant's aggregate compensation, in accordance with Section 1081.01(a)(15) of the Code.
- Catch-up contributions – Participants who have attained age 50 by the end of the calendar year may elect to make catch-up contributions of up to \$1,500 per Plan year, or such other amount as may be established by amendments to the Code.
- Rollovers contributions – Participants may contribute amounts representing rollovers from other qualified employee benefit retirement plans only if they are eligible to participate in the Plan as of the date of the contribution. For the year ended December 31, 2024, a total of approximately \$11,300 rolled into the Plan and reported as rollover contributions in the statement of changes in net assets available for benefits.

- Matching contributions – The Plan Sponsor make matching contributions based on years of service as follows:

Years of Service	Vested Percentage
Less than 5 years	.10 ¢ for each \$1 up to 10% of compensation
5 years but less than 10 years	.15 ¢ for each \$1 up to 10% of compensation
10 years but less than 20 years	.20 ¢ for each \$1 up to 10% of compensation
20 years or more	.25 ¢ for each \$1 up to 10% of compensation

- Profit-sharing contributions – Are not allowable under the Plan.

Each year, participants may elect to contribute a portion of their compensation, as defined in the Plan, not exceeding the maximum deferral amount permitted under the Code. Participants direct the investment of their contributions among various investment options offered under the Plan.

Participants may not withdraw funds from their accounts until they become eligible for benefit payments under the Plan, except under specific circumstances outlined in the Plan Document.

The total annual contributions made by both the Plan Sponsor and participants are limited to the lesser of \$69,000 or 100% of the participant's total compensation paid by the Plan Sponsor during the Plan year, as provided by Section 1081.01(a)(11)(B)(i) of the Puerto Rico Internal Revenue Code (the "Code").

- C) Participant accounts – Each participant's account is credited with the participant's contribution and allocations of the Plan Sponsor's matching contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D) Vesting – Contributions made by participants and rollover contributions, plus or minus any earnings or losses, are 100% vested at all times. The Plan Sponsor's matching contributions and their earnings will vest as follows:

2	40%
3	60%
4	80%
5 or more	100%

- E) Loans – Loans to participants from the Plan are not permitted.
- F) Investment options – Participants may decide how the contributions allocated to them are invested among the investment options offered by the Plan. If participants do not may decide how the contributions will be allocated, their contributions will be automatically allocated to the default investments based on their age. Any investment election may be changed with respect to future contributions.

- G) Payments of benefits and withdrawals – Payment of benefits from the Plan are in the form of a single lump-sum payment or installment payments at a fixed amount and a period not to exceed the life expectancy of the participant. Distributions can be paid due to a participant's retirement, death, or termination of employment, subject to conditions stated in the Plan. The Plan also provides for certain withdrawals during employment, as follows:
- Normal retirement age – The normal retirement age for each participant is the later of age 65 (not to exceed age 65) or the fifth anniversary of the participant's commencement date (not to exceed five years).
 - Disability retirement – A participant will be fully vested and may retire prior to normal retirement age upon becoming disabled.
- H) Hardship withdrawals – Participants may elect to make an in-service withdrawal of financial hardship only if the participant has an immediate and heavy financial need and the withdrawal is necessary to meet such need. The participant may not make pre-tax contributions or after-tax contributions for a period of twelve (12) months following the date of the in-service withdrawal. Also, in-service distributions may be available to participants as special disaster distributions, as determined by the Puerto Rico Treasury Department.
- I) Forfeitures – Upon a participant's termination from employment or withdrawal from the Plan for any reason other than death, retirement or disability, the Plan Sponsor's contributions on behalf of the participants not then vested are forfeited and used to reduce Plan costs and expenses. As of December 31, 2024 and 2023, forfeited accounts amounted to approximately \$8,300 and \$5,700, respectively.
- J) Plan expenses and administration – The Plan Sponsor is responsible for the general administration of the Plan and for carrying out the provisions thereof. The Plan Sponsor's contributions are held and managed by the Trustee, appointed by the Board of Directors of the Plan Sponsor, who manages cash received and interest income, and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officers or employees receive compensation from the Plan. Substantially all expenses of the Plan are paid by the Plan Sponsor.

2) Summary of Significant Accounting Policies:

The most significant accounting policies followed by the Plan are summarized below:

- A) Basis of accounting – The accompanying financial statements are prepared on the accrual basis of accounting.
- B) Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C) Interest in Master Trust – Investment assets of the Plan are maintained in the Master Trust administered by Banco Popular de Puerto Rico, as Trustee.
- D) Investment valuation and income recognition – Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction. See Note 4 for discussion of fair value measurements.

The net appreciation (depreciation) in fair value of investments, including realized gains or losses and net change in unrealized gains or losses, is reflected in the statement of changes in net assets available for benefits. Realized gains or losses on the disposal of investments are determined by specific identification and recognized on a trade date basis. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

- E) Contributions – Participant contributions are recorded in the Plan year in which the Employer makes the payroll deductions.
- F) Plan Sponsor' contributions – The Plan Sponsor's contributions may be paid in a lump-sum or installments, but the total amount should be paid to the trustee no later than the earlier of, the time (including extensions thereof) prescribed by law for filing the Plan Sponsor's Puerto Rico income tax return for its taxable year ending with or, within the plan year.
- G) Payments of benefits – Benefits payments to participants are recorded when paid.
- H) Benefits payable – The Plan accounts for benefits payable in accordance with the guidance provided by the American Institute of Certified Public Accountants (AICPA) *Audit and Accounting Guide, Audits of Employee Benefit Plans*. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan.

3) Information Certified by Banco Popular de Puerto Rico (Trustee):

The Plan's asset information as of December 31, 2024 and 2023 included throughout the Plan's financial statements and supplemental schedule, was prepared by or derived from information provided by the Trustee and furnished to the Plan's administrator.

The Plan's administrator has obtained a certification from the trustee that information provided to the Plan's administrator by the trustee related to the Plan's assets is complete and accurate. Accordingly, as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan's administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information, which appears throughout the financial statements and supplemental schedule related to the following assets:

The Trustee also certified the completeness and accuracy of \$1,108,022 of investment return related to the aforementioned assets for the year ended December 31, 2024.

4) Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The valuation techniques are based upon observable or unobservable inputs. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Master Trust's market assumptions.

These two types of inputs create the following fair value hierarchy:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Net appreciation in the fair value of the Plan's interest in the Master Trust consists of the Plan's specific share of realized gains or losses and unrealized appreciation or depreciation of those investments. The net appreciation and interest and dividends are allocated to the participating plans based upon participant Plan account balances. Information of the Master Trust's investments by level was not readily available.

Investments held by the Plan within the Master Trust are considered Level 1 type investments within the fair value hierarchy, except for the investment in obligations of U.S. governmental agencies that are considered Level 2.

6) Excess Contributions Payable:

During the years ended December 31, 2024 and 2023, the Plan did not pass the non-discrimination test required under the Internal Revenue Code. The non-compliance for the 2024 plan year was corrected on March 3, 2025, and the non-compliance for the 2023 plan year was corrected on April 23, 2024, both through the distribution of excess contributions and associated earnings to certain highly compensated employees, totaling \$40,608 and \$43,654, respectively.

7) Party-In-Interest Transactions:

Laboratorio Clínico Borinquen, Inc., Conmed Laboratories, Inc., Laboratorio Clínico Bairoa, Inc. and Banco Popular de Puerto Rico are parties-in-interest as defined by ERISA. There were no prohibited party-in-interest transactions during the years ended December 31, 2024 and 2023.

8) Plan Termination:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested and non-forfeitable in their accounts.

9) Tax Status:

The Plan is subscribed under the Trustee's Master Prototype Defined Contribution Plan (Master Plan), which has been qualified under the appropriate sections of the Puerto Rico Internal Revenue Code (the Code), as amended. The Trustee obtained its latest determination letter on May 18, 2012, in which the Puerto Rico Treasury Department stated that the Trustee's Master Plan, as then designed, was in compliance with the applicable requirements of Section 1081.01 of the Code.

The application to qualify the Plan within the Trustee's Master Plan has been approved on the determination letter dated June 24, 2013 issued by the Puerto Rico Treasury Department. The Plan's administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination of taxing authorities. The Plan Administrator evaluated the tax positions taken by the Plan and concluded that the Plan, as of December 31, 2024 and 2023, had maintained its tax-exempt status and had taken no uncertain tax positions that would require adjustments or disclosures to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

10) Risks and Uncertainties:

The Plan's investments are exposed to various risks, such as interest rate fluctuations, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the Plan's account balances and the amounts reported in the accompanying financial statements.

11) Subsequent Events:

The Plan's administrator has evaluated subsequent events through September 16, 2025, the date on which the financial statements were available to be issued and concluded there were no events or transactions that occurred during this period that required recognition and disclosure on the accompanying financial statements.
