INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Tacony Corporation Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Tacony Corporation Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tacony Corporation Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. DESCRIPTION OF THE PLAN

The following description of Tacony Corporation Retirement Plan (the "Plan"), formerly known as Tacony Corporation Employees' Profit-Sharing Plan, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

General

The Plan is a defined contribution plan for employees of Tacony Corporation (the "Company"), excluding certain divisions, who have completed one year of service. For salary deferral contributions, participants are eligible the first day of the quarter following the date of hire and attainment of age 18. For employer contributions, participants are eligible at age 18 and completion of one year of service (1,000 hours). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is governed by its Board of Trustees. Charles Schwab Bank ("Schwab") is the Plan's trustee.

Contributions

The Plan provides for four types of contributions: (i) Company profit-sharing plan contributions, which are discretionary in nature, (ii) participant 401(K) contributions equal to a percent or dollar amount of their annual compensation, as defined in the plan document, (iii) Company 401(k) matching contributions, and (iv) participant rollover contributions. Participants may elect to contribute a portion of their pre-tax eligible compensation pursuant to a salary deferral election, subject to regulatory limitations (\$23,000 for 2024). Participants may alternatively choose to make after-tax deferral contributions as a Roth contribution instead of or in addition to pre-tax deferral contributions, subject to the same limitations. In addition, all participants who have attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions, also subject to regulatory limitations (\$7,500 for 2024).

Effective January 1, 2023, the Plan was amended to change the Company matching formula to 200% of a participant's contributions to the Plan up to 5% of a participant's compensation, as defined in the plan document.

In 2024 and 2023, the Company made 401(k) matching contributions of \$1,768,215 and \$1,761,339, respectively. The Company made no profit-sharing contributions for the years ended December 31, 2024 or 2023.

Participant accounts

Each participant's account is credited with the participant's deferral and rollover contributions, the Company's contributions and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF THE PLAN (continued)

Vesting

Participants salary deferral, catch-up and rollover contributions are immediately vested, as well as any safe harbor contributions. Vesting in the Company discretionary contributions, plus earnings thereon, is based on years of continuous service. A participant is incrementally vested in the Company's contributions over six years of credited service. The non-vested balance is forfeited upon termination of service.

Payment of benefits

Upon termination of service due to termination of employment, retirement, death, disability, or other reasons, an employee may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or in installments. Hardship withdrawals are also permitted.

Notes receivable from participants

The Plan includes provisions authorizing loans to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined quarterly by the Plan Administrator.

Forfeited accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$87,876 and \$40,333, respectively. Forfeitures are used to reduce Company contributions or pay administrative expenses. For the years ended December 31, 2024 and 2023, the Company used \$0 and \$1,847 in forfeitures to reduce employer contributions, respectively.

Secure 2.0 and Cares Act

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Organization has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

Secure 2.0 and Cares Act (continued)

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security ("CARES") Act, related to participant loans and distributions. The Company has until December 31, 2026, to amend the Plan for changes allowed by the CARES Act. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect certain reported amounts of assets and liabilities therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of benefits

Benefit payments to participants are recorded when distributed.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and recorded as a benefit payment based upon the terms of the Plan document.

Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Contributions and receivables

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Company, which is the pay date. The Company's matching contributions and discretionary non-elective contributions, if any, are recorded in the year they are earned and to coincide with the year in which the Company records the contributions in its general ledger. The Plan records receivables for all contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year. Rollovers are recognized when received by the Trustee.

Subsequent events

Subsequent events were evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended with respect to eligibility requirements, employer contributions and the addition of an automatic enrollment feature.

Under the amended Plan, full-time employees of the Plan Sponsor become eligible to defer eligible compensation into the Plan on the first day of the month following 1 hour of service in the first 60 days of employment and attainment of age 18. Participants are eligible for discretionary employer contributions following 1 year of service (1,000 hours) and attainment of age 18.

Additionally, vesting in employer matching contributions are subject to a two-year vesting schedule.

Subsequent events (continued)

The Plan was amended to change the Company matching formula to 140% of a participant's contributions to the Plan up to 5% of a participant's compensation.

The Plan was amended to add an automatic deferral feature for all new eligible participants. The feature has an automatic deferral percentage of 3% and automatically escalates by 1% annually to a maximum of 10%.

3. CERTIFICATION OF INVESTMENT INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Schwab has certified to the completeness and accuracy of the investment and notes receivable from participants information and the related investment earnings, interest and dividends presented in the accompanying statements of net assets available for benefits and the statements of changes in net assets available for benefits as of and for the years ended December 31, 2024 and 2023, and the Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quote prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

4. FAIR VALUE MEASUREMENTS (continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by Schwab, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Partnership interest: Valued at the NAV of the Plan's interest in limited partnerships based on the partnerships' audited financial statements. The practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

6. TAX STATUS

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by EPIC Advisors Inc. This prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since adopting the prototype plan. However, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits. Market values through the date of issuance are generally down in amounts consistent with market performance.

8. PARTY IN INTEREST TRANSACTIONS

The Plan invests in certain collective trust funds whereby the Plan's investment advisor, Moneta Group ("Moneta") is a fund investment advisor and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Moneta for investment management services are paid by the Plan through a reduction of investment return and totaled \$94,313 and \$90,732 for the years ended December 31, 2024 and 2023, respectively.

Certain Plan investments are managed by Schwab; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Schwab for administrative and investment services are paid through a reduction of investment return and amounted to \$20,250 and \$13,153 for the years ended December 31, 2024 and 2023, respectively.

9. PLAN TERMINATION

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.
