## Independent Auditors' Report

### The Plan Administrator of MPI, Incorporated 401(k) Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of MPI, Incorporated 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **1. Description of Plan**

The following description of the MPI, Incorporated 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering substantially all employees, as defined, of MPI, Incorporated (the "Company" or "Employer"). An employee must be 18 years of age or older and complete three months of service to be eligible for elective deferral and Employer contributions. Non-resident aliens, interns/co-op employees and residents of Puerto Rico are not eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Each year, participants may contribute up to 100% of their annual compensation on a pre-tax or Roth basis, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC").

The Employer makes a safe harbor matching contribution in an amount equal to 100% of a participant's elective deferral up to 4% of their eligible compensation. The Employer may also make a discretionary non-elective contribution.

#### ***Vesting***

A participant is 100% vested in their contributions and safe harbor matching contributions, including allocated earnings thereon at all times. A participant is vested in their discretionary non-elective contributions at a rate of 25% per year of service after completion of two years of service with full vesting occurring upon completion of five years of service.

If a participant attains normal retirement age, dies or becomes disabled while an employee of the Company, he or she will become 100% vested in their accounts.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The maximum number of loans that can be outstanding at any time is one. Participant loans are secured by the balance in the participant's account and bear interest at rates currently being charged on similar commercial loans by persons in the business of lending money. Principal and interest is paid ratably through payroll deductions.

### **1. Description of Plan (continued)**

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

#### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,245 and \$7,469. These amounts may be used to reduce Company contributions. During 2024, no amounts were used to reduce Company contributions.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, age 59 1/2 or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. If a participant has a balance less than \$1,000, he or she shall automatically receive a lump-sum amount equal to the value of the participant's vested interest in his or her account without his/her consent. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

### **2. Summary of Significant Accounting Policies (continued)**

#### ***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value except for the group annuity contract, which is valued at contract value. Pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These investments are required to publish their daily NAV and to transact at that price and are deemed to be actively traded. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 25, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and the net appreciation in value of investments, interest, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company and United of Omaha Life Insurance Company, qualified institutions.

United of Omaha Life Insurance Company held the Plan's assets as of December 31, 2023 and executed investment transactions from January 1, 2024 to July 1, 2024.

#### **Common/Collective Trusts**

The Plan offers various common/collective trusts through Callen and State Street. The unit values are determined on a daily basis and amounts can be redeemed daily. The Plan has no unfunded commitments related to the common/collective trusts at December 31, 2024. The Plan did not hold investments in common/collective trusts at December 31, 2023.

### **4. Investments (continued)**

#### ***Group Annuity Contract***

The Guaranteed Account (the "Account") is an insurance company guarantee, issued and backed by the general asset account of United of Omaha Life Insurance Company. The Account offers liquidity to withdraw funds for benefit payments and investment elections.

The Account is comprised of various maturity accounts. Each month, a guaranteed interest rate is declared that will apply to the most recent maturity account comprising the Account. The monthly guaranteed rate is declared and communicated to plan sponsors in advance of each month and will apply to all future contributions to that maturity account for the maturity account term. All contributions and transfers to the applicable maturity account for that month will receive the declared rate which is the guaranteed interest rate less fees. Individual participant contributions and transfers to the Account are credited an aggregated rate based on the Plan's composition of maturity account balances and corresponding rates.

Because the Account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Account. A fully benefit-responsive investment has a guarantee of principal and interest. The Plan was not invested in the Account at December 31, 2024.

### **5. Tax Status**

The Plan's prototype plan document preparer has obtained an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") stating that the Plan is designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examination by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **6. Party-in-Interest Transactions**

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary non-elective contributions.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
