Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule of Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of and for the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. DESCRIPTION OF PLAN

**General** --- The following description of the Mastercool, Inc. (the "Company") 401 (K) Salary Savings and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan was established effective January 1, 1995 and was amended and restated August 1, 2015. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees of Mastercool, Inc. 401 (K) Salary Savings and Profit Sharing Plan, the Plan administrator and sponsor are responsible for oversight of the plan and they determine the appropriateness of the Plan's investment offerings and monitors investment performance. AdvisorTrust ("AdvisorTrust") who is the custodian and trustee has certified the information related to investments and notes receivable for the years ended December 31, 2024 and 2023.

**Eligibility** --- All employees are eligible to participate in the plan, except collectively bargained employees, leased employees and non-resident aliens with no U.S. source income. All eligible employees can make voluntary salary reduction contributions, including elective deferrals. Employees can enter the Plan on the first day of the calendar month coinciding with or next following the date the employee obtains the age 21 and completes one year of eligibility services or at least 1,000 hours, provided they are an eligible employee on that date.

**Contributions** --- Each year, participants may voluntarily contribute both pre-tax and/or Roth contributions to the maximum allowable amount as mandated under the Internal Revenue Service (the lesser of 100% of eligible compensation or \$23,000, as defined in the Plan). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. At its sole discretion, the Company may contribute and allocate to each eligible Participant's account, a percentage of the Participant's elective deferrals. Employer matching contributions, if any, shall be determined as soon as administratively feasible after the end of each pay period. Contributions are subject to certain limitations. During the years ended December 31, 2024 and 2023, the Company made matching contributions of \$193,828 and \$169,754, respectively.

The Company may, in its sole discretion, make a Profit Sharing Contribution on the employees behalf after the end of the Plan Year. Profit sharing contributions will (i) first be allocated to each participants' profit sharing account in the ratio that the sum of such participants' total compensation plus his excess compensation bears to the sum of all eligible participant's total compensation plus excess compensation, but not to exceed 5.7% and (ii) the balance, if any, will then be allocated to each participant's profit sharing account in the ratio that such participant's total compensation bears to all eligible participants' total compensation. During the years ended December 31, 2024 and 2023, the Company made discretionary profit sharing contributions of \$315,000 and \$300,000, respectively.

**Participant accounts** --- Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. DESCRIPTION OF PLAN (CONT.)

**Vesting** --- Participants are fully vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service and follows the chart below.

**Notes receivable from participants** --- Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account and bear interest at rates between 4.25% - 9.5%, which is commensurate with local prevailing rates as determined by the plan administrator. The interest rate shall remain fixed throughout the duration of the loan. Principal and interest is paid ratably through bi-weekly payroll deductions. Repayment should be made through after-tax payroll deductions; however, if repayment is not made by payroll deduction, a loan shall be repaid in accordance with procedures provided by the Plan Administrator.

**Payment of benefits** --- On termination of service due to death, disability, or retirement, a participant may elect to receive either in a single lump sum or installment amounts equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeited accounts** --- At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$13,862 and \$7,787, respectively. These accounts will be used to reduce future employer contributions.

**Hardship withdrawals** --- Upon proof, to the satisfaction of the Plan administrator of an immediate and heavy financial need, amounts vested by the employee may be withdrawn for a hardship purpose. Any amounts distributed due to a hardship must be distributed in a lump-sum. Distributions are subject to the applicable provisions of the Plan agreement. The Plan was amended on April 1, 2021 to include a provision of the SECURE Act to allow participants to withdraw funds from the Plan for the birth or adoption of a child.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting** --- The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates** --- The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results can differ from those estimates.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT.)

**Investment valuation and income recognition** --- Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** --- Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a deemed distribution is recorded. During the years ended December 2024 and 2023, deemed distributed loans were \$2,983 and \$10,335, respectively.

**Payment of benefits** --- Benefit payments are recorded when paid.

**Expenses** --- Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

### 3. FAIR VALUE MEASUREMENTS (CONT.)

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued by the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the SEC. The funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 4. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of funds managed by AdvisorTrust, Inc., the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Purchases and sales of these funds are open market transactions at fair market value. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA and applicable exemptions promulgated thereunder.

### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of a Plan termination, participants would become 100% vested in their employer contributions

### 6. TAX STATUS

The Internal Revenue Service has determined and informed the Trustees by a letter dated October 31, 2011, that the Plan and related trust are designed and are currently being operated in accordance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since the Internal Revenue Service determination, the Plan administrator and the Plan's tax counsel believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to tax examinations generally three years from its latest filing.

### 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

### 8. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by AdvisorTrust, Inc. for the years ended December 31, 2024 and 2023.
