Report of Independent Auditors

1. Description of Plan

The following description of the Inspire Medical Systems, Inc. 401(k) Plan ("the Plan") provides only general information about the Plan's provisions. Participants should refer to the Plan document and summary Plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the Human Resources department of Inspire Medical Systems, Inc. ("the Company", "Employer", "the Plan Sponsor", or "Inspire").

General

The Plan was established on January 1, 2008 and is a contributory defined contribution plan covering substantially all full-time employees of the Company. Eligible participants can choose to enroll in the Plan immediately upon hire. Effective June 1, 2024 the Plan was amended to reduce the maximum annual contribution from 100% to 85% of eligible annual compensation as defined in the Plan.

Effective October 7, 2024, the Plan was amended to disallow after-tax contributions and after-tax rollover contributions as active money sources. The amendment does not impact Roth contributions, which continue to be made on an after-tax basis.

The Inspire Plan Committee ("the Plan Administrator") is responsible for the general administration of the Plan. Empower Trust Company, LLC is the trustee, and Empower Annuity Insurance Company of America is the recordkeeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Each year, participants may contribute up to 85% of eligible annual compensation as defined in the Plan, subject to Internal Revenue Service ("IRS") limitations. Salary deferral contributions include pretax deferrals and Roth deferrals. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions equal to the maximum allowed by the IRS. The Company matches 50% of the first 6% of participants' contributions. Company matching contributions were \$5,339,998 for 2024. The Company may also make discretionary contributions at the discretion of the Company's board of directors. No such amounts were contributed for 2024.

Participants direct their contributions into various investment options offered by the Plan and can change their investment options on a daily basis. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and allocations of (a) the Company's discretionary contributions, if any, and (b) Plan

earnings and losses. Plan earnings are generally allocated based on the participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The vesting on the Company's matching contributions on participant contributions and discretionary contributions, if any, plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after four years of credited service. Participants will vest 100% in the event of death or disability while employed by the Company.

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period, the forfeited contributions are reinstated. Forfeitures from non-vested accounts are used to either reduce Company matching contributions or to pay Plan administrative expenses. The unallocated forfeiture balances as of December 31, 2024 and 2023 were \$188,857 and \$63,227, respectively. Forfeitures of \$69,635 were used to reduce the Company's 2024 matching contributions. No forfeitures were used to pay 2024 administrative expenses.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. In determining the availability of a loan under the Plan, no loan may be made from post-tax contributions, such as Roth deferrals. A participant may not have more than one loan outstanding at any point in time. The loans are secured by the balance in the participant's account and bear interest at the "prime rate" plus 2%, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions over not more than five years, or 15 years for the purchase of a primary residence. If a participant terminates employment with the Company, the loan becomes due and payable in full within a reasonable period of time or the participant may request a direct rollover into another qualified plan. If the loan is not repaid, it will be treated as a distribution to the participant based upon the terms of the Plan document.

Payment of Benefits

Upon separation from service with the Company due to death, disability, retirement, or termination, a participant whose vested account balance exceeds \$5,000 may elect to receive either a lump-sum of his or her vested account balance, rollover the entire vested portion to a qualified plan, receive installment payments on an annual basis over a specified period as provided for in the Plan, or continue to maintain his or her account in the Plan. A participant whose vested account balance is \$5,000 or less may elect to receive either a lump-sum distribution equal to his or her vested account balance in cash or may elect to rollover the entire vested portion to a qualified plan. Effective April 1, 2024, the mandatory cashout distribution limit was increased from \$5,000 to \$7,000.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the IRS, and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan are generally allocated to participant accounts proportionately based on the value of account balances. Expenses directly relating to the administration of a participant's account may be charged directly to the participant's account. Expenses that are paid by the Company are excluded from these financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Contributions

Participant contributions and the matching employer contributions are recorded in the year in which the participant compensation is earned.

Payment of Benefits

Benefits are recorded when paid. There are no amounts owed to the participants who had elected to withdraw from the Plan, but had not been paid as of December 31, 2024 or 2023.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan (except for fully benefit-responsive investment contracts) are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to April 15, 2025.

3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained or derived from information provided to the Plan Administrator and certified as complete and accurate by both Empower Annuity Insurance Company of America, the issuer of the fully benefit responsive investment contract and pooled separate account, and Empower Trust Company, LLC, the trustee of the Plan.

4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3 – Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety. There were no transfers between levels during the periods ended December 31, 2024 and 2023.

The following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan.

Mutual funds: Valued at quoted market prices on the last business day of the Plan year.

Common Collective Trusts and Pooled Separate Account: The Plan holds investments in Common Collective Trusts (“CCT’s”) and a Pooled Separate Account (“PSA”). CCT’s and the PSA publish a daily Net Asset Value (NAV) per unit and the daily NAV is available to the Plan. The Plan determines that the investments in CCTs and the PSA have readily determinable fair values because the investments are equity securities in a structure similar to a mutual fund in which the fair values per unit are determined and published and are the basis for current transactions. The Plan measures the investments at the published NAV because it concludes that the quoted NAV per unit represents the price at which the investments would be sold in transactions between independent market participants. Therefore, the Plan includes the investments in its fair value measurement disclosures, including the fair value hierarchy table.

The following tables set forth by level, within the fair value hierarchy, the Plan’s assets carried at fair value.

5. Fully Benefit-Responsive Investment Contracts

The Plan holds a traditional investment contract with Empower Annuity Insurance Company of America. This stable value fund meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed general account group annuity contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code ("the Code") or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of the contract
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestitures or mergers) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

6. Risks and Uncertainties

The Plan offers investments in securities that are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Counterparty credit risk is the risk that a counterparty to a financial instrument will fail on a commitment that it has entered into with the Plan. The Plan minimizes concentrations of counterparty credit risk by undertaking transactions with multiple counterparties. The Plan's investment managers have credit policies in place and the exposure to counterparty credit risk, as well as the creditworthiness of these counterparties, is monitored on an ongoing basis.

7. Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is the recordkeeper for the Plan and, therefore these transactions qualify as party-in-interest transactions. Empower Trust Company, LLC, is the trustee of the Plan and certifies investment information, and therefore is also a related party. The Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions, however they are exempt from the prohibited transactions rules under ERISA.

8. Tax Status

The underlying pre-approved plan has received an opinion letter from the IRS dated November 14, 2022 stating that the form of the Plan is qualified under Section 401 of the Code, and therefore the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved opinion letter. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan Administrator believes the Plan, as amended, is being operated in compliance

with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Subsequent Events

Following the plan year-end, the Plan began administering certain provisions of the SECURE 2.0 Act prior to amendment of the Plan document. Effective January 1, 2025, participants aged 60 to 63 became eligible for an increased catch-up contribution limit of \$11,250, equal to 150% of the standard catch-up amount.

In addition, an amendment was executed to provide a matching contribution equal to 50% of elective deferrals, not to exceed 6% of participant compensation per Plan Year, effective January 1, 2026.

Management evaluated subsequent events for the Plan through September 30, 2025, the date the financial statements were available to be issued. The Plan is not aware of any other subsequent events which would require recognition or disclosure in the financial statements.
