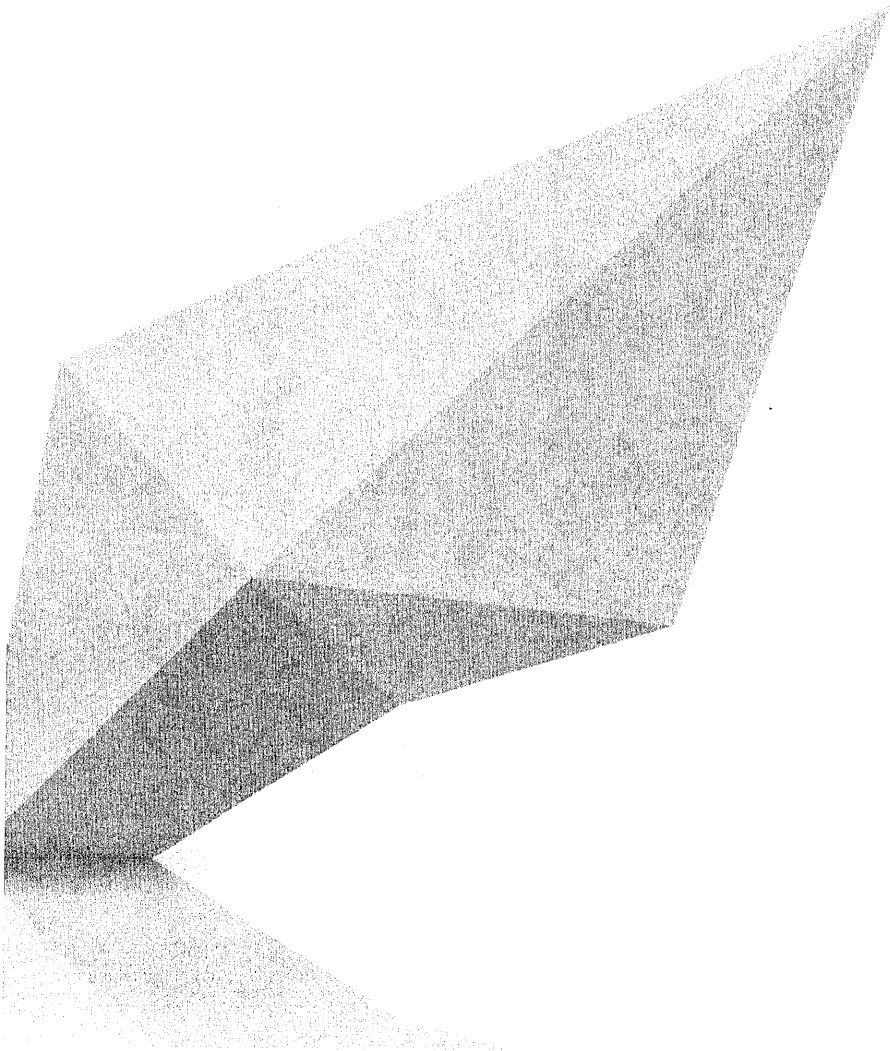

Notes to Financial Statements

Note 1: Description of Plan

The following description of the N.A. Mans & Sons Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which covers substantially all employees of N.A. Mans & Sons, Inc. (the "Company" and "Plan Sponsor"), meeting the eligibility requirements discussed below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Plan Sponsor is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustees.

Eligibility

Except for union, part-time, temporary, or seasonal employees, any employee who has provided 90 days of service and has attained the age of 21 is eligible to participate in the Plan and receive safe harbor matching contributions. Participants who are employed on the last day of the Plan year are also eligible to receive discretionary contributions. Effective January 1, 2024, under the SECURE 2.0 Act, long-term part-time employees who attained age 21 and worked at least 500 hours in the previous three consecutive years are eligible to make elective deferral contributions in the Plan. Participants may enter the Plan on the first day of the Plan year and each quarter coinciding with or following the date the eligibility requirements are met.

Contributions

Contributions to participant accounts are made by employees through tax-deferred salary and post-tax salary deductions. Participants may contribute up to 100% of their eligible compensation, not to exceed Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also directly roll over their assets from a qualified plan and transfer the assets into their Plan account ("rollover contributions"). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate deferral rate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in the Life Cycle family of funds appropriate for the participant's age and/or anticipated retirement date until changed by the participant.

The Company provides safe harbor matching contributions to eligible active participants of the Plan, at a rate equal to 100% of the employees' elective deferrals that did not exceed 3% of their compensation plus 50% of employees' elective deferrals between 3% and 5% of their compensation for the Plan. Total safe harbor matching contributions for the Plan year ended December 31, 2024 were \$799,686.

The Company may provide additional discretionary contributions to active participants; however, additional discretionary contributions were not provided during the year ended December 31, 2024.

Note 1: Description of Plan (Continued)

Rollovers

Participants who are currently employed or an eligible employee may be permitted to deposit into the Plan distributions that the participants have received from other retirement plans and certain IRAs. In 2024, there were \$283,837 of rollover contributions into the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's safe harbor and the Company's discretionary contributions and an allocation of Plan earnings or losses. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined in the Plan document. Participant accounts are charged with an allocation of Plan administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant contributions and earnings thereon are 100% vested at the date of contribution. Participants are 100% vested in safe harbor match contributions and earnings thereon after two years of credit service. Participants are 100% vested in discretionary contributions and earnings thereon after six years of credit service or upon other conditions as defined by the Plan document. In addition, a participant is fully vested upon death or disability.

Forfeitures

Forfeitures of non-vested Company contributions may be used to pay for the Plan's administrative expenses or reduce Company contributions. Forfeited nonvested accounts totaled \$2,623 and \$3,116 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$18,063 of forfeitures were utilized to reduce the Company's safe harbor matching contribution.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum amount of \$500 up to a maximum equal to the lesser of one half of their total vested account balance, or \$50,000. A maximum of one loan is allowed in any twelve month period. Loans are secured by the balance in the participant's account. Loans bear interest at a rate set by the Plan administrator in accordance with local prevailing rates for similar types of loans. Interest rates ranged from 3.25% to 8.50% on loans outstanding as of December 31, 2024 and 2023. Principal and interest payments are made ratably through payroll deductions over a term not to exceed five years.

Note 1: Description of Plan (Continued)

Payment of Benefits

Distributions are allowed upon retirement, attainment of age 59 ½, disability, death, or termination of employment. Participants or their beneficiaries may receive a lump sum distribution equal to the value of their vested interest in the account or installment payments as requested by the participant, subject to minimum distribution requirements. A participant no longer employed by the Company may be subject to various force-out provisions depending on the participant's account balance.

Subsequent Events

The Plan has evaluated subsequent events through October 2, 2025, which is the date the financial statements were available to be issued.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, or through the use of forfeitures, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

Note 3: Certification of Investment Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company ("Principal"), the Custodian of the Plan.

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Note 4: Fair Value Measurements (Continued)

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts ("PSAs"): Valued using the unadjusted NAV as of the reporting date, which is the basis for current transactions. The NAV is used as a practical expedient to estimate fair value. PSAs are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities) in the separate account as reported by the Custodian. While the majority of the underlying assets' values are based on quoted prices, NAV of the PSAs are not publicly quoted. The NAV is reported by the Custodian as of the financial statement date based on recent transaction prices. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date.

Common/collective trust funds: Valued at the NAV of units of the collective investment trust. The collective investment trust is composed primarily of fully-benefit responsive investment contracts as well as a variety of separate accounts and mutual funds. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5: Party-In-Interest Transactions

Certain plan investments are managed by Principal, the Custodian, therefore, these transactions qualify as party-in-interest transactions. In addition, certain plan investments are managed by Principal Life Insurance Company ("Principal Life"), the third-party administrator, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid to Principal Life were \$94,269 in 2024. Fees for the investment services during the plan year ended December 31, 2024 were offset against earnings. The Plan also pays various service providers for fees associated with administrative services to the Plan. These transactions also qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Company contributions.

Note 7: Tax Status

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, is in compliance with the application sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the notification letter, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
