Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Iowa State Bank 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statement of Net Assets Available for Benefits as of December 31, 2024, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Iowa State Bank 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Responsibilities of Management for the Financial Statements for the 2024 Financial Statements

December 31, 2024 and 2023

A. Description of the Plan

The following description of the Iowa State Bank 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Iowa State Bank ("the Company" and "Plan Sponsor") who are at least 19 years old and have completed 30 days of service for elective contributions. For the discretionary employer's matching contributions, eligibility is reached after completion of one year of service (defined as 1,000 hours) and the employee has attained the age of 19. Part-time, temporary and seasonal employees and janitors are excluded from the Plan. See further details in the Plan Amendments section. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant in the Plan has individual account balances representing their interest in the Plan. Additions to each account include 1) employee elective deferrals; 2) employer discretionary matching contributions; 3) investment income or loss earned on each individual's account balance; and 4) forfeitures by employees who have left the Plan prior to becoming fully vested. Accounts are charged with an allocation of any administrative expenses paid by the Plan. Allocation occurs to participants on a pro rata basis based on their account balances. Forfeitures may be used by the Plan to pay Plan expenses, offset the employer's contribution, or may be reallocated to participant accounts. Investment income or loss is added to each participant's account based on the investment performance of the fund in which the participant is invested. The Plan provides for all investments of employee elective deferrals and employer discretionary matching contributions to be self-directed by the participant. Participants are permitted to make rollover transfers from other qualified plans. Normal retirement age is the date the participant attains the age of 65. The participant can receive his/her account balance under the following methods: 1) lump-sum payment; 2) partial payments; 3) a series of substantially equal annual payments over a fixed period (i.e. fixed period installment); or 4) a specific dollar amount each year (i.e. fixed payment installment).

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. The Plan also has a Roth feature that allows participants to make contributions from after-tax compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan allows for in-Plan Roth rollover contributions from all sources. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a pooled separate account, and an insurance contract as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested pre-tax in a designated model fund until changed by the participant. Contributions are subject to certain statutory limits. Beginning January 1, 2025, the automatic enrollment percentage increased to 6 percent.

Employer Discretionary Matching Contributions

The employer makes discretionary matching contributions. For each of the years ended December 31, 2024 and 2023, the discretionary matching contribution was equal to 6 percent of eligible compensation earned by participating employees during the Plan years. The discretionary matching contribution percentage is based on a Board-approved formula. For the 2025 Plan year, the discretionary matching contribution percentage increased to 6.5 percent.

Vesting

Participants are immediately vested in their elective deferrals plus actual earnings thereon. Participants become fully vested in their allocated discretionary matching contributions after six years of service. To receive credit for a year of service, the participant must work 1,000 hours. However, the hours of service requirement is waived if the participant terminates employment on account of death, disability, or if the participant has attained normal retirement age.

Payment of Benefits

Any benefits provided by the Plan are paid from net assets available for benefits. The benefit to which a Plan member is entitled is the benefit (based on the Plan's vesting schedule) that can be provided by the contributions and income thereon allocated to such member's account. Upon disability, retirement, death or termination, the participant or beneficiary may elect to receive a lump-sum payment, partial payments, a series of substantially equal annual payments over a fixed period (i.e. fixed period installment), or a specific dollar amount each year (i.e. fixed payment installment). In the event an employee terminates participation in the Plan with a vested balance less than \$1,000, the vested balance is automatically distributed as a lump-sum payment. If the terminated participant's vested balance is between \$1,000-\$5,000, the participant has not reached age 65, and he/she does not complete a distribution request electing lump-sum or rollover, the balance is automatically rolled over into an Individual Retirement Account ("IRA"). In the event an employee terminates participation in the Plan, the non-vested contributions and allocated income are used by the Plan to pay Plan expenses, offset the employer's contribution, or are reallocated to participant accounts. Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, any adjustments necessary to properly reflect any unallocated funds (e.g., contributions, realized and unrealized gains and losses, etc.) since the last valuation date must be made. Any amounts then credited to the accounts of the participants shall become fully vested and non-forfeitable. Distribution to participants of their account balances would then be made in a lump-sum as soon as practicable after the termination date.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,478 and \$2,990, respectively. These accounts may be used by the Plan to pay Plan expenses, offset the employer discretionary matching contribution, or reallocated to participant accounts. During 2024 and 2023, \$7,599 and \$7,603, respectively, of forfeitures were used to reduce the employer discretionary matching contributions.

Investment Options

A participant may direct account balances, regardless of source, to any of several stock mutual funds, bond mutual funds, balanced mutual funds, a pooled separate account, and an insurance contract. Participants may change their investment elections at any time directly via telephone or on-line.

Discretionary Contributions

Additional discretionary contributions to the Plan are at the discretion of the participating employer and only those employees meeting the employer discretionary matching eligibility rules are eligible. Allocation of the contributions to the participant's accounts is made based upon eligible compensation while a participant in the Plan. No discretionary contributions were made for the years ended December 31, 2024 and 2023.

Plan Amendments

The Plan was amended effective February 1, 2023. Amended provision was as follows:

- Exclusion of part-time, temporary, or seasonal employees. These employees are regularly scheduled to work less than 1,000 hours of service in an entry service period.

The Plan was amended effective February 1, 2024. Amended provisions are as follows:

- Removal of part-time, temporary, and seasonal employees exclusion. Temporary and seasonal, as well as janitors, are now excludable classes.
- The "Retire Continue to Work" provision is no longer excluded (i.e., a participant can now begin to receive benefits after reaching normal retirement age even though they are still an active employee).

The Plan was amended effective January 1, 2025. Amended provisions are as follows:

- Automatic enrollment pretax deferral percentage increased from 3 percent to 6 percent.
- The above increase in automatic enrollment percentage is applicable to all active participants who were automatically enrolled under the previous provision as of January 1, 2025, and have not electively changed their deferral rates.

B. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for the fully benefit-responsive investment contract. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported a fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note F for discussion of fair value measurements. If available, quoted market prices are used to value investments.

The Plan presents, in the Statements of Changes in Net Assets Available for Benefits, the net appreciation in the fair value of its investments which consists of the realized gains or losses on investments bought and sold as well as held during the year and the unrealized appreciation on those investments. Investment related expenses are included in the net appreciation in the fair value of its investments.

Purchases and sales of securities are recorded on a trade-date basis. Investment income, net of related fees, is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Reinvested dividends in mutual funds have been included in the caption "Dividends" in the accompanying Statements of Changes in Net Assets Available for Benefits. Reinvested dividends amounted to \$412,776 for 2024 and \$366,779 for 2023.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receive compensation from the Plan. Audit fees are paid directly by the Plan Sponsor and are therefore excluded from these financial statements.

The Plan is charged an annual fee for recordkeeping services, which is a fixed fee based on a variety of factors including Plan characteristics, selected services, and selected investment options. This fee is prorated out among the twelve months of the Plan year. These fees are accumulated in the Statements of Changes in Net Assets Available for Benefits.

C. Investment Contract with Insurance Company

In 2024 and 2023, the Plan offers a fully benefit-responsive investment contract with Principal Life Insurance Company. The investment contract is a guaranteed interest account provided through a group annuity contract. The relevant administering body maintains the contributions in an allocated account at that date. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit responsive, contract value is the relevant measurement attributed to that portion of the net assets available for benefits attributable to the guaranteed investment contract.

The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by the relevant administering body, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$4,502,141 and \$4,766,288, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, and was 2.55% and 1.90% at December 31, 2024 and 2023, respectively. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events might limit the ability of the Plan to transact at contract value with the relevant administering body. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines; (2) a violation of a material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the contract without the issuer's consent. The Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

D. Tax Status

The Plan is designed to be in compliance with the provisions of the Employee Retirement Income Security Act of 1974 and related regulations. The United States Treasury Department has advised that the Plan and any amendments thereto constitutes a qualified trust under Section 401(a) of the Internal Revenue Code and is therefore exempt from Federal income taxes under the provisions of Section 501(a).

The Plan adopted a prototype profit sharing plan document of the Principal Financial Group which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore, believes that the Plan is qualified. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan has no federal or state tax examinations currently in process. As required by accounting principles generally accepted in the United States of America, management has evaluated the Plan's tax positions and concluded that the Plan had taken no uncertain tax positions that would require recognition in the financial statements.

E. Information Prepared and Certified by Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends and interest for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Trust Company (the trustee of the Plan). Accordingly, Principal Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Market Values of Pooled Separate Account and Mutual Fund investments
- Contract Value of the Fully Benefit-Responsive Investment Contract Investment
- Investment Income, including Net Appreciation in Fair Value of the Pooled Separate Account and Mutual Funds, Investment Income, Net of Fees, and Dividend Income

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

F. Fair Value Measurements and Disclosures

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair values hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. There were no level 3 inputs for the periods presented.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled Separate Account: Valued based on the fund's daily net asset value ("NAV"), which is considered by Plan management to be of fair value. The unit value of the funds is calculated daily.

Mutual Funds: Valued at the daily closing price as reported by the fund. These funds are actively traded and are required to publish their daily NAV and to transact at that price.

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

G. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

H. Related Party Transactions and Party-in-Interest Transactions

The Plan receives custodial services from Principal Life Insurance Company ("Principal"), the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to Principal for recordkeeping fees of \$81,609 and \$73,565 during 2024 and 2023, respectively. Indirect compensation totaling \$35,272 and \$30,673 was paid to Cetera Advisor Networks LLC for brokerage services during 2024 and 2023, respectively. These amounts were included as a reduction of the return earned on these funds. Certain administrative fees related to the administration of the Plan were paid by the employer. These transactions also qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

I. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

J. Subsequent Events

The Plan has evaluated events and transactions occurring after December 31, 2024, for potential items required to be recognized or disclosed in the financial statements. Subsequent events were evaluated through September 16, 2025, the date the financial statements were available to be issued.
