Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Basis for opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Their report dated September 23, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Bayview Asset Management, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Bayview Asset Management, LLC (the "Company"), beginning October 1, 2008, and most recently amended January 1, 2025, under the provisions of Section 401(a) of the Internal Revenue Code (the "Code"), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the Code for the benefit of eligible employees of the Company. The Plan's primary purpose is to provide employees with retirement benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Effective January 1, 2024, participants may elect to convert their pre-tax assets into in-Plan Roth rollover assets.

Plan Administrator and Trustee

The Plan's administrator and trustee are as follows:

- Plan Administrator - Bayview Asset Management, LLC
- Third-Party Administrator and Recordkeeper - Ascensus, Inc.
- Trustee - Ascensus Trust Company ("Ascensus")

Eligibility

Employees who are 21 years of age or older and who have completed 3 months of service are eligible to participate in the Plan.

Contributions

Participants may contribute from 1% to 50% of eligible compensation within the limitations prescribed by the Internal Revenue Service ("IRS"). For the year ended December 31, 2024, participants may contribute up to \$23,000, with those age 50 or older eligible to make an additional \$7,500 catch-up contribution, for a total contribution of \$30,500. The Company makes discretionary matching contributions, on behalf of each participant. For the year ended December 31, 2024, the discretionary matching contribution was 50% of a participant's contribution up to a maximum of the first 6% of the participant's eligible compensation contributed to the Plan.

All newly eligible employees are automatically enrolled in the Plan at a deferral rate of 3% of eligible compensation unless they affirmatively elect not to participate in the Plan. Participants may change the deferral rate for future eligible compensation at any time. The Plan does not have an escalation feature.

Rollovers

Participants are allowed to transfer their funds into the Plan from other tax-qualified plans.

Participant Accounts

Each participant's account is credited with the participant's voluntary contributions and allocations of (a) the Company's discretionary matching contributions and, (b) the Plan's earnings and appreciation in the value of investments. Participant accounts are reduced for withdrawals or distributions made to the participants, an allocation of administrative expenses paid by the plan, and investment losses and depreciation in the value of investments. Allocations are based on participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Discretionary employer matching contributions vest 20% plus earnings thereon after each year of service, beginning after the first year of service. Employees are 100% vested after five years of service. A year of vesting service is defined as a year in which an employee accrues 1,000 or more hours of service. Participants are immediately vested with respect to their contributions plus actual earnings thereon.

Investment Options

Upon enrollment in the Plan, participants elect investment options from various fund choices. All contributions are participant-directed and may be invested in one fund or allocated among different funds, subject to certain limitations set forth in the Plan. Changes in allocation of contributions among funds are permitted pursuant to Plan provisions. Under the terms of the Plan, discretionary employer matching contributions are invested in the same funds at the same percentages as chosen by the participants for their own contributions. If a participant does not make an investment election, contributions will be invested in the Plan's Qualified Default Investment Alternative.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Only current employees who are participants may borrow from their vested account balances, up to the lesser of \$50,000 or 50% of their account balance. The minimum loan amount a participant may borrow is \$1,000. Loan terms range from one to five years; however, terms may exceed five years for loans used in the purchase of a primary residence, as defined in the Code. The loans are secured by the balance in the participant's account. The interest rate for outstanding notes, which is the prime rate (as specified in the Wall Street Journal) plus 2%, ranged from 5.25% to 10.50% at both December 31, 2024 and 2023. Principal and interest are paid ratably through bi-weekly payroll deductions. No allowance for credit losses has been recorded at December 31, 2024 or December 31, 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, based on the plan provisions, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

On termination of service, including death, disability, or retirement, a participant may elect to either receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or cash installments for a period not to exceed the participant's life expectancy or the life expectancy of his or her designated beneficiary. Participants must begin receiving required minimum distributions by April 1 of the year following the year in which they attain the applicable required beginning date, as defined under the Code, regardless of whether they have terminated employment.

Forfeitures

Forfeited non-vested amounts can be used to reduce future employer contributions or to pay Plan expenses. During the years ended December 31, 2024 and 2023, there were \$167,998 and \$861,332, respectively, of forfeitures used to reduce employer contributions. Forfeitures used to pay Plan expenses were not material for the years ended December 31, 2024 and 2023. Unused forfeitures at December 31, 2024 and 2023 were \$136,856 and \$3,301, respectively.

NOTE B - SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies adhered to in the preparation of these financial statements.

Basis of Presentation

The financial statements are expressed in United States ("U.S.") dollars and have been prepared in accordance with U.S. generally accepted accounting principles ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation

Fair Value Measurements and Hierarchy

ASC Topic 820, *Fair Value Measurement and Disclosures* ("ASC 820"), clarifies the definition of fair value, establishes a framework for measuring fair value and establishes requirements for disclosure about fair value measurements. ASC 820 defines fair value as the price that would be received to sell an asset or paid to transfer a liability (i.e., the exit price) in an orderly transaction between market participants at the measurement date. In determining fair value, management uses various valuation approaches. In accordance with ASC 820, a fair value hierarchy for inputs is used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Investments measured and reported at fair value are classified and disclosed in one of the following levels within the fair value hierarchy based on the lowest level of input that is significant to the fair value measurement:

Level 1 - Valuation is based on unadjusted quoted prices in active markets for identical assets and liabilities that are accessible at the reporting date.

Level 2 - Valuation is determined from pricing inputs that are other than quoted prices in active markets that are either directly or indirectly observable as of the reporting date. Observable inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, and interest rates and yield curves that are observable at commonly quoted intervals.

Level 3 - Valuation is based on unobservable inputs that are significant to the fair value measurement and includes situations where there is little, if any, market activity for the financial instrument. The inputs into the determination of fair value generally require significant management judgment or estimation.

The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level of input that is significant to the fair value measurement.

Valuation Techniques

Money Market Funds

Valued at one dollar per share held by the Plan at year end. Money market funds held by the Plan are mutual funds invested in highly liquid, near-term instruments and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

Mutual Funds

Valued at the daily closing price as reported by the mutual fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

See NOTE D - Fair Value Measurements for further discussion of fair value.

Investment Transactions, Investment Income and Expenses

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits:

Benefits are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses in the statement of changes in net assets available for benefits. Fees related to distributions paid to participants are deducted directly from the gross distribution amount paid to the participant at the time of payment. Investment-related expenses are included in net appreciation in value of investments on the statement of changes in net assets available for benefits.

NOTE C – INVESTMENT CERTIFICATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Ascensus has certified, through its agent Ascensus, LLC, to the completeness and accuracy of:

- Investments, at fair value and notes receivable from participants as presented in the accompanying statements of net assets available for benefits at December 31, 2024 and 2023,
- Net investment income and interest income on notes receivable from participants as presented in the statement of changes in net assets available for benefits for the year ended December 31, 2024,
- Schedule H, line 4i - Schedule of assets (held at end of year) at December 31, 2024.

NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Ascensus serves as custodian and provides recordkeeping and administrative services to the Plan. As such, transactions with Ascensus and its affiliates qualify as party-in-interest transactions under ERISA. Fees paid by the Plan for recordkeeping, participant loans, distributions, and other administrative services are reported as administrative expenses in the statement of changes in net assets available for benefits.

The Plan issues loans to participants that are secured by the vested balances in the participant accounts.

NOTE F – PLAN TERMINATION

Although it has not expressed any intention to do so, the Company may terminate the Plan at any time subject to the provisions of ERISA. In the event the Plan is terminated, or upon the complete discontinuance of contributions by the Company under the Plan, participants would become 100% vested in all amounts credited to their accounts.

NOTE G – TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved 401(k) Profit Sharing Plan sponsored by Ascensus, LLC. On June 30, 2020, the IRS stated in an advisory letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Code and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that at December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

In the normal course of business, the Plan encounters various risks as described below.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE I – SUBSEQUENT EVENTS

The Plan has evaluated events and transactions that occurred during the period from the date of the financial statements through October 1, 2025, the date the Plan's financial statements were available to be issued. There were no events or transactions that occurred during the period that materially impacted the amounts or disclosures in the Plan's financial statements.
