Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of Toli Management Corp. DBA McDonald's 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from TransAmerica Life Insurance Company as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). 1. Plan Information

The following brief description of the Toli Management Corp. DBA McDonald's 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General – The Plan was established as a 401(k) plan that provides for employee participants to elect salary reduction contributions, originally established January 1, 2007, with an amendment and restatement on January 1, 2022. Through December 31, 2024, the Plan covered all full-time employees of Toli Management Corporation and its affiliates (the "Employer") who have six months of service. Beginning January 1, 2024, new rules relating to certain Long-Term Part-Time ("LTPT") employees went into effect. To be eligible to participate in the Plan, LTPT employees must have worked at least 500 hours of service in each of the previous three plan years, starting with the 2021 plan year. LTPT employees are eligible to save for retirement by deferring compensation to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Employer acts as the Sponsor of the Plan and has entrusted the maintenance of records and the duties of Plan Administrator to TAG Resources, LLC (TAG). The Employer is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Administrator and Sponsor. The custodian of the Plan's investments is Transamerica Financial Life Insurance Company (Transamerica). The Trustee of the Plan is an executive of the Sponsor.

Contributions – Eligible participants may elect to defer up to 90% of their compensation, through a percentage or a fixed dollar amount by contributing to their accounts in the Plan, on a pre-tax basis, or post-tax basis in the form of Roth contributions, subject to the maximum allowable under the Internal Revenue Code (the "Code"). Highly compensated employees are subject to additional limits set forth in the Code. Participants who have attained age 50 before the end of the Plan year are permitted to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified retirement plans and/or Individual Retirement Accounts ("IRAs"). Rollovers are not permitted from a Roth IRA. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts as investment options for participants.

Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution and Plan earnings and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting of Participants' Accounts – Participants are immediately vested in their contributions plus actual earnings thereon.

Payment of Benefits - On termination of service due to death, disability or retirement, participants become 100% vested in their employer contribution accounts. For termination of service prior to retirement, participants will receive the value of their vested account in a lump-sum payment.

Notes Receivable from Participants – Participants may not borrow from the plan.

Forfeitures - Forfeitures of unvested Plan matching contributions from terminated participant accounts are used to offset future Employer matching contributions or to pay Plan expenses. As of December 31, 2024 and 2023, the forfeiture balance was \$6,913 and \$6,526, respectively, and net additions from the balance during the year ended December 31, 2024 were \$6,913.

2. Summary of Significant Accounting Policies

Basis of Presentation – The Plan prepares its financial statements on the accrual basis of accounting in accordance with the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”).

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for doubtful accounts has been recorded as of December 31, 2024. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation in fair value of investments. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan.

3. Information Prepared and Certified by Custodian

The following information included in the accompanying financial statements and supplementary information as of December 31, 2024 and 2023, and for the year ended December 31, 2024 was obtained from data that has been prepared and certified to as complete and accurate by TransAmerica Life Insurance Company, the custodian of the Plan:

4. Fair Value

ASC Topic 820, Fair Value Measurements, establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are summarized as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Although the degree of judgment exercised by the Plan in determining fair value is greatest for investments categorized in Level 3, the inputs or methodology used for valuing investments are not necessarily an indication of the risk associated with those investments.

Following is a description of the valuation methodologies used for assets measured at net asset value ("NAV") as a practical expedient. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts – Investments in pooled separate accounts are represented by a "unit of account" and per unit values whose value is the result of the accumulated values of the underlying investments. These underlying investments are public investment vehicles valued using their daily net

asset values (“NAV”) provided by the administrator of the mutual fund investments. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities and then divided by the number of shares outstanding. Pooled Separate Accounts are classified outside of the fair valuation hierarchy.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions.

6. Tax Status

The underlying prototype non-standardized plan, on which the Plan is based, has received an opinion letter from the IRS dated August 17, 2021, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code ("Code"). The Plan's sponsor has determined that it is eligible to, and has chosen to rely on, the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan's Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to income tax examinations for the years subsequent to 2021.

7. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by an affiliate of the Custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan for the investment management and custodial services were \$31,200 for the year ended December 31, 2024.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
