## INDEPENDENT AUDITORS' REPORT

To the Plan Sponsor and Participants  
Murata Machinery USA, Inc. 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Murata Machinery USA, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Murata Machinery USA, Inc 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements  
December 31, 2024 and 2023

### Note 1 - Description of Plan

The following description of Murata Machinery USA, Inc. (Company or Murata)) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Effective July 20, 2020, the Plan allowed Cimcorp USA, Inc., a company owned by the same parent company of Murata, to begin participating in the Plan under the same plan document.

#### General

The Plan is a defined contribution plan covering substantially all employees of the Company who are 18 years of age or older and who have completed at least one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Participant Accounts

Each participant's account is credited with the participant's contributions, any costs directly applicable to the participant, and allocations of (a) the Company's contributions, (b) Plan earnings (losses), and (c) any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account

#### Contributions

Each year, participants may elect to contribute up to 20% of their eligible compensation (subject to limits on elective deferrals and annual additions), as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Upon completion of certain eligibility requirements, the Company will match 50% of participants' elective deferrals, up to a maximum of 4% of Plan compensation.

The Company has the right to determine the amount of any employer matching and discretionary (profit sharing) contributions made for a Plan year. The contribution is allocated based on the employee's compensation, as defined in the Plan. The contributions are invested into the investment options elected by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and collective trust funds as investment options for participants. Contributions are subject to certain statutory limitations.

## **Note 1 - Description of Plan (continued)**

### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts is based on a five-year graded schedule of 20% vesting per year of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates available for similar loans from commercial lending institutions. Principal and interest are generally paid ratably through bi-weekly payroll deductions over a period no longer than five years unless the loan is used to acquire a principal residence in which a 10 year repayment term is allowed.

### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's interest in his or her account, a partial withdrawal or installments, or have the distribution paid as a "direct rollover" to an individual retirement account, individual retirement annuity, or another employer's tax qualified plan. The Plan allows in-service distributions upon reaching age 59 ½. For termination of service for any reason and at any age, if the value of the vested benefit is less than or equal to \$1,000, the account balance will be automatically distributed from the Plan without the participant's consent.

### Forfeited Accounts

Forfeitures of participants' nonvested account balances may be used to pay plan expenses, reduce employer contributions, or as additional employer contributions to the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$24,577 and \$8,940, respectively. During the years ended December 31, 2024 and 2023, \$38,000 and \$30,040, respectively, of forfeitures were used to pay plan expenses. For the years ended December 31, 2024 and 2023, forfeitures of \$17,195 and \$31,696, respectively, were used to reduce employer contributions.

## **Note 2 - Summary of Significant Accounting Policies**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

## **Note 2 - Summary of Significant Accounting Policies (continued)**

### Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make the required loan repayments, the loan balance is reduced, and the delinquent participant notes receivable are recorded as deemed distributions based on the terms of the Plan document. Deemed distributions for years ended December 31, 2024 and 2023, were \$40,686 and \$71,234, respectively, and are included in benefits paid to participants in the accompanying statements of changes in net assets available for benefits.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the administration of benefit payments are included in administrative expenses and charged directly to the participant's account.

### **Note 3 - Fair Value Measurements and Disclosures**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The Plan applies U.S. GAAP authoritative guidance for fair value measurements and disclosures, which defines fair value, establishes a framework for measuring fair value, and requires certain disclosures about fair value measurements. The standard describes three levels of inputs to be used to measure fair value:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Asset and liabilities within the fair value hierarchy are based on the lowest (or least observable) input that is significant to the measurement. The Plan's assessment of the significance of an input requires judgment, which may affect the valuation and classification within the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Collective investment trust funds (CIT): investment portfolios which invest in a collective trust fund as well as a variety of separate accounts and mutual funds. The fair value of the underlying investments is used in determining net asset value (NAV). The CIT's annual report with asset value information is readily available. The NAV is the basis for current transactions and the CIT can be redeemed at NAV as of the measurement date.

**Note 4 - Related-Party and Party-in-Interest Transactions**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the custodian are considered party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees paid by the Plan for investment management and recordkeeping services amounted to \$96,465 and \$81,505, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 5 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. Any unallocated assets of the Plan would be allocated to participant accounts and distributed by the Organization in accordance with Plan provisions.

### **Note 6 - Risks and Uncertainties**

The Plan invests in various investment options. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 7 - Investment Information Certified by Plan's Custodian (cash basis)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Principal Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of the following information as of December 31, 2024 and 2023, and for the years then ended, included in the Plan's financial statements and supplemental schedule that was derived from information provided by the custodian of the Plan.

**Note 9 - Tax Status and Uncertain Tax Positions**

The underlying prototype non-standardized plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. The Company has determined that it is eligible and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability (asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to December 31, 2020.

**Note 10 - Subsequent Events**

The Plan administrator has evaluated subsequent events through September 3, 2025, which is the date the financial statements were available to be issued.
