We have performed an audit of the financial statements of Global Indemnity 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1: Description of Plan

The following description of the Global Indemnity 401(k) Plan provides only general information. Participants should refer to the Plan Agreement for a complete description on the Plan's provision.

General

The Plan is the Employee Retirement Income Security Act of 1974 ("ERISA") 404c compliant, Defined Contribution 401(k) Profit Sharing Plan of GBLI Holdings, LLC (the "Company" or "plan sponsor"). An eligible employee is any employee of the Company who is: 1) an eligible employee as defined by the Plan and 2) eighteen years of age or older, except if the employee is any of the following: 1) represented by a bargaining unit that has bargained with the Company in good faith on the subject of retirement benefits; 2) a nonresident alien with no U.S. income or all such income is exempt from U.S. income tax; 3) a leased employee; 4) an individual who is considered an independent contractor or an employee of an independent contractor who is later determined by the Internal Revenue Service ("IRS") to be an employee of the Company; or 5) a part-time, temporary, or seasonal employee who is regularly scheduled to work less than 1,000 hours, until such time as the employee works 1,000 hours in a 12-month period defined in the Plan. The Plan is subject to the provisions of ERISA.

Contributions

Eligible employees may contribute up to the lesser of 100% of pay (eligible compensation, as defined in the Plan) or the limits set by federal law. The Plan also allows for Roth contributions. Rollover contributions may be made by an eligible employee or an inactive participant, provided that those contributions meet the conditions as outlined in the Plan. Eligible employees who are at least age 50 by the end of that year may make catch-up contributions. Eligible employees returning to work after a period of qualified military service can make up missed 401(k) elective deferral contributions as required by law.

The Company contributes 100% of the first 6% of eligible compensation, as defined by the Plan, equivalent to contributions made by the participant per pay period. Contributions are subject to certain IRC limitations.

Participants are able to allocate 100% of their contributions among the various investment options. Participants may change their investment options at any time with respect to future contributions or to the funds in existing investment options.

With respect to the Company's matching contributions, the participant may allocate any portion to any investment regardless of the percentage allocation of his or her deferral contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, and earnings, and is charged with administrative expenses, which are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Account Options

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, pooled separate accounts, collective investment trusts, and a common/collective trust fund as investment options for participants.

Vesting

Participants are immediately vested in their voluntary contributions, matching contributions, rollover contributions, plus actual earnings thereon.

Note Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Borrowings are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50% at December 31, 2024, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions. Terms range from one to five years or greater, for the purchase of a primary residence. Notes receivable are stated at their unpaid principal balance.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant, or their beneficiary(ies) with a vested account balance of \$5,000 or greater, may elect to receive either a lump sum amount equal to the value of the participant's vested interest their account, or annual installments over a fixed period of whole years. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Terminated individuals with a vested account balance of less than \$5,000 will automatically be distributed from the plan. The Plan also allows for in-service distributions from a participant's vested account balance upon reaching age 59½ or due to financial hardship.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are, therefore, excluded from these financial statements. Investment-related expenses are included in net realized and unrealized investment gain (loss). Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Forfeitures

Forfeitures are accumulated in a forfeiture account and are used to pay plan expenses and/or employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$0, respectively. During 2024 and 2023, respectively, \$0 and \$4,766 was used to pay plan expenses and/or employer contributions.

Secure Act and Secure Act 2.0

The Plan is currently working with their third party administrator to ensure compliance and any required plan changes are made to comply with the Secure Act and the Secure Act 2.0.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized investment gain (loss) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administration of Plan Assets

The Plan's assets are administrated under a contract with Principal Trust Co., the trustee of the Plan. The trustee invests funds received from contributions, investment sales, interest, and dividend income and makes distributions to participants.

Payment of Benefits

Amounts allocated to withdrawing participants are recorded on the Schedule H of Form 5500 and Financial Statements for Benefits Claims that have been processed and approved for payment prior to December 31 but not yet paid as of that date.

Note 3: Transactions with Parties in Interest

Certain Plan investments are funds managed by an affiliate of Principal. Principal is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Certain investment advisory services are provided by UBS Financial

Services, Inc. UBS Financial Services, Inc. receives compensation for these services and, therefore, qualifies as a fiduciary and a party-in-interest. Administrative expenses paid to the trustee for the years ended December 31, 2024 and 2023 were \$90,763 and \$83,209, respectively. Administrative expenses paid to the investment advisor for the years ended December 31, 2024 and 2023 were \$74,876 and \$74,990, respectively.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 4: Information Prepared and Certified by Trustee of the Plan

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Line 4(i), Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest on notes receivable from participants reported in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 6: Tax Status

The Company has adopted a Non-Standardized Prototype Deferred Profit Sharing Plan as prepared by Principal Life Insurance Company ("Trustee"). The prototype plan has received an opinion letter dated June 30, 2020 from the National Office of the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter, however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan is exempt from federal and state income taxes under current regulations.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a

liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Subsequent Events

The Plan has adopted FASB ASC Topic *Subsequent Events*. This guidance defines subsequent events as events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are issued or are available to be issued. Management has evaluated subsequent events through August 6, 2025, the date on which the financial statements were available to be issued.

Note 9: Fair Value Measurement

The Plan measures its investments at fair value on a recurring basis in accordance with accounting principles generally accepted in the United States of America. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework that the authoritative guidance establishes for measuring fair value includes a hierarchy used to classify the inputs used in measuring fair value. The hierarchy prioritizes the inputs used in determining valuations into three levels. The level in the fair value hierarchy within which the fair value measurement falls is determined based on the lowest level input that is significant to the fair value measurement. The levels of the fair value hierarchy are as follows:

Level 1

Fair value is based on unadjusted quoted prices in active markets that are accessible to the Plan for identical assets. These generally provide the most reliable evidence and are used to measure fair value whenever available.

Level 2

Fair value is based on significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted market prices in active markets for similar assets or liabilities, quoted market prices in inactive markets for identical or similar assets, and other observable inputs.

Level 3

Fair value would be based on significant unobservable inputs. Examples of valuation methodologies that would result in Level 3 classification include option pricing models discounted cash flows, and similar techniques.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Fund and Collective Investment Trusts

Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. See Note 10.

Pooled Separate Accounts

Valued at the NAV of units of the separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate accounts, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.
