## FURROW GROUP 401(k) PLAN

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1 - PLAN DESCRIPTION

The following brief description of the Furrow Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all employees of the Furrow Group (Knoxville Motor Company d/b/a Mercedes Benz of Knoxville, Land Rover of Knoxville, Land Rover Porsche Chattanooga Partnership, Infiniti of Chattanooga, Furrow Auction Company and Furrow Services, LLC) ("the Company") who have completed a minimum of 90 days of service. Employees are eligible to receive employer contributions upon completing one year of eligible service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of the Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions** – The Plan is funded by participant and employer contributions. Each year, participants may contribute up to the maximum amount allowed by law of pre-tax compensation or as after-tax compensation (Roth), as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions are invested in a designated fund. The Company may make matching or profit sharing contributions at their discretion, which are limited to 6% of compensation. For the year ended December 31, 2024, the matching formula was 16.83% of the participant deferral amount, and there were no profit sharing contributions. Employer contributions are also invested as directed by the participant.

**Participant Accounts** - Each participant's account is credited with the participant's contributions, the Company's contributions and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest.

**Vesting** - Participants are fully vested in their accounts at all times.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is determined by the plan administrator by reviewing rates charged for similar types of loans by other lenders. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits** - On retirement, death, disability or termination of service, a participant (or participant's beneficiary in the event of death) may receive the vested portion of the participant's account. A participant who has attained the Plan's normal retirement age and who has not separated from service may also request distribution of their vested account balance. In addition, hardship distributions are permitted if certain criteria are met. Written requests for distributions must be submitted to the plan administrator for approval. Distributions are made in the form of lump sum payments or substantially equal installments.

**Forfeited Accounts** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$24 and \$1,166, respectively. These accounts will be used to pay administrative expenses or to reduce future employer contributions. In 2024, \$1,166 in forfeitures were used to pay administrative expenses.

## NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Under ERISA guidelines, certain delinquent loans are deemed to be distributed for IRS Form 5500 reporting.

**Contributions** - Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events** - The Plan administrator has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued. See Note 12.

## NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets in active markets;
  - Quoted prices for identical or similar assets in inactive markets;
  - Inputs other than quoted prices that are observable for the asset, such as interest rates and yield curves, implied volatilities, and credit spreads;

**NOTE 3 - FAIR VALUE MEASUREMENTS (Continued)**

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4 - GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan holds an evergreen benefit-responsive group annuity contract with Empower Annuity Insurance Company (EAIC), totaling \$231,107 and \$351,508 at December 31, 2024 and 2023, respectively. EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. The group annuity contract permits either the insurance company or the Plan sponsor to terminate the agreement with advance written notice to the other party.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE 4 - GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (Continued)**

Certain events limit the Plan’s ability to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

No events are probable of occurring that might limit the Plan’s ability to transact at contract value with EAIC and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

**NOTE 5 - INFORMATION CERTIFIED BY THE CUSTODIANS**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan, that the information in the accompanying financial statements and supplementary schedule of assets held at year end, with respect to investments, related investment activity, and notes receivable and related interest income are complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The information certified by the custodians is presented based upon their certifications.

**NOTE 6 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan holds a group annuity contract issued by EAIC and administered by Empower Retirement. EAIC and Empower Trust Company, LLC are the Plan custodians, and Empower Retirement is the Plan recordkeeper; therefore, the investment contract qualifies as a party-in-interest transaction. The Plan paid \$80,391 for the year ended December 31, 2024 in expenses related to plan operations and investment activity to various service providers. These transactions are considered to be party-in-interest transactions. Notes receivable from participants are considered to be party-in-interest transactions for which a statutory exemption from the prohibited transaction regulation exists.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 8 - TAX STATUS**

The plan sponsor adopted a non-standardized pre-approved plan document sponsored by Tennessee Pension Administrators LLC. The preapproval document received its latest determination letter dated June 30, 2020. Although the Plan has not applied for its own opinion letter and has been amended since the latest determination letter, the plan administrator and Plan management believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC, and the Plan continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

**NOTE 11 - PROHIBITED TRANSACTIONS - DELINQUENT PARTICIPANT CONTRIBUTIONS**

The plan sponsor was considered delinquent in remitting participant contributions totaling \$125 for the year ended December 31, 2024. These contributions have been remitted to the Plan in 2024, and the Company intends to reimburse the Plan for lost earnings.

**NOTE 12 - SUBSEQUENT EVENTS**

In December 2024, the Plan was amended to modify the existing Automatic Contribution Arrangement to an Eligible Automatic Contribution Arrangement, which includes a 5% automatic deferral rate for automatic enrollments, a 1% auto escalation feature up to a maximum 15%, and a 90-day permissible withdrawal period, effective April 1, 2025.
