## INDEPENDENT AUDITORS' REPORT

To the Trustees of the  
Colony Hardware Corp 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(c) Audit***

We have performed audits of the accompanying financial statements of the Colony Hardware Corp 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## NOTE 1 - DESCRIPTION OF PLAN

The following description of the Colony Hardware Corp (the "Company" or "Employer") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General* - The Plan is a defined contribution plan established for the benefit of eligible employees of the Company. All employees of the Company who have completed one month of service are automatically enrolled to participate, provided they are at least 21 years of age. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 ("ERISA"), as amended.

*Contributions* - Participants may elect to make pre-tax contributions equal to any whole percentage of their includable compensation. The Plan also has a Roth 401(k) investment option which allows participants to elect to designate all or a portion of their annual compensation, subject to the maximum limitation as defined in the Internal Revenue Code ("IRC"), as an after-tax contribution. If participants have made pre-tax 401(k) contributions prior to the addition of the Roth 401(k) option, they will not be able to re-designate their traditional 401(k) contributions. The Roth 401(k) contributions are invested separately in funds selected by the Plan administrator. The participants' Roth 401(k) account balances and earnings thereon may be withdrawn tax-free subject to the provisions of the Plan document, as revised. The contributions may not exceed the amount specified in Section 402(g)(5) of the IRC, as indexed for inflation. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate, with a default deferral rate set to 1% of eligible compensation. The Plan allows certain catch-up contributions if the participant is age 50 or over. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

The Plan has elected a safe harbor matching contribution that matches 100% of the first 3% of eligible salary deferrals and 50% of the subsequent 2% of salary deferrals, up to 5% of eligible compensation for the Plan year. The Company may also contribute a discretionary amount, which amount shall be deemed an Employer's Non-Elective Contribution.

*Participant Accounts* - Each participant's account is credited with the participant's pre-tax contribution, the Company's contributions, if applicable, and an allocation of Plan earnings and charged with an allocation of administrative expenses. Earnings allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting* - Participants are immediately vested in their voluntary pre-tax contributions and Employer discretionary matching contributions plus actual earnings thereon. Participants are fully vested in their account balances upon attaining their normal retirement date while in active service of the Company or upon the termination of credited services as a result of death or disability. Otherwise, vesting on the discretionary non-elective contributions is determined on years of service based on the following vesting schedule:

A participant must complete a full year of service based on the elapsed time method calculated based on 12 full months of employment during a Plan year to be credited with a year of service.

## NOTE 1 - DESCRIPTION OF PLAN (continued)

Notes Receivable from Participants - Participants may borrow from their fund accounts. The Plan provides for a \$1,000 minimum loan requirement. A participant may have only one outstanding loan at any time. Loan terms range from one to five years, or longer if used for the purchase of a primary residence up to ten years. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably in payments made no less frequently than quarterly through payroll deductions.

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the vested interest in his or her account by way of lump-sum distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If the value of the terminated participant's vested benefit exceeds \$1,000 but does not exceed \$5,000, the entire vested benefit may be paid to the participant by a direct rollover to an individual retirement account. In-service distributions may also be made from the Plan, these distributions may be made from a participant's vested account balance. Withdrawals from a participant's salary deferral account (excluding earnings) may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Withdrawals from a participant's accounts may also be made upon reaching age 59½, in accordance with the provisions specified in the Plan.

Investment Elections - Upon enrollment in the Plan, a participant may direct contributions among investment options in increments of one percent. Participants may change their investment choices at any time.

Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$24,291 and \$40,447, respectively. These accounts can be used to pay administrative expenses or to reduce Employer contributions. In 2024, \$33,205 of forfeited nonvested accounts were used to reduce Employer contributions.

Transfers - Effective February 1, 2024, the New South Construction Supply LLC 401(k) Retirement Plan merged into the Plan. Total account balances transferred into the Plan were \$5,000,195 for the year ending December 31, 2024.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

Administrative Expenses - Expenses incurred by the custodian and trustees with regard to the management of the Plan assets and investment advisory fees are paid for by the Plan. The Company pays for other expenses, such as administrative and accounting fees. Fees related to the administration of notes receivable from participants and other transactional costs are charged directly to the participant's account and included in the net appreciation (depreciation) in fair value of investments.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated subsequent events occurring between the end of the most recent fiscal year end and September 30, 2025, the date the financial statements were available to be issued, and has determined that there are no material events, other than noted below, that require disclosure in the financial statements.

## **NOTE 3 - CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants, for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan's assets.

## **NOTE 4 - FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

### **Level 1 Fair Value Measurements**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The fair value of the money market fund is reported at the carrying amount which approximates fair value because the instrument is liquid in nature. The money market fund held by the Plan are deemed to be actively traded.

**NOTE 5 - TAX STATUS**

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, is acceptable under Section 401(a) of the IRC. Although the Plan has not received a determination letter specific to the Plan itself, and the Plan has since been amended, the Plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its acceptance of contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is as least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

## **NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan assets include investments managed by Fidelity Investments, an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the Plan's trustee and, as such, transactions with the trustee qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$71,546 for the year ended December 31, 2024. Fees paid by the Plan for administrative and recordkeeping services amounted to \$113,147 for the year ended December 31, 2024. The Plan provides for notes receivable from participants. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA.
