### ***Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit***

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. General Information**

**Description Of The Plan**

The following description of the Baader North America Corporation 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established for the benefit of the employees of Baader North America Corporation (the Company or Plan Sponsor). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Eligibility**

Employees of the Company are eligible to participate in deferral and matching contributions upon attaining the age of 18 and completing 6 months of service.

**Contributions**

Unless otherwise elected, employees are subject to automatic enrollment in the Plan at a salary deferral rate of 5% of eligible compensation, with an automatic-escalation feature that increases contributions in 1% increments annually up to 10%, unless otherwise elected.

Each year, participants may contribute up to 85% of pretax annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also allows participants to make Roth elective contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company makes matching contributions equal to 100% of the first 1% and 55% of the next 7% of employee deferrals.

Also, at year end, the Company may elect to make a discretionary profit-sharing contribution to the Plan. For the Plan years ended December 31, 2024 and 2023, the Company made no discretionary profit-sharing contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company matching contributions and an allocation of (a) the Company discretionary profit-sharing contributions and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participant Investments**

Participants direct their deferral and Company contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options at any time throughout the year.

**Vesting**

Participants are immediately vested in their deferral contributions, the Company match, and related investment earnings. Vesting in the Company's profit-sharing contributions and earnings thereon is based on years of continuous service. Participants vest 20% each year after the first year of service and are fully vested after 5 years of continuous service. Participants are also 100% vested when they reach the age of 65 (normal retirement age), when they become totally disabled or upon death.

**Forfeitures**

Forfeited nonvested account balances are either used to pay administrative expenses, reduce Company contributions, or allocated to other Plan participants, as defined by the Plan. During the years ended December 31, 2024 or 2023, no forfeitures were available or used by the Company.

**Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The term of the loans cannot exceed five years, except for a loan that is used to acquire a principal residence. The loans must be adequately secured by the participant's vested account balance and bear interest at rates which are commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

**Payment Of Benefits**

Upon the participant's death, retirement or separation from service, the participant may elect to receive either a lump-sum amount equal to the participant's vested interest in his or her account, or through annuity options, as defined by the Plan. On termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or the beneficiary may withdraw the participant's balance as a single-sum payment.

In-service distributions may be made to a participant who has not separated from service provided the participant has attained the age of 59½.

**Participant Hardship Withdrawals**

A participant is permitted to withdraw from the Plan a portion of their account in the event of undue financial hardship.

**2. Summary Of Significant Accounting Policies**

**Basis Of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use Of Estimates**

Management uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States. Those estimates and assumptions affect the reported amounts of assets and liabilities, and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could vary from those estimates.

**Investment Valuation And Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment custodians and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid balance plus any accrued, but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan Agreement. Notes receivable from participants are secured by participants' vested account balances.

**Payment Of Benefits**

Benefit payments to participants are recorded when paid.

**Subsequent Events**

Management evaluates subsequent events through the date financial statements were available for issue, which is the date of the Independent Auditors' Report.

**3. Investments**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified by Principal Life Insurance Company and Principal Trust Company (collectively, Principal), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Principal that the information provided to the Plan Administrator related to the following information is complete and accurate to the best of their knowledge.

#### 4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2      Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds**

Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Pooled Separate Accounts**

Valued at the NAV of units held by the Plan at year end. The NAV as provided by Principal, is used as a practical expedient to estimate fair value. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are primarily comprised of shares of registered investment companies held through subaccounts of a separate account of an insurance company at December 31, 2024 and 2023. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. All pooled separate accounts have daily redemption frequencies at NAV with no redemption notice periods, and file annual reports on Form 5500 as direct filing entities. There are no capital commitments related to any of the Plan's pooled separate accounts.

**Common/Collective Trusts**

Valued at the NAV of units of the individual funds. The NAV, as provided by the trustees of the invested funds, is used as a practical expedient to estimate fair value and is calculated daily by the trustee. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Withdrawals from a common/collective trust for benefit payments are made within 30 days after the request for distribution. The common/collective trusts file annual reports on Form 5500 as direct filing entities, and there are no capital commitments related to the common/collective trusts.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

During the years ended December 31, 2024 and 2023, certain administrative expenses were paid directly by the Plan.

**6. Income Tax Status**

Effective February 17, 2022, the Plan was restated with a pre-approved 401(k) profit sharing plan document for savings plans sponsored by Principal Financial Group. Principal Financial Group received an opinion letter from the IRS dated June 30, 2020 as to the pre-approved plan's qualified status. The Company has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. Although the Plan has been amended since the pre-approved plan received the letter, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**7. Party In Interest Transactions**

Certain Plan investments are units of a common/collective trust and pooled separate accounts managed by Principal or affiliates of Principal. Principal is the recordkeeper for the Plan. These transactions are considered party in interest transactions allowable under ERISA.

Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered party in interest transactions allowable under ERISA.

**8. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
