Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of University at Buffalo Surgeons, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of University at Buffalo Surgeons, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of University at Buffalo Surgeons, Inc. Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about University at Buffalo Surgeons, Inc. Retirement Plan's ability to continue as a going concern one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, listed in the table of contents, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. PLAN DESCRIPTION

The following is a brief description of the University at Buffalo Surgeons, Inc. Retirement Plan (the “Plan”) provided for general informational purposes. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan sponsored by University at Buffalo Surgeons, Inc. (the “Company” or “Plan Sponsor”). The Plan was established January 1, 1988 and restated January 1, 2016. The Plan covers eligible employees of the Plan Sponsor. The Plan consists of employer discretionary contributions. Employees are eligible to receive employer discretionary contributions on the first day of the calendar month coinciding with or next following the date of attaining 21 years of age and completing one year of eligible service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – The Plan Sponsor may, in its sole discretion, contribute to the Plan on the employee’s behalf, provided the employee has met the eligibility requirements as described in the Plan document. Contributions are allocated in an amount designated by the Company to be allocated to each group of employees. The amount allocated to one group need not bear any relationship to amounts allocated to any other group. Total contributions made on behalf of each participant may not exceed limits imposed by the Internal Revenue Code (“IRC”). Participants may direct the contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified plans.

Participant Accounts – Individual accounts are maintained for each Plan participant. Participant accounts are increased by Plan Sponsor contributions, and the participant’s share of plan earnings (allocated daily). Participant accounts are decreased by the participant’s distributions and the participant’s share of plan expenses and losses. The allocation of earnings and losses is based upon the value of an individual account in relation to the total assets of the Plan.

Vesting – Participants are immediately fully vested in their rollover contributions at all times. Vesting in Company contributions and actual earnings thereon is based on years of credited service, with 50% vested after one year and 100% vested after two years.

Forfeitures – Participants not fully vested in their Company contributions upon termination of employment forfeit their non-vested balances. Forfeitures shall be utilized to reduce Company contributions or pay for reasonable Plan expenses. During the year ended December 31, 2024, \$613 of forfeitures were utilized to offset Company contributions. There were forfeitures of \$3,186 and \$3,036 available at December 31, 2024 and 2023, respectively.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balances. Note terms range from one to five years, unless the note is for the purchase of a principal residence, in which case a longer term may be permitted. The note is secured by the balance in the participant’s account, and bear interest at a commercially reasonable rate established by AmericanTCS, (the “Plan Administrator”). There were four outstanding loans at December 31, 2024 with interest ranging from 6.75% to 10.50% and mature through December 2028. Principal and interest are paid ratably through regular payroll deductions.

1. PLAN DESCRIPTION (continued)

Payment of Benefits – A participant will be eligible for payment of benefits upon attaining normal retirement age of 59 ½, disability, or death prior to termination or severance date. Upon termination of service, a participant may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. Distributions are also permitted in the event of financial hardship, as defined by the Plan.

Administrative Expenses – Fees related to the administration of investments, notes receivable from participants, requests for distributions and record keeping fees are charged directly to the participant’s account and are included in administrative expenses.

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – The Plan determines the fair value of assets and liabilities, which are subject to be reported at fair value based on U.S. generally accepted accounting standards. The standard establishes a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded, on an exchange. Level 2 inputs generally consist of market prices for identical assets, which are not actively traded, or market prices of similar assets or liabilities, which are actively traded, on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred followed by Level 2, and Level 3. Level 3 inputs are to be used when neither Level 1 nor Level 2 inputs are available.

An investment’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments at fair value as of December 31, 2024 and 2023:

Mutual funds: Valued based on the net asset values (“NAV”) of units held by the Plan at year end. The fair values of the underlying assets in mutual funds are measured using quoted market prices in active markets for similar assets.

Common collective trust: The stable value fund primarily holds guaranteed and other similar investment contracts that are fully-benefit responsive. The fund is valued based on the NAV of the shares held by the Plan as of the year-end using NAV contract value, and generally has no redemption restrictions or unfunded capital commitments. The common collective trust has been measured at fair value using the NAV practical expedient as of December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Guaranteed annuity account: Valued based on the contracted amount and is non-benefit responsive. The Plan Sponsor has determined that the contract value for the TIAA Traditional Annuity account approximates fair value. The contract value equals the accumulated cash contributions, interest credited to the plan's contracts, and transfers in less any withdrawals and transfers out. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3%. The Plan's investment in the TIAA Traditional Annuity account yielded investment gains of 4.37% and 3.94% for the years ended December 31, 2024 and 2023, respectively.

Registered investment companies: Valued based on the quoted market prices available on an active market, which represents NAV of the shares held by the Plan at year end.

Pooled separate account: Valued based on the NAV of units held by the Plan at year end. The fair values of the underlying assets in the pooled separate account are measured using quoted prices in active markets for identical assets or on the pricing data provided by outside valuation service providers, who in turn generally use the mean of bid and ask prices, but may also use alternative observable pricing inputs for certain securities. The pooled separate account has been measured at fair value using the NAV practical expedient as of December 31, 2024 and 2023, and generally has no redemption restrictions or unfunded capital commitments.

Money market fund: Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish a daily NAV and to transact at that price. The money market fund is deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recognized on the ex-dividend date.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Subsequent Events – Management of the Plan has evaluated the effects of all subsequent events through September 23, 2025, the date which the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2). The following table sets forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31, with the exception of the pooled separate account and common collective trust that are measured at fair value using the NAV practical expedient. The fair value for the pooled separate account and common collective trust are provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

4. PARTY IN INTEREST TRANSACTIONS

TIAA-CREF and American Trust Company, the trustees of the Plan, managed certain investments of the Plan during the years ended December 31, 2024 and 2023, and therefore, transactions with TIAA-CREF and American Trust Company qualify as party in interest transactions.

5. INCOME TAX STATUS

The Plan is utilizing a prototype plan, which received a favorable determination letter from the Internal Revenue Service (“IRS”) stating that the Plan is qualified under applicable sections of the IRC and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. The Plan was amended subsequent to the IRS determination letter. The Plan Administrator believes the Plan, as amended, is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan and related trust are tax exempt.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. CERTIFIED INVESTMENT INFORMATION
