Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Description of the Plan

The following description provides only general information regarding the provisions of ACME Industrial 401(k) Salary Reduction Plan and Trust (the Plan). Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

The Plan was established on January 1, 1990, by ACME Industrial Company (the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), for the benefit of certain eligible union employees of the Company. The Plan is a defined contribution retirement plan covering employees of the Company who have completed the eligibility requirements as detailed in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation.

Employees who are not otherwise excluded from the Plan, are eligible to participate in the Plan on the first day of the calendar month, coincident with or next following the date the participant attains age 18 and completes three consecutive months of service. New employees who are eligible to participate in the Plan and do not make alternative elections are automatically enrolled at a 3% contribution rate.

Participants may elect to contribute up to a maximum of 100% of their pre-tax compensation as defined by the Plan, subject to IRC limitations. Salary deferrals may also be designated as (after-tax) Roth deferrals by participants. Participants may also roll over amounts representing distributions from other qualified retirement plans.

Contributions to the Plan are invested as directed by the participants in various investment options. In the absence of participant direction, contributions are invested in a qualified default investment alternative account until changed by the participant. Participants must evaluate their own investment goals and objectives and choose the investments best suited to achieve those goals and objectives. Poor investment performance by the investment options selected by the participants may cause their account balance to be lower than contributions made to the Plan.

Note 1. Description of the Plan (continued)

Company discretionary profit sharing contributions may be contributed to the Plan at the option of the Company's management. In addition, the Company has an agreement with Plastic Workers Union Local No. 18, AFL-CIO (the Union), which provides that the Company contribute \$0.25 per hour worked (and an additional \$0.125 for each overtime hour worked). Pursuant to the agreement with the Union, the Company also contributes \$2 per full year of service as of December 31 annually. To be eligible to receive employer contributions, union employees must be employed with the Company for one year or more of continuous service as of February 1 of each year. Employer contributions for the years ended December 31, 2024 and 2023, consist of contributions pursuant to the agreement with the Union of \$57,603 and \$49,183 respectively. There were no discretionary profit sharing contributions paid by the Company during the years ended December 31, 2024 and 2023, respectively.

Individual accounts are maintained for each participant to reflect the participant's contributions and Company contributions, as well as allocations of investment earnings or losses and administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participants are immediately fully vested in their elected deferrals, rollovers, employer contributions and actual earnings thereon.

Upon termination of service due to death, disability or retirement after age 59½, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account, partial account distributions or annual installments. For termination of service for other reasons, a participant may receive a lump-sum distribution. Account balances of terminated participants that are less than \$5,000 are automatically distributed. Distributions of balances between \$1,000 and \$5,000 are subject to automatic rollover requirements, as defined in the Plan document.

Participants in service may make hardship withdrawals upon demonstrating an immediate and heavy financial need, as allowed under federal rules.

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one outstanding note at any time. Loan terms can range up to 60 months, unless the proceeds are used to acquire the participant's principal residence, in which case, the loan may be repaid over a period longer than 60 months. The interest rate is based on prevailing market conditions and is fixed over the life of the note. The interest rate on outstanding participant notes as of December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Principal and interest are repaid ratably by the participants through payroll deductions.

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting.

Investments - Investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of either December 31, 2024 or 2023. Related fees are recorded as administrative expenses when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits - Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but were not yet paid at either December 31, 2024 or 2023.

Expenses - Certain management and administrative services are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included net appreciation in fair value of investments.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

Note 3. Priorities upon Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain fully vested in their accounts.

Note 4. Tax Status

The Company adopted a volume submitter prototype plan. The Plan is not required to receive a determination letter directly from the Internal Revenue Service, and therefore, the Plan has not received a determination specific to the Plan itself. The prototype plan determination letter has been relied upon by the Plan. The Company and the Plan Administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The following provides a description of the three levels of the fair value hierarchy:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

In accordance with generally accepted accounting principles, certain investments that are measured at fair value using the net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy.

The Plan's investments in pooled separate accounts are valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair values of the underlying investments held by the pooled separate account less its liabilities. The practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported net asset value.

Note 5. Fair Value Measurements (continued)

The Plan's investments in pooled separate accounts are available under a group annuity contract issued by John Hancock Life Insurance Company. These pooled separate accounts are allocated units of participation in sub-accounts, which represent the Plan's share of the underlying investments, consisting primarily of publicly traded fixed income and equity mutual funds. Redemptions are available daily without notice.

Note 7. Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

The Plan has a significant portion of its assets in two pooled separate accounts, American Funds 2035 Target Date Fund and American Funds 2030 Target Date Fund, which represented approximately 43% and 44% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, respectively.

Note 8. Party-in-Interest Transactions

The Plan holds units of participation in pooled separate accounts managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the Trustee and Custodian of the Plan's investment assets, and therefore, these transactions qualify as exempt party-in-interest transactions.

Note 9. Reconciliation of Financial Statements to Form 5500

The financial statements have been prepared using the accrual basis of accounting, while the Plan's Form 5500 has been prepared on the modified cash basis of accounting. The following is a reconciliation of net assets available for benefits per the financial statements to the Form 5500:
