### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Valley ENT, P.C. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 DESCRIPTION OF PLAN**

The following description of the Valley ENT, P.C. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants and others should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective January 1, 2007. The Plan has been amended throughout the years to comply with tax legislation and was most recently amended and restated effective June 17, 2024. The Plan excludes nonresident aliens and employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Retirement Plan Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Eligibility**

Employees of Valley ENT, P.C. (the Company) are eligible to make deferral contributions and participate in the safe harbor contribution upon completion of one hour of service from the date of hire. Employees are eligible to participate in the discretionary profit sharing component of the Plan upon completion of one hour of service if they are employed on the last day of the Plan year.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to contribute a minimum of 2% up to 100% of pretax annual compensation, as defined in the Plan. The annual contribution is limited to the lesser of 100% of compensation or the maximum amount allowable by the IRC. Participants are automatically enrolled with a 3% deferral withheld from their compensation as an elective deferral contribution and must opt-out to decline participation in the Plan. Company contributions consist of a nondiscretionary safe harbor contribution and a discretionary profit sharing contribution. All eligible employees are entitled to the safe harbor contribution regardless of their participation in the Plan. For the years ended December 31, 2024 and 2023, the safe harbor contribution was 3% of base earnings. Additionally, certain employees are eligible to receive a discretionary profit sharing contribution. For both years ended December 31, 2024 and 2023, the Company's profit sharing contribution was between 2% and 9% of base earnings, depending on individual participant eligibility.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contributions, and an allocation of the Plan's earnings or losses and administrative expenses. Allocations are based on participant earnings or losses or account balances, or participant transactions as defined by the Plan. The benefit, to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Vesting in the Company's contributions plus actual earnings or losses become vested to the participant's account at the rate of 20% after two years of credited service, increasing 20% for each year of credited service until the participant is 100% vested after six years of continuous service. Any qualified nonelective contributions and safe harbor contributions vest immediately. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Notes Receivable from Participants**

Participants may borrow from their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance per the provisions set forth in the Plan document. Participants are only allowed one loan outstanding at any one time. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest of the prime interest rate plus 1%. In the event the loan proceeds are to be applied to the purchase of the applicant's primary residence, the loan's duration may be for a reasonable period of time the primary residence is used. Principal and interest is paid ratably through bi-weekly payroll deductions.

**Forfeitures**

Forfeited nonvested accounts are first used to restore any participant's account that was previously forfeited but has since repaid their vested distribution or has made a valid claim. Any remaining forfeitures shall be used by the Company to offset administrative expenses and then to reduce matching contributions. At December 31, 2024 and 2023, there were approximately \$3,037 and \$8,910, respectively, in unallocated forfeitures. During the years ended December 31, 2024 and 2023, \$8,929 and \$15,538 of forfeitures were used to reduce the Company contributions, respectively.

**Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Self-Directed Brokerage Account**

Participants may direct their investments in the Plan to a self-directed account managed by Charles Schwab Bank in the Personal Choice Retirement Account (PCRA). The PCRA allows participants to invest in stocks, bonds, and mutual funds traded on major exchanges, subject to certain restrictions.

The Plan also allowed permitted participants to invest in a self-directed brokerage account that was held independently through an outside brokerage company. Effective June 17, 2024, participants may no longer invest in a self-directed brokerage account through an outside brokerage company. Any funds held in such accounts were either transferred to the PCRA or the general assets of the Plan during 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make a number of estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the third-party administrator and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Contributions**

Contributions from participants and Employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

For the year ended December 31, 2023, and the period from January 1, 2024 through June 16, 2024, certain information disclosed in the accompanying financial statements was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the custodian of the Plan. Investments and related income held in self-directed accounts outside of Charles Schwab Trust Bank for the year ended December 31, 2023, and the period ended June 16, 2024, were not covered by the certification supplied by the Plan administrator.

For the period from June 17, 2024 through December 31, 2024, T. Rowe Price Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompany statements of net assets available for benefits as of December 31, 2024, and the statement of changes in net assets available for benefits for the period from June 17, 2024 through December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in valuation methodologies for the years ended December 31, 2024 and 2023.

*Cash:* Valued at cost which approximates fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Funds:* Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order ensure that securities liquidations will be carried out in an orderly business manner.

*Self-Directed Accounts:* Self-directed brokerage accounts consist of cash equivalents, mutual funds, and unit investment trusts that are valued based on readily determinable market prices. Self-directed brokerage accounts also consist of bonds which are classified as Level 2 investments.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan is a Sungard Business Systems LLC volume submitter. The Plan administrator received an opinion letter in which the IRS stated that the volume submitter plan, as designed and amended, was in compliance with the applicable requirements of the IRC. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Some of the Plan's investments were managed by Charles Schwab Trust Bank, the custodian of the Plan. SEI Trust and Raymond James also managed certain assets of Plan's self-directed accounts. Therefore, these transactions qualified as party-in-interest transactions. Tri-Ad was the record keeper as defined by the Plan, through June 16, 2024, and qualified as a party-in-interest.

Effective June 17, 2024, the Plan transferred assets, except for assets held in the Charles Schwab PCRA, to T. Rowe Price Trust Company, the custodian of the Plan. T. Rowe Price Retirement Plan Services serves as the record keeper as a result of this transfer. Therefore, these transactions qualify as party-in-interest transactions.
