(1) Description of Plan

The following brief description of the Northeast Building Products, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering all eligible employees of Northeast Building Products, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Trustees and plan administrator are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Eligibility

Employees are eligible to participate in the Plan when they have completed 60 days of service and attained age 18. Eligibility for Profit Sharing contributions is a year of service and attained age 18.

Contributions

Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to the maximum allowable under Internal Revenue Code (IRC) guidelines. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also roll-over amounts into the Plan representing distributions from other qualified defined benefit and defined contribution plans.

The Plan includes an auto-enrollment provision whereby eligible employees, as defined, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Under the auto-enrollment provisions, 3% of the participant's compensation will be deferred and invested into a designated plan fund. The automatic deferral election will increase 1% on the first day of each subsequent year, until it equals 10% of compensation, unless the employee elects to have a different deferral percentage applied.

For the year ended December 31, 2024, in accordance with safe harbor provisions, the Company contributed 100% of each participant's elective deferrals not exceeding 3% of the participant's eligible compensation, plus 50% of each participant's elective deferrals in excess of 3% but not in excess of 5% of the participant's eligible compensation for each payroll period. The Company may also elect to make additional discretionary contributions. There was no discretionary contribution made for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of the Company's and their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor match and discretionary contributions, plus actual earnings thereon. Employer contributions prior to 2022 vest 20% after two years of credited service and vest an additional 20% for each year of credited service after that until 100% vested. A participant is 100% vested after six years of credited service, upon attainment of normal retirement age or upon death or total disability while employed by the Company.

Payments of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,274 and \$196,476, respectively. Forfeited accounts may be: (a) used to pay administrative expenses incurred by the Plan; (b) used to restore previously forfeited accounts of rehired participants; (c) allocated to eligible participants on a pro rata basis; or (d) used to reduce employer contributions. During 2024, forfeitures in the amount of \$28,751 were used to pay plan expenses and \$205,627 were used to reduce employer contributions.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(2) Summary of Significant Accounting Policies, Continued

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by Plan's custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with corresponding deduction to contributions. The Plan distributed the year-end excess contributions to the applicable participants prior to the subsequent September 15 deadline.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain costs and expenses incidental to the administration of the Plan, including asset management fees, are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Any expenses resulting from plan payments to participants are deducted from the respective participants' accounts. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

(3) Financial Information Certified by Qualified Institutions

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and other income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (Empower Annuity) and Empower Trust Company, LLC (collectively, Empower), qualified institutions.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation of methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund and mutual funds: Valued at the daily closing price as reported by the fund. The funds held by the Plan are open end funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

(5) Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with Empower Annuity. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses charged by Empower Annuity. Participants may ordinarily direct the transfer of all or a portion of their investment at contract value.

(5) Investment Contract with Insurance Company, Continued

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3%. Such interest rates are reviewed on a yearly basis for resetting.

(6) Related Party Transactions and Party-In-Interest Transactions

Certain investments are shares of a money market fund and a mutual fund managed by MassMutual Life Insurance Company, an affiliate of the custodians, and an insurance company general account managed by Empower Annuity, one of the custodians, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

Under an agreement negotiated with Empower, the Plan is a beneficiary of a reduction of a portion of the Plan's mutual fund management fees, which are rebated to the Plan. The allowance is deposited in a holding account maintained by the Plan. During 2024, the rebate income received by the Plan amounted to \$28,097 and is recorded as other income. Rebate income was used to pay plan expenses as permitted by the plan document.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(8) Income Tax Status

The Plan uses a prototype volume submitter profit sharing plan document. The volume submitter received an opinion letter from the IRS dated June 30, 2020, that indicated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, the plan administrator believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(10) Nonexempt Transactions

During 2024, the Company failed to remit certain participant contributions within the timeframe prescribed by the Department of Labor's Rules and Regulations. These transactions are considered prohibited transactions under ERISA. The Company intends to correct the failures by remitting contributions to the affected participants' accounts, including lost earnings, during 2025.
