Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ATI Holdings, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 - PLAN DESCRIPTION

The following brief description of the ATI Holdings, LLC 401(k) Profit Sharing Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan, which covers eligible employees of ATI Holdings, LLC (“the Company”) meeting certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Participant Contributions: All employees, 21 years of age or older are eligible to contribute salary deferral contributions immediately upon hire. Enrollment is available the day the eligibility requirements are satisfied. Each year, participants may elect to contribute up to 80% of annual compensation, as defined in the Plan, in the form of either pretax or Roth deferrals, subject to maximum limits established by the Internal Revenue Code (“IRC”). Participants 50 years of age or older by the end of a calendar year may elect to contribute additional catch-up contributions to the Plan. Contributions are deducted from the employee’s pay pursuant to a salary reduction agreement that the participants can modify or revoke during the plan year. Participants can also contribute amounts representing distributions from other qualified plans.

Employer Contributions: In order for employees to be eligible for employer matching contributions, employees must be making 401(k) contributions to the Plan. Employees must also have attained age 21 and have completed one year of service. One year of service is completed on the last day of the Eligibility Computation Period in which the employee is credited with 1,000 hours of service.

The employer matching contributions equal 50% of the participant deferrals, which do not exceed 6% of the participant’s compensation. For each plan year, the employer may contribute to the Plan, at its discretion, a profit-sharing contribution integrated with Social Security. If after the contribution is allocated based on a formula that is integrated with Social Security, a portion of the discretionary profit-sharing contribution has not been allocated, the remainder is allocated to eligible participants in the same proportion that compensation bears to the compensation of all eligible participants. Discretionary profit-sharing contributions are only allocated to participants employed on the last day of the plan year who have worked 1,000 hours. No discretionary contribution was authorized for the 2024 plan year.

With respect to matching contributions and discretionary profit-sharing contributions, the entry date is the first day that the participant satisfies the eligibility requirements.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, the Company’s contributions, the earnings, employer profit sharing contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Forfeitures: Forfeitures occur in the plan year that a participant receives a distribution of the entire vested account or, if the participant does not receive a distribution, after five consecutive one-year breaks in service. Forfeited amounts can be used to pay plan expenses. Forfeitures attributable to matching and discretionary contributions not used by the Plan will be used to reduce future matching and discretionary contributions to the Plan, respectively.

NOTE 1 - PLAN DESCRIPTION (Continued)

Notes Receivable from Participants: Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The principal amount of each loan to a participant will be charged against the participant's accounts in the Plan. The interest rate charged is determined by the plan administrator and is commensurate with the rate that would be charged by a bank or other professional lender for making a loan under similar circumstances. Principal and interest is paid ratably through monthly payroll deductions.

Vesting: Participants are immediately vested in their own salary deferral contributions plus actual earnings thereon. Prior to January 1, 2020, vesting was based on years of continuous service at the rate of 20% per year. Participants were fully vested after five years of service. Effective January 1, 2020, participants are vested immediately in the Company's profit sharing or matching contribution portion of their accounts.

Administrative Expenses: Administrative expenses are paid from plan assets. Loan management fees are allocated to participants' account balance. The Company also provided administrative services to the Plan at no cost.

Payment of Benefits: Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount or installment payments equal to the value of the participant's vested interest or an annuity for the life of the participant, the participant and the spouse, or the participant and a designated beneficiary. Participants may elect to withdraw their vested account balance after reaching the Plan's normal retirement age, the later of 65 or 5 years of participation, or delay until retirement. Starting the calendar year in which a participant reaches age 72 a participant may elect to receive in-service distributions in the same manner as Minimum Required Distributions, as defined in the plan document. Participants may also choose to receive a distribution of their vested account balance attributable to their salary deferrals, the Company's profit-sharing contribution account, and/or the employer matching contribution account after attaining age 59½. Amounts of \$5,000 or less may be distributed without the terminated, retired, disabled, or deceased participant's or beneficiary's consent.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Risks and Uncertainties: The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks associated with global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Stable Value Fund: The fair value of participation units in stable value fund is based on its net asset values of such fund. The fund generally provides for daily redemptions by the Plan at reported net asset value per share with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, and interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust d/b/a Principal Trust Company (the trustee of the Plan).

NOTE 4 - TAX STATUS

The Internal Revenue Service ("IRS") issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Plan management believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under the Department of Labor's regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Notes receivable from participants qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Professional and other administrative fees are paid by the Plan. Investment management fees are paid by the Plan.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. Any unallocated forfeitures would be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 7 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 1, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the plan was amended to provide that employer matching contributions will be made on a discretionary annual basis.
