**Note 1. Description of the Plan**

***General***

The following description of Crow Holdings Retirement Savings Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan, established on January 1, 1992, is a defined contribution profit-sharing plan sponsored by Crow Family, Inc. (Company or Employer) and its related adopting employers. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Vanguard Fiduciary Trust Company (Vanguard) serves as the Plan's trustee and custodian.

***Vesting and Participation***

All participant salary deferred contributions are 100% vested and nonforfeitable. Effective August 2, 2021, employer matching contributions are 100% immediately vested for current participants and employees who enter the Plan after that date. Terminated employees remain on a five-year graded vesting schedule, where employees become vested at 20% per year of service and become fully vested after five years of service.

Employees become eligible for participation at the age of 21 and upon completing 30 days of service as defined by the Plan.

***Contributions***

For the years ended December 31, 2024 and 2023, the Employer matched 100% of the salary deferrals up to the first 3% of plan compensation plus 60% of salary deferrals up to the next 1% of plan compensation plus 50% of salary deferrals up to the next 1% of plan compensation. The Employer's matching contributions are discretionary. Participant contributions are limited to 50% of annual compensation but cannot be less than 1% of the participant's annual compensation.

Contributions by participants are subject to certain limitations and maximum amounts allowed under the Internal Revenue Code (IRC). Rollover contributions are allowed from other qualified retirement plans. Participants over 50 years of age are allowed catch-up contributions subject to certain limitations.

***Participant Accounts***

Each participant's account is credited with the participant's deferred contribution and allocation of the Company's discretionary matching contribution and plan earnings on a daily basis. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investment in that fund. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

***Participant Investment Account Options***

Participants have the option of directing contributions into any of the separate investment accounts and may change the allocation daily.

***Forfeited Accounts***

Forfeitures represent the portion of nonvested benefits remaining in the Plan for all terminated employees. Forfeited balances become available to offset employer contributions or to pay plan expenses, which would be otherwise payable by the Company, in accordance with the plan document. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,077 and \$1,103, respectively. For the years ended December 31, 2024 and 2023, Company contributions were reduced by \$3,410 and \$41,832 respectively, from forfeited nonvested accounts.

***Payment of Benefits***

Upon termination of service, retirement or disability, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Participants who reach age 59½ and active participants requesting hardship withdrawals may withdraw their vested account balance subject to certain conditions and restrictions.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$1,000 and up to a maximum of the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate determined by the plan administrator. Loan repayments are made ratably through payroll deductions over a period not to exceed five years (except for loans for the purchase of a principal residence not to exceed fifteen years).

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and investments held in the brokerage option are valued at the net asset value (NAV) of shares held by the Plan at year-end. The investment held in the common collective trust is valued at NAV value per share utilizing the practical expedient at year-end.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses, or investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans may be reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administration Costs***

The Company pays all significant administrative costs for the Plan.

**Note 3. Certification of Plan Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets held at end of year as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Investments Measured Using the Net Asset Value per Share Practical Expedient**

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. The collective investment trusts invest in mutual funds, a variety of separate accounts and collective trust funds. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**Note 5. Life Insurance Policies**

Participants purchased a life insurance policy through the Plan. These policies are owned by the Plan trustees for the benefit of the insured participant. These policies are in a “paid up” status and may be distributed or canceled at the insured participant’s direction. Upon distribution of an insured participant’s total vested account balance, this policy must also be distributed to the participant. These contracts are fully allocated to the insured participant’s account. Therefore, these contracts are excluded from plan assets in the accompanying financial statements. The face amount and death benefit value of these policies totaled \$150,000 at December 31, 2024 and 2023.

**Note 6. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan invests in certain investment funds managed by an affiliate of the trustee. The Company provides certain administrative services at no cost to the Plan and pays all significant administrative costs of the Plan.

**Note 7. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Note 8. Transfers of Plan Assets**

In July 2024, certain participants were transferred into the Crow Holdings Retirement Savings Plan from Freedom Energy Operations, LLC's 401(k) Plan. An aggregate of \$1,334,114 was transferred in and is included as assets transferred in in the accompanying statements of changes in net assets available for benefits.

In December 2023, certain participants were transferred out of the Crow Holdings Retirement Savings Plan and into the RR Advisors, LLC 401(k) Plan. An aggregate of \$5,193,627 was transferred out and is included as assets transferred out in the accompanying statements of changes in net assets available for benefits.

**Note 9. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 11. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by The Vanguard Group. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 12. Subsequent Events**

Subsequent events have been evaluated through September 22, 2025, which is the date the financial statements were available to be issued.

Effective May 1, 2025, the Plan was amended to allow part-time employees to participate in the Plan after completion of thirty days of continuous service. In addition, the amendment removed the minimum age requirement for Plan eligibility and changed the service requirement to one year for participation in the Plan.
