1. Description of Plan

The following description of the Thomas Concrete, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General

The Plan is a defined contribution plan covering substantially all employees of Thomas Concrete, Inc. (the Company or Plan Sponsor) and its participating subsidiaries that have at least two months of consecutive service.

Contributions

The participants are automatically enrolled at 2% unless the participant elects otherwise. Each participant may elect to make pre-tax contributions and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus an additional \$7,500 if the employee has attained age 50 by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may make discretionary matching contributions and discretionary profit-sharing contributions to the Plan. The discretionary matching contribution is equal to a percentage of the participant's salary deferrals. The discretionary profit-sharing contribution will be divided among participants eligible to share in the contribution as defined in the Plan document. During 2024, the Company did not elect to make discretionary matching contributions or discretionary profit-sharing contributions to the Plan.

The Company makes a safe-harbor matching contribution equal to 100% of participant contributions up to 4% of eligible compensation. During 2024, the Company contributed \$2,846,269 as a safe-harbor matching contribution, which is net of \$105,534 forfeitures used to reduce employer contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings and losses on the investments in their account and is charged with certain administrative expenses and individual transaction fees. Upon enrollment in the Plan, a participant may direct their contributions to any of the investment options offered by

the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account.

Vesting

Participants are vested immediately in their contributions and safe-harbor matching contributions plus actual earnings and losses thereon. Participants who were employed with the Company on or after January 1, 2016 are immediately fully vested in Company discretionary matching and discretionary profit-sharing contributions. Participants who were terminated prior to January 1, 2016 are subject to the six year graded vesting schedule with 20% vested after two years of service and 20% each year thereafter.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have two notes outstanding at any time. The notes are secured by the balance in the participant's account and must bear a reasonable rate of interest, as defined by the Plan document. During 2024, notes had fixed rates ranging from 4.25% to 9.50% for the term of the notes, not to exceed 5 years, unless used for the purchase of a residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution. If a participant terminates employment and has a balance between \$1,000 and \$5,000, the participant may have their account paid as a direct rollover to an individual retirement account established by the Company for the benefit of the participant equal to the value of their account. If the account balance is \$1,000 or less, the participant may receive a lump-sum distribution equal to the value of their account. In-service withdrawals are permitted for participants who have attained age 59½. Participants are also eligible to receive hardship withdrawals when certain conditions are met.

Administrative Expenses

The Plan permits for payment of operational and administrative expenses, which are allocated to participant accounts proportionately based on the value of their account balances. These expenses are paid to service providers of the Plan and, therefore, qualify as party-in-interest transactions. Expenses relating to the acquisition and disposition of investments and specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the

appropriate participant's account. All other administrative expenses were paid by the Company. The Company does not expect reimbursement from the Plan for these expenses.

Forfeited Accounts

Forfeited non-vested accounts totaled \$70 and \$100,876 at December 31, 2024 and 2023, respectively. Forfeited non-vested accounts may be used to pay Plan expenses or used to reduce qualified nonelective contributions, qualified matching contributions, and safe-harbor matching contributions. During 2024, the Plan used \$0 of forfeitures to pay for administrative expenses. The Plan used \$105,534 of forfeitures to reduce safe-harbor matching contributions in 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The safe-harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. Discretionary matching and profit-sharing contributions are considered payable to the Plan when approved by the Plan's administrative committee. Any unfunded participant or employer contributions are included in the employee or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Net change in fair value of investments includes interest, dividends, realized and unrealized gains and losses on those investments, and certain operational and administrative expenses. Interest income is recorded when earned.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

As of December 31, 2024, the Company had not adopted any provisions of the SECURE 2.0 Act (the Act) of 2022. However, subsequent to year-end, management indicated its intent to adopt certain provisions effective January 1, 2025, in accordance with the Act's implementation timeline. The Company is currently evaluating the impact of these changes, and formal plan amendments are expected to be made prior to the December 31, 2026 deadline.

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 31, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

Information in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held and notes receivable from participants at December 31, 2024 and 2023, and net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the Plan's qualified institution.

4. Investments

Plan investments include a stable value fund managed by Transamerica. Transamerica is a service provider of the Plan; therefore, transactions in this investment qualifies as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments as they are paid through revenue sharing, rather than direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include public healthcare emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in the mutual fund accounts are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a stable value fund held in a common/collective trust fund. The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs. The stable value fund trades at the net asset value (NAV) which is based on the contract value of the underlying investments (Level 1). Participants transact at NAV daily in the fund. The stable

value fund includes certain redemption restrictions. If the Plan chooses to redeem all or a significant portion of the stable value fund, the issuer may require a 12-month wait period to redeem.

5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

6. Income Tax Status

The Plan is operating under a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan document offered by Ascensus, LLC (Ascensus). The Internal Revenue Service has determined and informed Ascensus by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

INDEPENDENT AUDITOR'S REPORT

To the Plan Investment Administrative Committee and Participants of the
Thomas Concrete, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Thomas Concrete, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Opinion

- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by the qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C) institutions.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified

investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Thomas Concrete, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General

The Plan is a defined contribution plan covering substantially all employees of Thomas Concrete, Inc. (the Company or Plan Sponsor) and its participating subsidiaries that have at least two months of consecutive service.

Contributions

The participants are automatically enrolled at 2% unless the participant elects otherwise. Each participant may elect to make pre-tax contributions and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus an additional \$7,500 if the employee has attained age 50 by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may make discretionary matching contributions and discretionary profit-sharing contributions to the Plan. The discretionary matching contribution is equal to a percentage of the participant's salary deferrals. The discretionary profit-sharing contribution will be divided among participants eligible to share in the contribution as defined in the Plan document. During 2024, the Company did not elect to make discretionary matching contributions or discretionary profit-sharing contributions to the Plan.

The Company makes a safe-harbor matching contribution equal to 100% of participant contributions up to 4% of eligible compensation. During 2024, the Company contributed \$2,846,269 as a safe-harbor matching contribution, which is net of \$105,534 forfeitures used to reduce employer contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings and losses on the investments in their account and is charged with certain administrative expenses and individual transaction fees. Upon enrollment in the Plan, a participant may direct their contributions to any of the investment options offered by

the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account.

Vesting

Participants are vested immediately in their contributions and safe-harbor matching contributions plus actual earnings and losses thereon. Participants who were employed with the Company on or after January 1, 2016 are immediately fully vested in Company discretionary matching and discretionary profit-sharing contributions. Participants who were terminated prior to January 1, 2016 are subject to the six year graded vesting schedule with 20% vested after two years of service and 20% each year thereafter.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have two notes outstanding at any time. The notes are secured by the balance in the participant's account and must bear a reasonable rate of interest, as defined by the Plan document. During 2024, notes had fixed rates ranging from 4.25% to 9.50% for the term of the notes, not to exceed 5 years, unless used for the purchase of a residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution. If a participant terminates employment and has a balance between \$1,000 and \$5,000, the participant may have their account paid as a direct rollover to an individual retirement account established by the Company for the benefit of the participant equal to the value of their account. If the account balance is \$1,000 or less, the participant may receive a lump-sum distribution equal to the value of their account. In-service withdrawals are permitted for participants who have attained age 59½. Participants are also eligible to receive hardship withdrawals when certain conditions are met.

Administrative Expenses

The Plan permits for payment of operational and administrative expenses, which are allocated to participant accounts proportionately based on the value of their account balances. These expenses are paid to service providers of the Plan and, therefore, qualify as party-in-interest transactions. Expenses relating to the acquisition and disposition of investments and specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the

appropriate participant's account. All other administrative expenses were paid by the Company. The Company does not expect reimbursement from the Plan for these expenses.

Forfeited Accounts

Forfeited non-vested accounts totaled \$70 and \$100,876 at December 31, 2024 and 2023, respectively. Forfeited non-vested accounts may be used to pay Plan expenses or used to reduce qualified nonelective contributions, qualified matching contributions, and safe-harbor matching contributions. During 2024, the Plan used \$0 of forfeitures to pay for administrative expenses. The Plan used \$105,534 of forfeitures to reduce safe-harbor matching contributions in 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The safe-harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. Discretionary matching and profit-sharing contributions are considered payable to the Plan when approved by the Plan's administrative committee. Any unfunded participant or employer contributions are included in the employee or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Net change in fair value of investments includes interest, dividends, realized and unrealized gains and losses on those investments, and certain operational and administrative expenses. Interest income is recorded when earned.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

As of December 31, 2024, the Company had not adopted any provisions of the SECURE 2.0 Act (the Act) of 2022. However, subsequent to year-end, management indicated its intent to adopt certain provisions effective January 1, 2025, in accordance with the Act's implementation timeline. The Company is currently evaluating the impact of these changes, and formal plan amendments are expected to be made prior to the December 31, 2026 deadline.

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 31, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

Information in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held and notes receivable from participants at December 31, 2024 and 2023, and net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the Plan's qualified institution.

4. Investments

Plan investments include a stable value fund managed by Transamerica. Transamerica is a service provider of the Plan; therefore, transactions in this investment qualifies as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments as they are paid through revenue sharing, rather than direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include public healthcare emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in the mutual fund accounts are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a stable value fund held in a common/collective trust fund. The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs. The stable value fund trades at the net asset value (NAV) which is based on the contract value of the underlying investments (Level 1). Participants transact at NAV daily in the fund. The stable

value fund includes certain redemption restrictions. If the Plan chooses to redeem all or a significant portion of the stable value fund, the issuer may require a 12-month wait period to redeem.

5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

6. Income Tax Status

The Plan is operating under a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan document offered by Ascensus, LLC (Ascensus). The Internal Revenue Service has determined and informed Ascensus by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
