To Whom It May Concern:

I am writing on behalf of Publication Marketing Corp to explain the circumstances surrounding our failure to file a final Form 5500 for the 2023 plan year by the required deadline.

The plan was transferred to Lyons/Resourcing Edge in 2023. Lyons was supposed to take over the plan on 1/1/2023. The previous third-party administrator did not file the final Form 5500 because it was clearly understood that Lyons had taken ownership of the assets. However, they did not take actual ownership of the assets until 5/17/2023 and a final form 5500 was not filed by the previous administrator.

This information regarding failure to file Form 5500 was not communicated to anyone here at Publication Marketing Corporation by Resourcing Edge or the previous administrator, otherwise we would have filed the final form timely.
