### NOTE A - GENERAL DESCRIPTION OF THE PLAN

A general description of the Hale Trailer Brake & Wheel, Inc. 401(k) Plan (formerly the Hale Trailer Brake & Wheel, Inc. Cash or Deferred Profit-Sharing Plan) follows. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan, which commenced December 31, 1986. All full-time employees who have completed at least one hour of service within six months of the start of their employment are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may contribute up to the applicable Internal Revenue Service annual limits. The Company's matching contribution is 50% of each participant's contribution up to a maximum of 6% of each individual's salary. The employee contributions were \$2,059,499 and \$1,874,523 in 2024 and 2023, respectively. The Company's matching contributions in 2024 and 2023 were \$774,845 and \$748,764, respectively.

The Company may also, at its own discretion, make profit-sharing contributions to the Plan. The Company's profit-sharing contribution in 2024 and 2023 was \$250,000.

#### **Participant Accounts**

A separate investment account is maintained for each Plan participant. Participants may direct the investment of their accounts into various funds specified by the Plan. Participant accounts are credited with the participant's contribution, an allocation of the Company's matching and profit-sharing contribution and an allocation of Plan earnings (losses) and charged with an allocation of administrative expenses, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Plan Loans**

Participants are eligible for a loan after completing two years of service and maintaining an account balance of \$2,000. A loan amount is limited to the lesser of \$50,000 or 50% of the participant's account. The term of a loan is five years unless the loan qualifies as a home loan (i.e., to buy a principal residence). The term of a home loan is fixed by the Plan Administrator. The interest applicable to the loan is determined at prime rate at the time of application. Repayments are made through a payroll deduction. The amount of any loan not repaid is taxed as a distribution.

#### **Vesting**

Participants are always 100% vested in their own contributions. Vesting in the Company's matching and discretionary contributions increases 20% for each year of employment, reaching 100% after five years.

#### **Payment of Benefits**

The Plan provides that under certain conditions participants may withdraw their vested interest or a portion thereof. Participants may withdraw after-tax contributions at any time. A participant is entitled to receive the value of his or her account in a lump sum distribution in the event of retirement, termination, disability, death, or the attainment of age 59 1/2 as an active employee. Benefit payments to participants are recorded upon distribution.

#### **Forfeitures**

Employees who terminate employment and are not vested will forfeit the nonvested portion of their account balance to the Plan, as specified in the plan document. The forfeitures account balance was \$320 and \$257 at December 31, 2024 and 2023, respectively.

Forfeitures shall be applied to reduce administrative expenses of the plan, then any remaining forfeitures shall be used to reduce employer contributions. During the years ended December 31, 2024 and 2023, \$10,869 and \$12,223 were used to pay plan expenses, respectively.

#### **Plan Amendments**

On December 29, 2022, the "Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act" was signed into law in the United States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act, however plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

#### **Plan Termination**

The Plan may be terminated at any time by the Company. In the event of Plan termination, distribution of participant accounts shall be in accordance with the Plan document.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies employed in the preparation of the accompanying financial statements are described below.

#### **Basis of Accounting**

The financial statements of the Hale Trailer Brake & Wheel, Inc. 401(k) Plan (the "Plan") are prepared on the accrual basis.

#### **Investment Valuation and Income Recognition**

Plan investments in mutual funds are stated at fair value. Shares of registered investment companies are valued at quoted market prices. The Plan's investments in the common collective trust is stated at net asset value as a practical expedient as reported by the trustee which include a mix of mutual funds and managed accounts. Net appreciation or depreciation of investments is reported on the statement of changes in net assets available for benefits and consists of realized gains and losses and the unrealized appreciation or depreciation of these investments. All underlying investments options are valued daily. This daily price is considered the selling price for transfers and withdrawals, and is calculated each day the principle market is open and available to any participant in the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded as of the record date.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Administrative expenses, excluding transaction fees and asset management fees, are paid by Hale Trailer Brake & Wheel, Inc. (the "Company").

#### **Party-in-Interest Transactions**

Certain participants have outstanding loans with the Plan as of December 31, 2024 and 2023. These transactions qualify as party-in-interest transactions allowable under ERISA guidelines.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### **Date of Management's Review**

Management has evaluated subsequent events through September 22, 2025, the date which the financial statements were available to be issued.

### NOTE C - ADMINISTRATION OF THE PLAN

The Plan is administered by a committee appointed by Barry Hale, Jr. The committee is the Plan Administrator and fiduciary for ERISA purposes.

### NOTE D - TAX STATUS OF THE PLAN

The Plan's design is based upon the Alerus Financial, N.A. Non-standardized Pre-approved Profit Sharing/Money Purchase/CODA Plan documentation. The Volume Submitter Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service has determined and informed Alerus Financial, N.A. that the plan document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter, however, the plan sponsor and administrator believes that the Plan, as designed, is currently being operated in compliance with the applicable requirements of the IRC. The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes.

Management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

### NOTE E - RELIANCE ON TRUSTEE'S REPORT

The administrator of the Plan chose the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Under that section, no auditing procedures are required to be performed with respect to the investment information certified by the trustee of the Plan, Alerus Financial, N.A., other than comparing such information to that contained in the financial statements and supplemental schedule.

### NOTE F - FAIR VALUE MEASUREMENTS

Professional accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels.

*Level 1* inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. *Level 2* inputs are other than quoted prices that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. *Level 3* inputs are unobservable inputs based on the Plan's assumptions used to measure assets and liabilities at fair value. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Assets of the Plan for which fair values are determined on a recurring basis are summarized as follows:

(a) Certain investments that are measured at fair value using the net asset value per share (or its equivalent) as a practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of net assets available for benefits.

Mutual funds have quoted prices for identical assets in active markets; therefore, the investments are measured at fair value using these readily available Level 1 inputs.

The common/collective trust is valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
