We have performed audits of the financial statements of J. McLaughlin 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of the Plan

The following description of the J. McLaughlin 401(k) Plan (the Plan), which was established by Georgica Pine Clothiers, LLC (DBA J. McLaughlin) (the Company), provides only general information. Participants should refer to the Plan agreement, and any amendments thereto, for a complete description of the Plan's provisions.

#### *General*

The Plan was established on January 1, 2000 and was amended and restated effective February 1, 2016 for regulatory and certain Plan changes. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Eligibility*

The Plan is a single-employer defined contribution retirement plan covering all employees of the Company, except union employees and non-resident aliens, who are age 21 or older and have completed 60 days of service.

#### *Contributions*

Participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan, which cannot exceed the limits permitted under the Internal Revenue Service (IRS) regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover) at any time. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan does not include an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

Effective January 1, 2023, the Company will make safe harbor matching contributions in an amount equal to 100% of each participant's elective deferrals up to 4% of participants' eligible compensation. The safe harbor matching contribution totaled \$624,529 for the year ended December 31, 2024. Profit-sharing contributions may be made at the option of the Company's owners. For the 2024 Plan year, the Company did not make any profit sharing contributions to the Plan.

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's other contributions is based on years of continuous service, as follows:

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loans are made for terms not to exceed five years, unless the loan is used to acquire a principal residence, in which case the loan may not exceed ten years. The loan interest rate is based on the prime rate plus 1%. Interest rates on outstanding loans for the years ended December 31, 2024 and 2023 ranged from 4.25% to 9.5%. Principal and interest are paid ratably through monthly payroll deductions. No more than one note is allowed at any time and repayment of the entire balance is permitted at any time.

### ***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may only receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

### ***Forfeited Accounts***

The nonvested forfeited balances were \$10 and \$13,031 as of December 31, 2024 and 2023, respectively. Forfeitures of the Plan are used to reduce Employer contributions. During the year ended December 31, 2024, \$7,869 was forfeited by participants, \$21,044 was used to offset the Employer contributions, and the forfeiture account earned \$154.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 7 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan investments are paid by reducing the participant's existing investment account balance and are shown as a reduction of investment income in the statement of changes in net assets available for benefits. Expenses that are paid directly by the Company, such as third-party administrator and payroll service provider fees, are excluded from these financial statements as they are paid by the Plan Sponsor. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

## **3. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Co. (Voya). Voya is the custodian of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Notes receivable from participants also qualify as exempt party-in-interest transactions. The Company, doing business as J. McLaughlin, is also a party-in-interest.

### 4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income from guaranteed annuity contract, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right at any time to terminate the Plan in accordance with ERISA by delivering to the trustee and third-party administrator written notice of such termination. Upon termination of the Plan, no further contributions will be made to the Plan, and all participants' accounts will become fully vested and shall be distributed in accordance with the provisions of the Plan.

### 6. Tax Status

The Plan uses a pre-approved plan document sponsored by USI Consulting Group (USI). USI received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then-designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

## Notes to Financial Statements

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - This level consists of inputs to the valuation methodology that are unobservable and significant to their fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Pooled Separate Accounts (PSAs)* - PSAs are valued at the net asset value (NAV) of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by Voya, is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. This investment is a direct-filing entity. The Plan's investments in the separate accounts may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments.

*Guaranteed Annuity Contract* - The guaranteed annuity contract is reported at fair value, which approximates contract value. The fair value equals accumulated cash contributions and interest credited to the Plan's contract, less any withdrawals and fees.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Prohibited Transactions and Contingencies

During the Plan year ended December 31, 2022, participant contributions, including loan repayments, totaling \$242,075, were not remitted to the Plan in a timely matter as prescribed by Department of Labor (DOL) regulations. These transactions constitute prohibited transactions as defined by ERISA. In July 2024, the late remittances were self-corrected with a contribution of \$356 in lost earnings to the accounts of the affected participants. The lost earnings include the amount the participants should have earned from the date the contributions should have been made through the date of correction.

### 10. Subsequent Events

Subsequent events were evaluated by the Plan's management through October 2, 2025, the date the financial statements were available to be issued. There were no subsequent events requiring adjustment to the financial statements or disclosures.
