Note 1: Description of Plan

The following description of the United Banker's Bancorporation, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of United Bankers' Bancorporation, Inc. and its wholly owned subsidiary, United Bankers' Bank (collectively referred to as the Company), except those who do not qualify for participation. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees who have attained the age of 18 and are considered part of an eligible class of full-time employees are eligible to participate in the Plan. Employees may enter the Plan on the first day of month coinciding with or following the date they satisfy the Plan's eligibility requirements.

Contributions

Participants may defer a portion of their eligible compensation, as defined in the Plan, in whole percentages up to 100%, subject to the maximum amounts allowed by the Internal Revenue Code (IRC). Participants who attain age 50 or older are also eligible to make catch-up contributions, subject to the maximum amounts allowed by the IRC. Under provisions of the IRC, the Plan also allows participants to roll over funds from other qualified plans. Additionally, the Plan allows for participants to defer pretax Roth elective contributions.

The Plan also allows for safe harbor and matching nonelective contributions. Participants are eligible to receive Company safe harbor and matching nonelective contributions upon the completion of the eligibility requirements, as defined above. The Company provides safe harbor nonelective contributions to eligible employees of 3% of the participant's eligible compensation, and matching nonelective contributions equal to 25% of each 1% of the employee's deferral, up to a maximum 1% matching nonelective contribution.

Discretionary nonelective contributions may be made by the Company to participants of the Plan. These contributions can be either a uniform percentage of each eligible individual's compensation or an amount to be allocated to each participant. There were no discretionary nonelective contributions for the year ended December 31, 2024.

Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor nonelective contributions, the Company's discretionary nonelective contributions, if any, and allocations of the Plan's investment earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan and the Plan's investment losses. Allocations are based on participants' earnings, account balances, or specific transactions, as defined in the Plan. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their own contributions, Company safe harbor nonelective contributions (including basic matching and non-elective contributions), and related earning thereon. Balances attributable to Company discretionary nonelective contributions shall vest based on the participant's years of service according to the table below. A year of service is defined as 1,000 hours of service during the Plan year.

Forfeitures

Forfeited employer matching balances of terminated participant's non-vested accounts are used to fund future Company contributions, offset Plan administrative expenses, or allocated to the participating employees. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$46 and \$0 respectively.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans have terms ranging from one to five years, or up to 15 years for the purchase of a primary residence, and are secured by the balance in the participant's account. The loan interest rate is set at 1.00% above the prime rate. At December 31, 2024, interest rates on loans ranged from 4.25% to 9.50% and are due in various amounts through April 2031. Principal and interest are paid ratably through biweekly payroll deductions. A participant may have no more than 2 outstanding notes at any one time.

Note 1: Description of Plan (Continued)

Payment of Benefits

On termination of service, death, permanent disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's interest in his or her account, or installments over varying periods, as permitted by the Plan. The Plan allows in-service withdrawals after age 59 1/2 for any reason and financial hardship withdrawals before age 59 1/2, as defined. Upon termination, participants with an account balance of \$5,000 or less will have their account automatically rolled over to an individual retirement account with Empower. Participants with an account balance in excess of \$5,000 also have the option of keeping their account balance in the Plan. Effective January 1, 2024, the mandatory distribution amount increased from \$5,000 to \$7,000. Participants attaining the age of 73 must receive a required minimum distribution no later than April 1 following the calendar year in which they turn 73, unless the participant is still employed by the Company, in which case they can defer receiving their benefit until they are terminated or retire.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Revenue Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's Board of Trustees determines the appropriateness of the Plan's investment offerings and monitors investment performance. See Note 4 for a discussion of fair value measurements.

Investment Valuation and Revenue Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Risk and uncertainties

The Plan provides for investment in a variety of investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan unless paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Reclassifications

Certain amounts from the prior year financial statements have been reclassified for comparative purposes to conform to the presentation in the current year financial statements.

Subsequent Events

Plan management, in preparing the financial statements and notes thereto, has considered subsequent events through September 30, 2025, the date the financial statements were available to be issued.

Note 3: Information Certified or Provided by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, guaranteed investment contract, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, on behalf of MassMutual, the Custodians of the Plan.

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value in accordance with Accounting Standards Codification (ASC) Topic 820. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 4: Fair Value Measurements (Continued)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Fair value is estimated using the NAV per unit by the issuer of the pooled separate accounts. Fair value is based on the fair value of the underlying investments held by the pooled separate accounts.

Note 5: Investment Contract with Insurance Company

The Plan holds a guaranteed investment contract with Empower Annuity Insurance Company of America that invests contributions in the guaranteed interest account. The contributions made under the contract are maintained in a general account. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The Plan's total investment recorded at contract value was \$5,924,175 and \$6,073,083 as of December 31, 2024 and 2023, respectively.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract.

Examples of such events include the following:

1. The Plan's failure to qualify under section 401(a) of the IRC or the failure of the trust to be tax-exempt under section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreement without the consent of the issuer

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants shall become 100% vested and shall be distributed to the participants or their beneficiaries.

Note 7: Income Tax Status

The Plan uses a pre-approved plan document sponsored by DWC The 401(k) Experts, which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Note 8: Party-in-Interest Transactions

Empower Trust Company, LLC and Empower Annuity Insurance Company of America are the Custodians; therefore, these transactions qualify as party-in-interest transactions. The Plan also pays Plan expenses that are considered party-in-interest transactions. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

Note 9: SECURE Act 2.0

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Effective January 1, 2024, the mandatory force out limit increased from \$5,000 to \$7,000. Plan management will determine the optional provision to elect in the future.
