Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Burlingame Industries 401(k) and Profit Sharing Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of plan

The following brief description of the Burlingame Industries 401(k) and Profit Sharing Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General

The Plan is a defined contribution plan sponsored by Burlingame Industries, Inc. (the “Company”, “Sponsor” or “Plan Administrator”). The Plan is a multiple employer Plan, covering all eligible employees of Burlingame Industries, Inc., Diamondback Express, Inc., Eagle Roofing Products Florida, LLC, Innovacyn, Inc. and Mountain Lakes Resort, LLC (collectively the “Employers” or individually each an “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and it includes a Profit Sharing provision and a Section 401(k) provision. Employees must reach age 18 and complete one month of service in order to be eligible to join the Plan and make elective deferral contributions and receive employer matching contributions. Eligible employees are automatically enrolled in the Plan with elective deferrals set at 3% for participants hired before May 1, 2022 and 5% for participants hired/rehired as of May 1, 2022 and thereafter, and annually increases by 1%, up to a maximum of 10%. At any time, employees may select an alternative deferral amount or elect not to defer under the Plan. Employee participation continues until retirement, disability, termination of employment, or death, at which time the participant's vested account balance becomes payable. The Plan is administered by an Employee Benefits Committee (“Plan Administrator”) whose members are appointed by the Board of Directors of the Company. The Plan has been amended and restated as of January 1, 2014. The Plan has since been amended. See Note 3.

Contributions

An Employer may make 401(k) matching contributions or discretionary lump-sum profit sharing contributions to the Plan as determined at the discretion of the Board of Directors. Participants may make contributions to the 401(k) Plan in an amount not to exceed 75% of their compensation or Internal Revenue Service (“IRS”) limits. For the years ended December 31, 2024 and 2023, the Employers provided matching 401(k) contributions at the rate of 75% of the participant's contributions, subject to a maximum of 5% of compensation earned. The Employers made discretionary profit sharing contributions totaling \$1,535,000 and \$1,761,000 to the Plan for the years ended December 31, 2024 and 2023, respectively. Participants direct the investment of their deferred contributions, Employer matching, and profit sharing contributions into various investment options offered by the Plan. Participants may elect to change their investment options and transfer their account balances among the different investment options at any time.

Participant accounts

Participants' accounts are credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary deferral contributions plus actual earnings thereon. Profit sharing and 401(k) employer matching contributions vest on a 6-year graduated schedule based upon 1,000 hours worked in each Plan year.

Benefit payments

Upon termination of service, a participant will receive a lump-sum cash payment equal to the value of his or her vested account.

Forfeitures

The distribution and allocation of Employer profit sharing and matching contributions forfeited are first made available to reinstate previously forfeited Employer profit sharing or matching contributions account balances of rehired, former participants provided certain provisions in the Plan are met. The remaining forfeitures are available to be applied to reduce Employer contributions or to reduce Plan expenses. The forfeiture holding account balance was \$178,371 and \$262,610 at December 31, 2024 and 2023, respectively. In 2024 and 2023, employer contributions were increased by \$61,862 and reduced by \$89,137, respectively, from forfeited nonvested accounts.

Notes receivable from participants

Participants may borrow a minimum of \$1,000 up to the lesser of 50% of their vested balances or \$50,000. Notes are available from the participants' vested portion of their account balance and are secured by such vested balance. Interest is determined in accordance with prevailing rates on commercial loans and allocated to the participant borrower's account. At December 31, 2024, participant notes were outstanding with various monthly payments and maturities from 2025 through 2051, bearing interest rates from 5.25% to 10.5% and valued at unpaid principal balance plus accrued but unpaid interest. Principal and interest is paid ratably through monthly payroll deductions.

2. Summary of significant accounting policies

Basis of accounting

The financial statements have been prepared using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and change therein, and disclosure of contingent assets and liabilities. Actual results could differ from the estimates.

Contributions

Employer profit sharing contributions are recognized in the period for which they were declared. Employer and employee 401(k) contributions are recognized in the period in which the related compensation is earned.

Investment valuation and income recognition

The Plan's mutual fund investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

The Plan's common collective trust is stated at fair value. The trust consists of the Morley Stable Value Fund which is valued based on the underlying unit value of contracts held by the fund. These include investment contracts and security-backed contracts. An investment contract is a contract issued by a financial institution to provide a stated rate of return to the buyer of the contract for a specified period of time. The security-backed contracts contain wrapper contracts which provide contract value payments for certain participant-initiated withdrawals and transfers, a floor crediting rate, and return of fully accrued contract value at maturity. The fund carries its investments at contract value. Plans that directly invest in common collective trusts that hold fully benefit-responsive investment contracts do not need to include the disclosures required by Financial Accounting Standards Board ("FASB") Accounting Standard Codification ("ASC") 962-325-35, Plan Accounting – Defined Contribution Pension Plans in the Plan's financial statements. As such, these disclosures are excluded from the Plan's financial statements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of benefits

Benefits are paid directly by the trustee and are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments. For the years ended December 31, 2024 and 2023, the Employers did not pay for any administrative expenses on behalf of the Plan.

3. Tax status

Effective January 1, 2014, the Plan adopted the Charles Schwab prototype plan document and is relying on the tax exempt status from the Internal Revenue Service by a letter dated September 21, 2020, that the Plan and related trust, as then designed, are in accordance with applicable sections of the Internal Revenue Code ("IRC"). The prototype plan has been amended since receiving the latest opinion letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

4. Risks and uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. Plan termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants shall become fully vested in their account balances and the net assets of the Plan will be allocated to the participants in accordance with the terms of the Plan.

6. Information certified by the trustee

The following is a summary of the information included in the Plan's financial statements that was prepared by the trustee, Charles Schwab and furnished to the Plan Administrator. The trustee has certified that such information is complete and accurate.

7. Fair value measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Money Market*: Money market securities are valued at the closing price reported in the active market in which the individual security is traced.
- *Common Collective Trust*: Valued at the net asset value ("NAV") of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.
- *Mutual Funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
