# Thule Holdings, Inc. 401(k) Plan Notes to Financial Statements

Years ended December 31, 2024 and 2023

## **1. Description of the Plan**

### **General**

The following description of the Thule Holdings, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan available to all eligible employees of Thule Holdings, Inc. and Thule Organization Solutions, Inc., (collectively, the Company) who have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Contributions**

Each year, participants may contribute up to 90% of their pretax annual compensation, as defined in the Plan, subject to certain Internal Revenue Code (IRC) limitations. Participants may also contribute amounts representing after-tax compensation (Roth deferral contributions), as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified (and certain nonqualified) defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an automatic contribution arrangement. Employees hired on or after the effective date are subject to automatic deferrals of 3% with no arranged escalation after meeting the eligibility requirements of the Plan.

Management made a safe harbor matching contribution each payroll period equal to 100% of the first 3% of the participants' pre-tax or Roth salary deferral contributions, plus 50% of the next 2% of the participants' pre-tax or Roth salary deferral contributions up to a maximum of 4% of the participants' salary for the years then ended December 31, 2024 and 2023. Contributions are subject to certain dollar limitations as set forth by the Internal Revenue Code (IRC). Such limitations on participant contributions were \$23,000 and \$22,500 for Plan years 2024 and 2023, respectively, with the exception of certain allowable catch-up contributions for participants over the age of 50. The maximum amount a participant may contribute as a catch-up contribution for the Plan years 2024 and 2023 was \$7,500.

**1. Description of the Plan (continued)**

**Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contribution, and allocations of Plan earnings, and charged with withdrawals and an allocation of Plan losses and certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions, Company safe harbor matching contributions, plus earnings thereon. As such, there are no forfeited accounts at December 31 2024 and 2023.

**Notes Receivable from Participants**

Notes receivable from participant accounts represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed as determined periodically by the Plan Administrator. Principal and interest is paid ratably through payroll deductions on a weekly basis for hourly employees and bi-weekly basis for salaried employees. Loans must be repaid within five years. The range of interest rates on participant loans outstanding was 4.25% to 9.50% as of December 31, 2024.

**Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons as defined in the Plan Document, a participant may receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Participants who have reached the age of 59 1/2 may, upon written request, make withdrawals from the vested portion of their account balance. Any such withdrawn amounts may not be repaid to the Plan. In the event a participant's vested account balance is less than \$1,000, the Plan may distribute the balance to the participant without their consent.

Withdrawals from a participant's vested balance may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investments Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year, which is presented in the Statements of Changes in Net Assets Available for Benefits.

The Plan's investment in a common collective trust is measured using the net asset value (NAV) per share of the investment as a practical expedient as permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement and Disclosures* (ASC 820) and ASC 946, *Financial Services – Investment Companies*.

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

**2. Summary of Significant Accounting Policies (continued)**

**Payment of Benefits**

Benefits are recorded when paid. No participants have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 and 2023.

**Administrative Expenses**

For the Plan years then ended December 31, 2024 and 2023, the Plan incurred administrative expenses in connection with loan initiation fees which are paid by the participant. Administrative expenses incurred in connection with professional services and investment transactions, and payments of benefits to participants, are paid by the Plan.

**3. Information Prepared and Certified By Trustee**

The Plan's investments are held and administered by the Trustee, State Street Bank and Trust Company, as of December 31, 2024 and 2023 and for the years then ended. All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, notes receivable from participants as of December 31, 2024 and 2023, and interest income, dividends and net appreciation (depreciation) in fair value of investments for the years then ended December 31, 2024 and 2023, was obtained and certified as complete and accurate by State Street Bank and Trust Company.

**4. Fair Value Measurements**

The Plan uses a framework that provides for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include; quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**4. Fair Value Measurements (continued)**

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value; there have been no changes in the methodologies used at December 31, 2024 and 2023. Mutual funds and money market funds are valued at the value of such shares as of the close of business at the end of the year based on quoted active market prices of the underlying investments, and as such, are classified as Level 1 investments. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

\* Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the Statements of Net Assets Available for Benefits.

**5. Exempt Party-in-Interest/ Related Party Transactions**

Certain Plan investments are shares of mutual funds and an interest in a common collective trust fund which are held and managed by State Street Bank and Trust Company, the Trustee as defined by the Plan, and Transamerica Retirement Solutions, the Recordkeeper as defined by the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

**6. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth by ERISA.

**7. Federal Income Tax Status**

The prototype plan document, which the Plan has adopted via a non-standardized adoption agreement, obtained its latest opinion letter in 2020 in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
